
In terms of public information dissemination of the fact that a Community Plan Review has been taking place, the following steps have been taken in addition to notifying each of the 5,000 households on either side of Hastings Street west of Willingdon Avenue:

1. The attached advertisement inviting participation was run in the newspaper (Boundary Road News) on 1980 January 30 and this was distributed to all homes in Burnaby.
2. The Planning Department has had contact with several citizens groups in North Burnaby including:
 North Burnaby Residents Association,
 North Slope Ratepayers,
 Burnaby Heights Association,
 Willingdon Heights Neighbourhood Improvement Program Committee.
3. The Planning Information program has disseminated information on the Plan Review to its members.
4. At the Public Hearing on 1980 February 19 for Rezoning Reference #1/80 (Bosa Bros.) considerable discussion about the "Community Plan Review" took place in presentations at this Public Hearing. The minutes of that Hearing record that a Mr. M. DeFigueiredo of 4855 Empire Drive was present and did in fact give a presentation to the assembly.

In addition to the foregoing, a good deal of awareness of and participation in the ongoing review has been generated by discussion in numerous Council meetings and coverage in the local press.
