The writer considered that it was a matter of major importance that liquor advertising in "Westworld" be stopped.

(b) Walter J. Booth, Re: No Restrictions on Height of Fill Permitted on Land Being Developed.

A letter dated 1981 April 01 was received noting that the Municipality has a restriction on the maximum height of fences but apparently no restrictions exist on the height of fill permitted on land being developed.

It was agreed that the Municipal Engineer would contact Mr. W.J. Booth and discuss the matter of concern to him in greater depth.

(c) Strataco Management Ltd., Property
Manager, on behalf of Owners of Strata
Plan N.W. 655, Re: Landscaping Village Del Ponte - Strata Plan N.W. 655
Millburn Court, Millbrook Lane, Belfriar
Drive and Bridgewater Crescent.

A letter dated 1981 March 26 was received in which it was noted that the landscaping of the property adjacent to the north west perimeter of the Village Del Ponte has not been completed by the developer.

The writer reported that he had contacted the developer in this regard but would appreciate receiving whatever assistance the Municipal staff can provide in ensuring that the developer meets his obligations to the owners of Strata Plan N.W. 655.

Council was advised that the Municipal staff was pursuing this matter with the developer, Bosa Bros., to ensure that the landscaping in question will be completed in the not too distant future.

(d) Province of British Columbia, Ministry of Environment, Waste Management Branch, Manager, Resource Recovery Section, Re: Recovery of Resources from Solid Wastes in British Columbia.

A letter dated 1981 March 24 was received advising that the Waste Management Branch of the Ministry of the Environment had commissioned Stanley Associates Engineering Ltd. to carry out a study of municipal recycling in British Columbia. This study has now been completed.

This report is being distributed to Municipal Authorities, recycling groups and others concerned with this subject in British Columbia. The writer requested that Municipal comments be received before 1981 April 30.

Council was advised that the Municipal Engineer will forward his comments on this subject directly to the Ministry of Environment, Waste Management Branch, and will also submit a report to Council incorporating his comments to the Waste Management Branch for information purposes.

(e) Municipal Administration Education Council, Chairman, Re: Brochure "Municipal Education Programs in British Columbia".

A letter dated 1981 April 02 was received enclosing a copy of a brochure entitled "Municipal Education Programs in British Columbia". It was requested that Council make this brochure available to Municipal staff in order that they may be aware of the opportunity for employees in the Municipality to upgrade and enhance their administrative skills.

(f) Union of British Columbia Municipalities, Executive Director, Re: Royal Canadian Mounted Police Contract Negotiations.

A letter dated 1981 April 02 was received advising that the current R.C.M.P. contract agreement, which officially ended on 1981 March 31, has been extended on an interim basis for three months until 1981 June 30, with all terms and conditions contained therein remaining unchanged.

The reason for this extension of time of the current contract is that negotiations for a new contract have not yet been concluded. Discussions between the Federal government and the Provincial Attorney General's Department will continue until final agreement is reached with the expectation that agreement can be reached before 1981 June 30.

As and when the new contract is finally settled, its terms and conditions will be made retroactive to 1981 April 01.

(g) Federation of Canadian Municipalities, <u>Executive Director</u>, Re: Consent Form.

A letter dated 1981 April 02 was received enclosing "Consent Forms" to be completed by members of Council wishing to serve on the Board of Directors of the Federation of Canadian Municipalities.

His Worship, Mayor Mercier, advised that he would be submitting a further report on this matter to Council within the next week or two.

(h) James G. Lorimer, Member Legislative Assembly, Burnaby - Willingdon, Re: Proposed Street Realignment from Willingdon Avenue to Patterson Avenue.

A letter dated 1981 April 07 was received expressing concern with the proposed realignment of Willingdon Avenue to Patterson Avenue. The opinion was expressed that it will generally become part of the highway system for the proposed Annacis Island crossing.

The Director of Planning advised that he hoped to have a report on this subject available for the next meeting of Council on 1981 May 04.

(i) Province of British Columbia, Ministry of Municipal Affairs, Minister, Re: Inspector of Municipalities to Undertake Investigation into Expropriation at 9637 Cameron Street.

A letter dated 1981 April 10 was received advising that the Minister has asked the Inspector of Municipalities to undertake an investigation into the District of Burnaby's expropriation of the property at 9637 Cameron Street in Burnaby, belonging to Mrs. Lillian Mann. The Minister advised that he was concerned about the District of Burnaby's conduct of the expropriation. He suggested that the District of Burnaby not proceed with the expropriation until the Inspector of Municipalities has completed his investigation.

Item 4, Municipal Manager's Report No. 20, 1981 April 21, pertaining to this subject, was brought forward for consideration at this time.

The Municipal Manager reported that staff is completely satisfied that the Corporation has conducted itself properly during the entire expropriation procedure, in accordance with all applicable legislation, and would confirm that the property is still required for Municipal purposes.

Council is aware that Mrs. Mann's property was acquired, not only to meet current parking requirements in the most optimum manner, but also to provide for Library expansion. The property is also included in the area designated in the Cameron Road Community Plan for public recreational use.

Should Council abandon the acquisition of 9637 Cameron Street, the Corporation could be faced with costs totalling \$100,000 to compensate Mrs. Mann for her costs and to pay our own legal costs, and then still be faced with reinitiating the acquisition of the property in the not too distant future for Municipal purposes at a considerably increased cost.

The Municipal Manager recommended:

(j) Petition, Residents of Burnaby, Re: Monitor Assessed Values of Large Industrial and Commercial Properties.

A petition bearing nine signatures of Burnaby residents was received requesting that Burnaby Municipal Council adopt a policy of monitoring more closely the assessed value of large industrial and commercial properties to ensure an equitable tax assessment base between residential, commercial and industrial properties and that the Burnaby Lands Department:

- (1) Be charged with responsibility to conduct independent appraisals of large industrial and commercial properties, compare their appraisals with B.C. Assessment Authority appraisals as appear on the Assessment Roll and report comparisons made to Burnaby Council prior to January 20 each year.
- (2) Initiate appeals of assessments as they appear on Assessment Rolls where they appear too low.
- (3) Actively intervene in other assessment appeals when the claim is that large industrial or commercial property assessed values should be reduced.
- (k) Petition, Resident Taxpayers of Burnaby, Re: Burnaby Municipal Council Participate in Appeals Against Assessed Values of Oil Refinery Properties in Burnaby.

A petition signed by eight resident taxpayers of Burnaby was received advising that the petitioners do fully support the application and/or appeal of David Fairey against the assessed actual values that appear on the 1981 Assessment Roll for all properties in Burnaby owned or occupied by Shell Oil Company, Chevron Oil Company and Gulf Oil Company.

The petitioners also called on the Burnaby Municipal Council and Burnaby School Board to support and participate in appeals against assessed values of oil refinery properties in Burnaby on the basis that they are too low.

1. Port of Vancouver Master Plan

The Municipal Manager provided a report from the Director of Planning concerning the Port of Vancouver Master Plan.

The Director of Planning reported that the commencement of work on a Master Plan for the Port of Vancouver was recently announced by Transportation Minister Jean Luc Pepin. Planning staff had a previous initial meeting with Mr. Ray Gainer, Project Manager for the Master Plan, to explore mutual concerns. It was agreed that Burnaby Council should be fully apprised of this project including the study terms of reference as soon as possible.

It was also agreed that municipal participation on this project including representation on the Liaison Committee will be the responsibility of the Commercial/Industrial Coordinator, who is Mr. P. Bloxham of the Burnaby Planning Department.

- (3) THAT the developer of Subdivision Reference #93/79 (Sunshine Mortgages Ltd.) be required to construct the pumping station as a part of his Servicing Agreement with the Corporation of the District of Burnaby for this subdivision.
- (4) THAT a purchase order be issued to Sunshine Mortgages Ltd. in the amount of \$52,425.00 for the Corporation's share of the cost of the station.

"WHEREAS by Bylaw No. 7209 cited as 'Burnaby Expropriation Bylaw No. 3, 1978' which received reconsideration and final adoption 1979 June 11 The Corporation of the District of Burnaby expropriated real property vested in The Director, The Veterans' Land Act, being Lot 1, Block 23, District Lot 6, Group 1, Plan 6991, New Westminster District, except the West 80 feet thereof; and

WHEREAS the Council deemed it desirable and in the public interest to expropriate the real property described for pleasure, recreation and community uses of the public and in particular for the Northeast Burnaby Recreation/Library Complex:

THEREFORE BE IT RESOLVED that:

- Bylaw No. 7209 cited as 'Burnaby Expropriation Bylaw No. 3, 1978' be repealed;
- 2. Section 558 of the Municipal Act be put into effect immediately;
 - 558. (1) Notwithstanding this Act, whenever at any time before the compensation money has been actually paid, the acquisition of a parcel of land or real property, or any interest in them, taken or expropriated for municipal purposes, or any portion of it, is determined by bylaw of the council to be unnecessary, or if the council determines by bylaw to abandon the work, purpose or undertaking in respect of which the land, real property or interest has been taken or expropriated, the council may, by the same or another bylaw, declare that the land, real property or portion of it, or the estate, right, title or interest in it, is not required and is abandoned by the municipality.
 - (2) On a certified copy of the bylaw being filed in the land title office for the district in which the land or real property is situate, the land or real property or interest declared to be abandoned shall revest in the person from whom it was taken or expropriated, or in the persons entitled to claim under him.
 - (3) Notwithstanding abandonment or revesting, compensation shall be made by the municipality to the owner or occupiers of or other persons interested in the land or real property for any loss, costs or damage sustained by them in consequence of the taking or expropriation, and its amount shall be determined under this Division.
 - (4) The compensation made or awarded under subsection (3) shall be in lieu of any compensation which would otherwise be payable under section 544, and its payment constitutes full satisfaction and discharge of all demands by the claimant in relation to the expropriation or taking by the municipality of the land, real property or interest.
- 3. The matter of compensation as referred to in subsections (3) and (4) to include all costs, and punitive damages, to the owner of the real property as aforementioned."

There being no seconder to the aforementioned Motion, as moved by Alderman Brown, no further action was taken on this matter at this time.
