A letter dated 1981 February 06 was received in which it was noted that, while municipal taxes continue to increase, no improvments of any kind had occurred on Watling Street. The writers were also concerned with the municipal tree planting program on Maywood Street from Cassie Avenue to Telford Avenue.

Item 1, Municipal Manager's Report No. 13, 1981, pertaining to this subject, was brought forward for consideration at this time.

The Municipal Manager submitted reports from the Municipal Engineer and the Parks and Recreation Administrator on this subject.

The Municipal Engineer noted that street improvements are carried out in Burnaby under the Local Improvement process. Engineering staff will contact Mr. and Mrs. Redwick and inform them more fully of the procedure that is required in this regard.

The Parks and Recreation Administrator reviewed in detail the tree planting program in the area of concern to Mr. and Mrs. Redwick.

The Parks and Recreation Administrator pointed out that the trees selected for planting in this area are ornamental trees which do not grow unusually large and, therefore, will not create the tangling appearance as suggested.

(c) Greater Vancouver Regional District, Commissioner -Regional Development, Re: Proposed Regional Economic Development Department.

A letter dated 1981 February 06 was received concerning the proposed Regional Economic Development Department.

Nine municipalities are prepared to participate in the function but they have taken this position on the basis that all G.V.R.D. municipalities would be participating. The municipalities which are not prepared to participate include those with the largest amounts of vacant industrial land which would be an important factor in the work of a Regional Economic Development agency. The creation of an Economic Development agency under these conditions would mean either that non-participating municipalities would receive the benefits of area-wide efforts without paying a share of

the costs or that the agency would have to promote some municipalities and not others. The G.V.R.D. Board was reluctant to establish an agency under these conditions and at its October 29, 1980 meeting the matter was referred to the Planning Committee for further consideration.

The G.V.R.D. Planning Committee, after considering concerns expressed by member municipalities, regarding the function and permanence of the proposed Regional Economic Development Department, directed that:

- 1. Any final proposal to establish a Regional Economic Development function be submitted formally for final endorsement to all member Councils and electoral area Directors prior to any application by the Board for supplementary letters patent for this purpose.
- (d) Lower Mainland Municipal Association, Secretary-Treasurer, Re: Meeting Hazelmere Golf and Country Club, 18150 - 8th Avenue, Surrey, B.C., Thursday, 1981 February 26 at 18:30 h.
