Mr. Owen Dykstra then addressed Council on the subject of the current work stoppage. The following is the text of Mr. Dykstra's submission:

"On behalf of your employees, members of the Burnaby Civic Employees' Union, CUPE Local 23, I thank you for the opportunity to address Council.

We, and many of the taxpayers who elected you, would like to know whether your responsibility to your electorate and employees is indeed, as it should be, greater than to a private labour relations consultant and the GVRD. The private consultant is Mr. Graham Leslie, who established a Labour Relations Bureau to which he lured almost all of the Councils within the GVRD; and indeed, he calls his company the "GVRD Labour Relations Department".

He claims that he is responsible to the Mayors and Councils within the GVRD.

But we suspect that he is responsible to many other organizations to which the Burnaby Council is not elected. Nor do we feel that this Council has responsibilities here greater than their responsibility toward the Burnaby Taxpayer.

Or the Burnaby Municipal Employees.

The question is raised because of Council's attitude toward the current negotiations.

By allowing others to make the decisions for you, of course you make things easy for yourself.

If things go wrong in Burnaby you can now say it is not your responsibility ... it is that of the Union and the GVRD.

We ask: Is this fair?

When last year you decided that you needed an increase in pay for the Mayor and members of Council, you made sure that no other body would decide how much that should be.

You voted yourselves an average increase of 22%, regardless of the fact that the Provincial Government had placed a ceiling of 5% on Municipal budgets, and also regardless of the fact that you had first made sure that the 7½% increase for your employees was well below the average wage increases for that year, and well below the increases in the cost of living.

However, you found that you could justify the 22% for the sake of catch-up, and you made sure that other organizations would not prevent you from doing your thing: And further, you felt that others had no business meddling with Council's affairs (i.e., the Minister of Municipal Affairs).

This year you did even better by adopting a formula which ties your salaries to the Municipal budget.

Good thinking! Not only is the cost of living looked after, because the budgets automatically have to increase as the cost of living increases - but you also have a little extra for the natural growth of the Municipality.

And yet you are not prepared to take direct responsibility for negotiations with your employees.

Your conscience does not seem to bother you when you know that at one time our wage rates were at par with those of the forest industry ... actually, some years, even a few pennies higher ... and now they are \$1.98 per hour less for base labour rate, even before the I.W.A. starts negotiations, and you know there will be a healthy increase when they start negotiating in June.

All we ask for is a catch-up, just like the one you voted yourselves.

But you do not want anything to do with negotiations for your employees. Only for yourselves.

We ask again: Is this fair?

The real losers in all this are the very same people who elected you; the Burnaby taxpayers, including many of your own employees.

You are in the process of destroying something Burnaby was known for in the past, something that made Burnaby unique among other municipalities.

That was innovation and foresight by both management and labour, with a joint goal to make this Municipality the most efficient organization for both taxpayers and Municipal staff.

It was a simple formula.

We cooperate for the best productivity; management cooperates for the best wages, benefits and working conditions.

We had our problems working out the details, but because of the sincere efforts on both sides, goals were achieved that made all parties winners and the taxpayer reaped benefits in the form of greater efficiencies and better service.

Some examples: The Benefits Society and the sanitation task system.

The GVRD has already destroyed much flexibility because of its job evaluation system (which you are responsible for, allowing it to happen).

And now it is almost too late with your new attitude, which seems to be to give the lowest possible wages, with the likely result of the least possible productivity.

This will drag Burnaby down to the level of other municipalities, with the employees and the taxpayers being the big losers.

Another example is the destruction of our benefit plan, which you are allowing to happen.

Through a lot of negotiations, trust and cooperation from both sides, the Benefit Society was established in the late 50's - with the result that, on comparisons with other Municipal employees, Burnaby employees had more benefits for about the same cost to the employees and about the same cost to the employer.

Also, the years of cooperation produced savings which were returned to the Society for additional benefits.

Everyone was a winner.

During the early seventies, along came Mr. Leslie, who discovered that the Burnaby employer was making some savings on benefits, and he tried to force this concept (which, by the way, is a complete change from earned sick leave, to a form of insurance) onto the workers of other municipalities with disastrous results.

Because of this, there have been no improvements in benefits in area negotiations since about 1975, because every time the Unions place benefits on the table, Mr. Leslie comes back with the Burnaby package.

This has practically halted any innovative benefit changes which could benefit both parties, and has also created a high degree of mistrust by our members toward our Benefit Society, which could well be the destruction of the Benefit Society, and you are hiding your heads in the sand, and letting it happen.

Mr. Leslie and the other employers seem to want this benefit package so bad that they seem to be prepared for it with additional wage increases, but of course they won't offer Burnaby additional increases until the other Unions accept a benefit package that we already have.

Does that make sense?

Again we ask, is that fair?

We urge that Burnaby Council tonight endorse a resolution ordering Mr. Leslie back to the negotiating table immediately and instructing him to place a fair offer on the table - with no strings attached.

We also urge that Burnaby Council immediately after negotiations are completed (we know that Mr. Leslie has you locked in until negotiations are completed), fire Mr. Leslie and the GVRD, and that Council again assume full responsibility and control of labour negotiations within the Municipality of Burnaby.

Let's get this strike over with. Maybe we can jointly repair the damage which has been done."

A letter dated 1981 March 09 was received recommending that Council adopt a resolution calling for the British Columbia Automobile Association to discontinue liquor advertising in the magazine "Westworld" from this time forward.

(e) W.J. Booth, Re: Grading of Land North side of Woodsworth Street

A letter dated 1981 March 12 was received complaining of the fill dumped on the land on the north side of Woodsworth Street, particularly at the rear of the property at 5560 Hardwick Street. The writer was of the opinion that the placing of this fill will permit the occupants of the house to be built on the property to look over and down on his back garden and invade his privacy.

Item 1, Municipal Manager's Report No. 16, 1981, pertaining to this subject, was brought forward for consideration at this time.

A letter dated 1981 March 02 was received advising that the Canadian National Exhibition would like to identify Canadian municipalities on their modern benches located throughout the 300 acre site. These strategically placed benches would result in welcome rest areas sponsored by the various municipalities.

While the Municipality might consider shipping its own benches to the Canadian National Exhibition, it might be easier and more feasible to sponsor a number of benches at a cost of \$300. each. The Canadian National Exhibition would be responsible for their maintenance and refurbishing each year.

- (h) School District No. 41 - Burnaby, Secretary-Treasurer, Re: Shifting of school taxation from Provincial responsibility to Municipal responsibility.

A letter dated 1981 March 12 was received in which it was noted that the shifting of school taxation from Provincial responsibility to Municipal responsibility causes the Board of School District No. 41 - Burnaby much concern.

Council's interest in, and agreement with this concern, is much appreciated. The Board would be interested in pursuing a meeting with the Mayor and Council to explore possible solutions, including perhaps joint recommendations to the Provincial Government.

Realizing that both Council and the Board are in difficult times with respect to other pressing matters, it is understood that this meeting might have to take place one or two months down the road.

Alderman Drummond

Alderman Drummond enquired as to the problems presently being encountered by the breaking of glass in the new bus shelters and suggested that Council receive a report on this situation.
