- (a) His Worship. Mayor Lewarne, advised Council that the Burnaby Public Library Board did not wish to be heard as a delegation on the Provisional Budget this evening.
- (b) Jocelan Wise then addressed Council on the subject of a development permit and road dedication concerning 4025 Norland Avenue. The following is the text of Mrs. Wise's submission:

"I appeared before Council to seek a development and building permit four storeys high complying with municipal guidelines.

At my delegation before Council on 1981 October 26, the Council referred me to the Municipal Manager, Mr. Shelley. He submitted a proposal to the Dania Society and myself, outlining the municipality's participation in acquiring land and sharing costs of road construction. A price was put on my land at that time, I considered it low and not the municipality's jurisdiction; my experience told me that no matter what price was set they would bid much lower and I mean much lower.

1982 February 01

In a letter dated 1981 December 07 from the Dania Society to Mr. Shelley, and a copy to myself, the Society indicated interest in purchasing my land, but did not submit an offer.

On 1981 December 15 I wrote to Dania Society requesting that they submit an offer to purchase by 1981 December 17 so I could deal with it. This was not done at that time. However, late in December I received a letter, a proposal to purchase for a price almost one-half again what Mr. Shelley suggested in his November proposal.

I had an offer to purchase from the Dania Society in the summer of 1981 that was twice as much as the last offer.

The Society had an appraisal done on my land at that time and then came in with an offer much lower. However, I was considering to accept the offer, but later they withdrew their offer because of the cost of construction of the road, they said.

I am at a disadvantage to deal with the Dania Society because of the Planning Department's desire to consolidate the two properties. The Society are taking full advantage of this, along with the low price that has been set, the Society have offered much less.

After eight years of dealing with the Society I warned Mr. Shelley this is what would happen, exactly as I predicted.

I am appealing for a development and building permit, failing this the municipality can buy my land.

I cannot cope with the water problem and I would like to discuss this further with Mr. Olson and the Council."

It was agreed that in order for the proposed development of the property at 4025 Norland Avenue to proceed, Mrs. Wise should submit an application for rezoning to the appropriate category to the Director Planning & Building Inspection and the normal procedure regarding rezoning could then be followed.

Neither the subdivision pattern, as was shown in previous Council reports received on 1980 January 07, 1979 October 29, 1979 August 13 and 1979 July 30, nor the factors considered for establishing the pattern, have changed.

It was his choice of A.L.R.T. that brought about the need for elaborate and expensive \$6 million stations.

Conventional L.R.T. can be designed with smaller, less expensive stations placed at closer intervals. That would mean more convenience for passengers. Unlike A.L.R.T., which must be programmed to stop at every station whether there are passengers or not, Conventional Light Rapid Transit, which would be manually operated, would only stop if there were boarding or alighting passengers. (i) Elizabeth De Foe, Re: Bill to repair ornamental lamp standard

A letter dated 1982 January 22 was received concerning the cost of repairing an ornamental light standard which was damaged as a result of a motor vehicle accident in which the writer was involved.

Council was advised that a staff report on this subject would be available on 1982 February 08 and further consideration of the matter was deferred until that time.

Mr. Robinson trusted that this is an issue that Council is interested in and that it will be making its position known to Mr. Bonner as well.

The Library Board hopes that Municipal Council will be able to review the need for the Library Board to reduce its budget by such a large amount so that these services can be resumed as soon as possible to enable the Board to achieve its primary purpose of meeting the needs of the community for effective Library service.

1. Refinery Assessments

The Municipal Manager provided a report from the Treasurer concerning refinery assessments in Burnaby.

The Treasurer noted that in 1981 February Council ratified the action of the Treasurer in requesting the Assessment Authority to do an audit of refinery assessments in Burnaby.

The Treasurer has now been advised by the British Columbia Assessment Authority that a review of land and improvement values by the Field Audit Section was carried out in 1981.

From the report, it was concluded that land values determined by the Burnaby/New Westminster assessment area were satisfactory. On the other hand, the study of the improvements was inconclusive due to lack of sufficient evidence in the province. In the circumstances, the British Columbia Assessment Authority is attempting to obtain the necessary expertise to assist them in carrying out a provincewide review as expeditiously as possible. The Municipal Manager recommended:

 Road Dedication Enquiry Proposed Commercial Development 4330 and 4360 Kingsway and 5956 Wilson Avenue Rezoning Reference #163/81

The Municipal Manager provided a report from the Director Planning & Building Inspection concerning a road dedication in connection with the subject proposed commercial development.

The Director Planning & Building Inspection noted that at its meeting of 1982 January 18, Council advanced the rezoning proposal at Kingsway and Wilson to a Public Hearing. At that time an enquiry was made as to whether the rezoning applicants had paid for property owned by the municipality which is dedicated for road right-of-way purposes in conjunction with a rezoning.

The Director Planning & Building Inspection provided information on similar situations where lands acquired by the municipality had been subsequently dedicated for road allowances with road works then constructed by the developer.

The Director Planning & Building Inspection concluded that there is no precedent for requiring a developer to pay for municipally owned property in order to subsequently dedicate the property for road right-of-way purposes. Unless otherwise directed by Council, municipal staff will continue to follow the established approach.

AND WHEREAS The District of Burnaby has received an application from Russel Pedersen, Architect, to construct a garage and install a driveway entrance door to the basement of the existing residence:

THEREFORE BE IT RESOLVED that the additions and alterations as more specifically noted in this report be approved by Council."

- (2) THAT prior to the issuance of Municipal Approval a Restrictive Covenant pursuant to Section 215 of the Land Title Act be registered against the title of the property to preclude outside storage of the vintage vehicles, commercial use associated with the storage activity and mechanical repair of the vintage vehicles on the property.
- (3) THAT a copy of this report be sent to the present owner of the property, Mrs. Lorraine Sung, 7640 Berkley Street, Burnaby, B.C. V5E 4A7.

Alderman Stusiak noted that Council had received this evening sketches illustrating the bus interface with the forthcoming A.L.R.T. system and requested further information on this subject.

Alderman Emmott advised Council that he would make arrangements for Mr. Mansbridge, Commissioner - Transit, Greater Vancouver Regional District, to contact Alderman Stusiak in the immediate future to arrange a meeting at which this subject could be discussed in much greater detail.

Mayor Lewarne advised Council that he had been in contact with Mr. Twining, Area Assessor, British Columbia Assessment Authority this afternoon. Mr. Twining had advised the Mayor that as a result of deliberations by the Courts of Revision a recommendation has been put forward that the assessment for land only for single family dwellings in Burnaby be reduced by nine percent.

The number of assessment appeals received this year was approximately 2,500, of which approximately 2,000 were on residential property. The normal number of appeals for any given year is approximately 250. It is expected that it will take two months to hear all of the appeals currently before the Courts of Revision.
