- (c) Ms. Gayle D. Gavin, 3746 Cambridge Street, then addressed the members of Council and advised that she was the President of the Interim Steering Committee of the Burnaby Peace Committee. Ms. Gavin, by way of introduction, explained that the membership of the Burnaby Peace Committee is made up of a group of Burnaby citizens who are interested in the issue of peace and came together during the month of 1982 July. There were twenty-two (22) citizens who attended the founding meeting, where it was resolved that an interim committee would work to establish a program for the work of the committee in Burnaby. A meeting is planned for 1982 October 21 at the Eastburn Community Centre for the purpose of forming the Burnaby Peace Committee. All members of Council were invited to attend this meeting.

Ms. Gavin then advised that the reason she was appearing before Council this evening was to ask Council to consider, in concert with the United Nations General Assembly, proclaiming the week of 1982 October 23 to 1982 October 31 as "International Disarmament Week in Burnaby". Ms. Gavin then read to Council a portion of the introduction to a special session of the United Nations General Assembly regarding the issue of disarmament that was held in 1978.

- (a) Mrs. Catherine M. Glosli, 3462 Keswick Avenue, then addressed the members of Council and advised that she was a member of the Executive of the Sullivan Heights Ratepayers Association and was speaking tonight on behalf of those people residing south of the proposed Beaverbrook extension. Mrs. Glosli stated that she sympathized with the long time residents of Cameron Street and felt that the provision of amenities for the new residents of the neighbourhood should not be provided at the expense of the long term residents. The speaker, in concluding her presentation, stated that the traffic and parking problems in the area have not been resolved.

In response to questions from Council, Mrs. Glosli advised that she was not in favour of the proposed closure of Bell Avenue and wished to see the proposed alignment for the Beaverbrook extension altered so that it will connect with Reese Avenue.

- (b) Mrs. Helen Schaug, 9355 Cameron Street, then addressed the members of Council regarding the subject of the extension of Beaverbrook and the Cameron Street traffic. Mrs. Schaug, a long time Burnaby resident, requested that she be treated fairly and advised of what is in store for her property. Mr. Schaug stated that the proposed Beaverbrook extension will

result in the relocation of six families currently occupying property that will be required to construct the road. The speaker also advised that the proposed road would involve the destruction of her home. Mrs. Schaug could not understand the need for the road as it will not alleviate the traffic problems in the area. Mrs. Schaug referred to a meeting held at the Cameron Street School on 1982 May 12 where a petition containing the signatures of two hundred and sixty (260) residents was presented to Council requesting that the neighbourhood be allowed to remain as it is at present. If the Beaverbrook extension is necessary, then at least have it connect with Reese Avenue, which would not involve the taking of anyone's property. Mrs. Schaug also stated that she did not wish to see Cameron Street widened as this would only result in an increase of traffic on the street. In concluding, Mrs. Schaug advised that they wished to make some improvements to their home and requested that they be given an answer as to where the road will be located, when will construction start and when will their properties be required?

- (d) Mr. Kenneth Cox, 2495 Norcrest Court, then addressed the members of Council and advised that he was appearing on behalf of the Sullivan Heights Ratepayers Association at tonight's meeting. The substance of Mr. Cox's presentation is contained hereunder:

"As you are no doubt aware, the residents of Sullivan Heights are most concerned about any proposed changes in and around the Bell Avenue, Cameron Street and Beaverbrook Drive area. The primary reasons for these concerns are:

1. That Cameron Street is the commercial and recreation centre for the area.
2. That all Sullivan Heights residents must enter and exit the neighbourhood along these streets.
3. Unusually heavy demands are being placed on these streets, not only by the residents, but also by shoppers and business people as well as a steady stream of commuter traffic from Coquitlam and other districts looking for shortcuts through our neighbourhood into Vancouver.

It is my understanding that the other delegations here are primarily concerned about their property on Cameron Street and how the livability has deteriorated along this street. For some the final straw will be the proposed Beaverbrook extension. If it goes ahead as planned, it would not surprise me at all to see adjacent properties go up for sale and long time residents abandon this area. I know that Council has toured this area and is aware that Sullivan Heights homeowners maintain their residences extremely well. The residents are also very concerned about the overall condition and appearance of the neighbourhood. However, a few homeowners who would like to make improvements haven't simply because they don't know what is going to happen to their property. Council is also aware that a definite plan for the area is in order, but it must be one that the residents can live with and feel is in their best interests. To this end, this Association is in the process of conducting an information poll of all the ratepayers in our area to ascertain precisely how the residents feel about such contentious issues as the barricades in our area, the routing of the Beaverbrook extension, whether or not it is even desired, access to the Lougheed Highway and the impact of commuter traffic through our neighbourhood. Once this information has been collected it will be presented to Council. It is our hope that Council will then be better informed to give responsible direction to the Planning Department so that the most desirable and beneficial use is made of the land in this area, and similarly that road changes in this area concerning either the municipal or provincial governments are made only after consultation and concurrence of the neighbourhood residents."

In response to questions from Council, Mr. Cox advised that the results of the poll will be available within one month.

(e) Mrs. Mary Wright, 9337 Cameron Street, then appeared before Council and advised that she was a long time resident of the area and was appearing here tonight to protest the proposed alignment of the Beaverbrook extension. Should the construction of this road proceed it will pass through the property owned by Mrs. Wright. Mrs. Wright explained that the quality of the lifestyle in the area has deteriorated subsequent to the construction of the highrise apartments in the area and the blockading off of several streets. Traffic pours out onto Cameron Street from the highrise developments and those establishments contained within the commercial or recreational portion of the developments. The residents are also faced with dealing with the traffic resulting from the new recreation centre, the Lougheed Mall, the garden apartments in the area, and also through traffic coming from Coquitlam, Port Moody and points east. In the midst of all this, there is the elementary school where the children must lead charmed lives as no one has yet been injured as a result of the traffic. Mrs. Wright questioned why the Beaverbrook extension is even being considered. If a road must be built, what are the reasons for considering the Beaverbrook/Cameron alignment over a route up between Cameron and Sullivan to Reese Avenue. In concluding her presentation, Mrs. Wright advised that she believed she has earned the right to select the time when her house is to be sold.

(f) Veronica I. Woodcock, 1982 October 06,  
Re: Proposed extension of Beaverbrook, widening of Cameron Street and closure of Bell Avenue.

This delegate did not appear before Council this evening.

(g) Mr. Arnold Stepler, 9311 Cameron Street, then addressed the members of Council and advised that he has owned his property for approximately 30 years and did not wish to move at this time. The property is centrally located and convenient to his place of work. Mr. Stepler could not understand why the municipality did not use the property they owned behind his property on Cameron Street to construct the Beaverbrook extension. Mr. Stepler asked Council to reconsider the location of the proposed Beaverbrook extension.

Maintenance Centre. An agreement in principle has been obtained to relocate the transmission facilities from the middle of the site to a corridor on the periphery of the site. B.C. Hydro and B.C. Transit will be required to provide certain undertakings that the relocation of these facilities will be compatible with community objectives for the area.

A land exchange is also proposed whereby surplus municipal lands will be exchanged for lands which will be acquired by B.C. Transit and which are required for the Byrne Road-Tenth Avenue connector.

The Municipal Manager recommended:

- (1) THAT Council authorize the preparation and execution of an easement to contain the relocated B.C. Hydro transmission facilities as shown on figure 1 attached to the report, subject to the following:
- (a) Written confirmation of the verbal undertaking from B.C. Hydro that the construction of the future 230 KV transmission lines will be in an underground situation.
  - (b) Written confirmation of the verbal undertaking from B.C. Hydro to install transmission poles with stand-off insulators abutting the Byrne-Tenth Connector for the existing and proposed 69 KV transmission lines.
  - (c) Preparation of an engineering design by B.C. Transit to establish final grades and road widths for that portion of the Byrne-Tenth Connector abutting the relocated transmission line.
  - (d) Approval of the foregoing design by the municipality.



- (e) Written confirmation of the verbal undertaking from B.C. Transit that they will landscape the right-of-way abutting the Byrne-Tenth Connector with suitable plant material which is compatible with transmission facilities and approved by B.C. Hydro and the municipality.
  - (f) Preparation of the requisite right-of-way plans by B.C. Transit.
- (2) THAT Council authorize the transfer of title on 1982 December 31 of additional municipal lands, as shown on figure 2 attached to report to B.C. Transit, for the sum of \$1.00, subject to B.C. Transit acquiring and dedicating lands currently owned by B.C. Hydro and which are required for the Byrne Road-Tenth Avenue major road connector.

E N Q U I R I E S

ALDERMAN BROWN:

Alderman Brown enquired as to who would be responsible for taking action with respect to a home at 3735 Albert Street which has been vandalized and may at some time in the future be further vandalized and set on fire.

In response to Alderman Brown's enquiry, Alderman McLean read a letter from the Director - Fire Services to the owner of the property at 3735 Albert Street ordering the house to be boarded up.

Alderman Brown enquired as to whether the municipality has any information on, or any input into, the decision to remove all the existing trees from the Holy Cross Church lands on Delta Avenue and the placing of fill on this property to a height of eight feet facing Taralawn Court.

In response to Alderman Brown's enquiry, the Director Planning & Building Inspection advised that he will investigate this enquiry and inform Alderman Brown of his findings.

Alderman Brown enquired as to why the municipal crews were removed from the municipal property at 9637 Cameron Street this morning after being on the site for only a short period of time.

1982 October 12

In response to Alderman Brown's enquiry, the Director Engineering replied that the municipal crews had been prepared to deal with the septic tank and field. However, the decision to not do any work today was at the request of Mrs. Mann, who advised that she had been told by the Municipal Manager that probably only work of a survey nature would be carried out today. Rather than mislead Mrs. Mann, or appear to have misled her, the crews were removed from the site. It was Mrs. Mann's request for a one day deferment.

ALDERMAN STUSIAK:

Alderman Stusiak enquired as to whether the contract had been awarded for the paving of Marine Way.

In response to Alderman Stusiak's enquiry, the Director Engineering advised that the department had been informed on Friday, 1982 October 08 that the contract had been awarded and they were now in the process of obtaining details from the Department of Highways as to an estimated completion date.

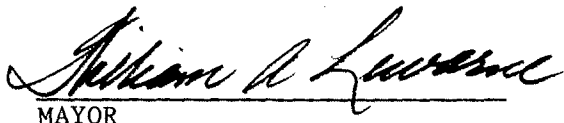
