

(a) Mr. R.W. Hassard, President, Weiser Inc., then addressed Council on the subject of the Loaned Executive Assistance Program. The following is the substance of Mr. Hassard's submission:

"A few years ago your Municipal Manager, Mr. Melvin Shelley, called some of us from the private sector to discuss a program he thought could be of benefit to both the municipality and Burnaby's business community. He described a cooperative approach in which employees from private enterprise would come and work together with municipal employees on specifically selected municipal projects. The idea was that the private sector would acquire an understanding of governmental operations and processes, and the municipality, on the other hand, would receive outside expertise and an objective appraisal of systems and procedures from highly qualified professionals at the right price - absolutely no cost. That initial contact led to a number of contacts and before long the Loaned Executive Assistance Program, or LEAP as it is more commonly called, was successfully launched.

Council received a report on this program in 1980 March. The current report and some other background information was forwarded to you last week with the agenda, so it is unnecessary to spend your time this evening on an explanation of how the program actually works in practice. I would merely point out that the format and guidelines that were developed are serving us very well, and we are encouraged by the results achieved to date.

I would like now to introduce to Council the members who serve on the LEAP Executive Committee. Seated in the gallery are:

Mr. J.B. (Jim) Garton, Senior Vice President, Transmission Division for AEL Mictrotel Ltd.

Mr. A.W. (Andy) Marynowski, Refinery Manager, Shellburn Refinery.

Absent this evening are:

Mr. R.A. (Roy) Moore, Comptroller for Dairyland

Mr. F.S. (Frank) Tucker, Vice President, Customer Service, British Columbia Telephone Company who, together with me, complete our representation from the private sector.

At the front table, from the public sector, is Mr. Shelley, representing the municipality. I want to add that the Municipal Management Committee, as the result of recent deliberations, are now also members of the Committee, and the Directors will therefore attend and participate in all future LEAP Executive Committee meetings.

In addition to the two LEAP projects which have already been worked on and two others that have been identified for initiation in the future, I should point out that a number of mutually rewarding discussions have taken place at meetings involving municipal staff and the Executive Committee. We are highly pleased with the results because exchanges of information on topics such as productivity, succession planning, training and development, quality circles, citizen involvement, organization, etc., provide participants from both the public and private sectors with new insights, perspective and practical information that is useful in the day to day management of our respective work situations.

Due to labour contract negotiations pre-empting the attention of both municipal staff and private sector participants, our activity pretty much went on 'hold' during most of 1981 and some of the initial momentum was lost. However, we resumed meetings early this year and I believe soon will get our teeth into some more worthwhile projects for the future. It should be remembered, in any event, that this is a long-range, longterm endeavour and not a make-work project for any of us. All of those participating both from public and private sectors have plenty to do in their own fields so there is no panic if an occasional lull occurs in the LEAP activities.

Meetings are generally held every two months at the Burnaby Municipal Hall and during last year, several meetings were held at the facilities of our private sector participants. This allowed a quick, comprehensive tour of the various facilities so that each member of the LEAP Committee has become familiar with not only the public sector facilities and procedures with which we are involved, but also with some of the private sector facilities and procedures.

My colleagues and I from the private sector have developed an even greater respect and admiration for the progressive attitudes and undoubted competence of Burnaby's Municipal Management Group having been afforded the opportunity to become more aware of what goes in 'our' municipal administration. Of course, there is no end to the new challenges which will be encountered by management both in the public and private sectors. The need to find better ways to do things will remain unending.

The knowledge resources potentially available to the municipality through the Loaned Executive Assistance Program are immense and are available without cost to enhance the other volunteer resources mustered from within our community by you, the elected Council. Your continued encouragement and recognition of the Loaned Executive Assistance Program within your staff and within the community is all that the program needs to inspire us to continue to explore and implement better ways for achieving the objectives set by Council."



The Municipal Manager provided a report concerning the proposal to restructure the G.V.R.D. Labour Relations Function.

The Municipal Manager advised that he has not been persuaded by the discussion that took place at the March 29 Council Meeting or by his research since that time, that Burnaby would benefit by withdrawing from the Labour Relations function. It is absolutely critical that there be a balance of power at the collective bargaining table. If there are gains to be made by being outside the G.V.R.D. for this function, they will, in the opinion of the Municipal Manager be short term in nature.

On the other hand, it is possible for Burnaby to provide this service with its own staff, and there will probably be a savings in cost. For that savings in cost there is a risk which can easily offset it. That is the risk of not getting the best settlement possible as a result of the whip-sawing that is sure to be experienced. We would likely end up informally working with not only the G.V.R.D., but also other municipalities that may opt out of the function, and we would slowly get back to where we were with the Municipal Labour Relations Bureau in the late 1960's.

There is little doubt that the structure and the management processes in the G.V.R.D. Labour Relations function need to be improved. There is also little doubt that each municipality must concentrate on improving the working relationship between itself and its unions, and the answer to that may well be to put into place some form of year round bargaining of non-monetary items. That is a policy decision and it can be implemented either within or without the G.V.R.D.

8. Letter from Mr. Cliff Bressler which appeared on the agenda for the 1982 April 05 Meeting of Council, Willingdon Avenue extension to Patterson Avenue

The Municipal Manager provided a report from the Director Engineering concerning the Willingdon Avenue extension to Patterson Avenue.

The Director Engineering noted that in 1968 the Engineering Department designed what was to be a major arterial connection between Kingsway and Imperial Street that followed the Willingdon Avenue alignment from Kingsway to Maywood Street and then swung to the west to connect to Patterson Avenue just north of Imperial Street. The design called for Willingdon Avenue to underpass the existing B.C. Hydro Central Park rail freight line.

The Burnaby Comprehensive Transportation Plan includes this road link as a major collector rather than an arterial. It is programmed for implementation in conjunction with the development of the Metrotown Core and A.L.R.T. (i.e., it would be built before 1986).

The Director Engineering wished to assure Mr. Bressler that the municipality's interest and options will be fully protected regarding the possible extension of Willingdon Avenue and to thank him for his continuing interest in future development of roads in his area of Burnaby.


