

RECOMMENDATIONS:

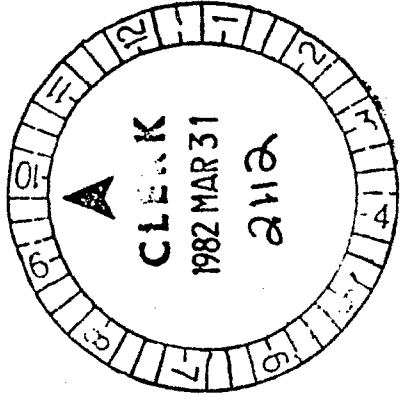
