WELCOME

PROCLAMATION

(a) Mr. Steve Zeswick, 7397 Kingsway, then addressed Council on the problems he was encountering with the property adjacent to his occupied by Lavigne's Engine Rebuilders Ltd. at 7405 Kingsway, and the lack of co-operation on the part of municipal staff in dealing with these problems. The following is the substance of Mr. Zeswick's submission:

"Mr. Zeswick reported that he had problems with garbage on his neighbour's lot, which despite his complaints to the municipality, had not been removed. Mr. Zeswick also pointed out that a business was being conducted at 7405 Kingsway which was not permitted by the Burnaby Zoning Bylaw. Mr. Zeswick advised Council that he was constantly harassed by the Licence Department staff with regard to yard sales which he conducted on his property. Mr. Zeswick had requested the Licence Department to take him to Court to let a judge decide as to who was right or wrong in this instance. Another result of the engine rebuilding activity on his neighbour's lot was the fumes caused by the running of engines. Mr. Zeswick also complained of the lack of co-operation on the part of the local media when he has requested assistance from them in solving his problems. Mr. Zeswick also advised Council that oily parts of engines were stored in plain view of his own property and that building permits had been issued which extended the legal non-conforming use of the property at 7405 Kingsway. Mr. Zeswick was also concerned that his garden has been contaminated by leaking oil from the Lavigne property."

MOVED BY ALDERMAN CONSTABLE: SECONDED BY ALDERMAN STUSIAK:

"THAT staff bring forward a report on the accusations and items mentioned by Mr. S. Zeswick in his presentation."

CARRIED UNANIMOUSLY

(b) Mr. Owen Dykstra then addressed Council on the subject of labour relations. The following is the text of Mr. Dykstra's submission:

"First of all, we want to express our appreciation to you for once again giving us the opportunity to put forward our suggestions for improving labour relations between the Corporation and our local union.

The purpose of this submission is twofold. First, we will summarize briefly the position we put forward in September of last year. Secondly, we want to clarify the collective bargaining policy of the Canadian Union of Public Employees as adopted at our National Convention in October, 1981.

When we appeared before you last we had just suffered the longest municipal strike in our history. It is now generally acknowledged by all the parties involved ... the municipal councils, the unions, the public and even the Greater Vancouver Regional District ... that the strike need not have happened, or could have been shortened considerably, if there had been changes in the G.V.R.D. bargaining structure.

We proposed at that time, and we still propose, the following changes:

First, it is absolutely clear that the elected council's of the municipalities involved in the G.V.R.D. must take back responsibility for the collective bargaining process. As one analyst, (Jack Clarke, The Province, 1981 May 7) pointed out at the time, it was surprising that the G.V.R.D. bargaining group did not shatter under the enormous internal pressures of frustration and dissension experienced by municipal representatives because of their loss of control.

We maintain that this Council, as the elected government of the Corporation, has the responsibility of overseeing all the physical and social needs of your community. That community includes your employees.

Furthermore, you are the people who are most informed about the resources of this district and are closest to its needs. You also have the obligation to be accountable to the citizens of Burnaby for decisions that are made on their behalf.

We realize this is often difficult for elected people, particularly in the controversial area of labour relations. As one local mayor has said, politicians may be tempted to use the G.V.R.D. as a buffer between them-selves, their employees, and the taxpayers. But, he pointed out, those politicians who hide behind the G.V.R.D. can quickly lose touch with local employees' needs. (The Province, 1981 May 17)

In our previous submission, we outlined how our local needs differ from other municipalities. We have different priorities, methods of operation, and job responsibilities. Many of our job classifications and specifications are unique. All these differences must be taken into account at the bargaining table, and, in fact, in the day-to-day relationships between our local union and the Corporation.

These matters are most effectively dealt with between our local union and appropriate committees of the Corporation, and should not be turned over to a separate body that is unapproachable and unfamiliar with local needs.

In the end, this means that labour relations are a responsibility that politicians must face. Our union is confident that this Council is not reluctant to fulfill this responsibility.

With these considerations in mind, we maintained, and continue to maintain, that the Corporation should discontinue its present involvement and commitment within the G.V.R.D. Labour Relations Department.

For the same reasons, we feel that a move in the other direction to the even more binding restraints of formal accreditation would also be a mistake, as other accredited employer groups have discovered. We discussed this in some detail in our previous submission, pointing out that this results in even more loss of control by local municipal councils.

Finally, in our previous submission, we proposed a model for municipalities within the G.V.R.D. based on voluntary association in order to co-operate and co-ordinate with each other. With this kind of liaison, municipalities would be able to take into account the effects of their actions on each other. But most important, each municipal council would have the freedom to act independently if they find their own interests are not being met within this alliance.

The G.V.R.D. Labour Relations Department would then function purely as a research group during collective bargaining, offering consultation, information, support and assistance to its member municipalities when called upon.

This brings us to the second part of our submission -- C.U.P.E. collective bargaining structure. The model we have proposed for the municipalities is in fact similar to the model employed by the unions which were negotiating either jointly or independently with the G.V.R.D. the last time around. It is based on voluntary association and the agreement of wholly and completely autonomous local unions to co-operate and coordinate with one another so long as their needs are being met. At all times, local unions have the right to discontinue that association prior to, during, or subsequent to negotiations.

At our recent Convention, C.U.P.E. adopted a Collective Bargaining policy which has been published in our Autumn, 1981 edition of our national magazine The Public Employee. Some people who have read that policy statement may have misunderstood it, believing that it proposes a structure different than the one we have outlined here. In fact, a careful reading of the resolution that was passed will show that the structure is exactly the one we already have in place in our Co-ordinated Bargaining Committee. It is exactly what we are discussing - a coordination 'with other local unions in the same jurisdiction and within a meaningful geographic region'.

Each local union is free to act autonomously when its own interests require it. Merger is suggested only for those locals having the same employer. This does not apply to the District of Burnaby since all our employees are already members of the same local union.

Our National Departments of Organizing and Servicing, Research and Public Relations act in a consulting and support capacity, much in the same way that we are suggesting is appropriate for the G.V.R.D. Labour Relations Department or any other consultative body.

In summary, a voluntary association, both for municipalities and unions, providing for independence within it, is the structure that will best service all our needs. You must consider the effects of your decisions on other communities, but your first obligation is to your own, including your own employees. We must weigh the effects of our actions on other local unions, but we look to our own welfare and well-being first.


You are accountable to your constituents and we to ours.

We trust that you will give these recommendations your serious consideration."

With the unanimous consent of Council, Mr. Dykstra then went on to discuss the recently announced reduction in the Burnaby budget for 1982 of \$2 million and the affect of this reduction on a possible reduction of municipal staff. The following is the substance of Mr. Dykstra's submission on this subject:

"Your Worship, I believe that it was at the last Council meeting a motion was passed to reduce the proposed expenditures for 1982 by \$2 million. In discussing this matter with various Aldermen, it was my understanding that it was the intent to reduce or not go beyond the services that were Now what has happened is that our first problem supplied in 1981. occurred today and that is the reason for the urgency of it. The Library has informed us that because of Council's decision they have to cut some services. One service will be cut completely, and that is the Storybuses, with the result that six people will be affected, and of course indirectly by the bumping procedures. We were led to believe that, not officially of course, that the \$2 million only affected new services and programs for 1982. We were also led to believe that although you decided that permanent municipal forces were not to exceed the 1981 complement, you did not say that a reduction through layoff was You did make reference to not hiring and to vacancies. required. You also made mention of reducing the use of consultants. I know one consultant that costs the municipality a lot of money, and that is the G.V.R.D. Labour Relations Department. Seriously, to cut programs and effect layoffs, it is somewhat different than private industry, because you end up basically fooling the taxpayers. The taxpayer, first of all, you cut the service like the Storybuses, supposedly to reduce the budget, which it will. At a time like this, when the economy is the way it is, those people will not find other jobs. They will be either on unemployment or on welfare. It will be some other agency that will be paying the shot, and the same taxpayers will be, indirectly, having to pay money. Really, to sum it up, the taxpayer loses twice, because they lose the service and they are still paying. Certainly, in our opinion, that will not improve the economy. We respectfully ask you seriously consider If it was not your intention to layoff staff in order to reduce this. the 1982 budget, that you clearly instruct staff regarding those instructions because certainly some department heads cannot do it.





The Library, for example, had to reduce their budget by \$170,000.00. They ended up by having to cut \$104,000.00 in wages, which will mean people out the door.

ENQUIRIES

ALDERMAN CONSTABLE:

Alderman Constable noted that on a recent trip to Victoria to discuss Oakalla Lands, Mayor Lewarne had been accompanied by Elwood Veitch. Alderman Constable noted there were eight elected members of the Municipal Council, two of whom had served on the Oakalla Lands Committee and who were fully conversant with the subject. Alderman Constable enquired as to why the Mayor had not selected a person who was an elected official of the municipality to accompany him to Victoria on this occasion.

His Worship, Mayor Lewarne, replied that Mr. Veitch had served as Chairman of the Oakalla Lands Committee, which has not yet been disbanded. Mr. Veitch was available at the required time and had accompanied the Mayor at his own expenses.

ALDERMAN BROWN:

Alderman Brown enquired as to the present status of the 13 applications for strata titling of duplexes.

The Director Planning & Building Inspection advised that these applications were currently being processed.

ALDERMAN McLEAN:

Alderman McLean noted that a municipal truck had apparently spilled garbage on Sprott Street just off Douglas Road, which was apparently plugging up the ditch at this location.

The Director Engineering advised that he would look into the situation immediately.

Alderman McLean noted that three cars were parking illegally outside the Municipal Hall between the entrance to the Aldermen's parking lot and the Kushiro Gardens Tablet. The cars in question were apparently municipal employees' cars.

It was agreed that the Municipal Manager and Director Engineering would look into this situation.

Alderman McLean requested that he and Alderman Nikolai be provided with a plan of the Cameron Recreation Library Park/Site indicating municipally owned land in this area.

It was agreed that the Director Planning & Building Inspection would provide Aldermen McLean and Nikolai with the information requested.

Alderman McLean noted that the third high rise apartment had now opened at Kingsway and Patterson Avenue. Alderman McLean was of the opinion that access to this tower was to be from Bond Street, but in fact access was now being gained from Patterson Avenue. Alderman McLean enquired as to whether the Patterson Avenue access to this tower was legal.

It was agreed that the Director Planning & Building Inspection would provide Alderman McLean with the information requested.

Alderman McLean further noted that a raised concrete left turn slot had been constructed on Canada Way in the vicinity of MacDonald Avenue. Alderman McLean was of the opinion that this concrete divider was a definite hazard to traffic and would be the cause of a serious accident.

It was agreed that the Director Engineering would examine the situation of concern to Alderman McLean.
