(a) Mr. Nigel Hacker then addressed Council on the subject of regulations in the Burnaby Zoning Bylaw prohibiting construction of a basement or cellar in R5 zoning. The following is the substance of Mr. Hacker's submission:

"My problems in this connection arose when the Building Department refused, or did not allow, the plans for a semi detached duplex at 3806 Burke Street. This was earlier this month. Prior to the submittal of these plans to the Building Department my client approached that department and asked for its regulations and was told that the maximum permitted floor area was 1247 square feet per unit, that a cellar was permitted provided it was half under grade and was allowed to be finished as long as it was not a separate living unit and he is allowed to have bathrooms in the up and down portions of the unit. Upon looking at various buildings of the same structure we approached the owner of the plans on one of them, purchased these plans which were architecturally designed, and upon making making a few cosmetic changes, such as upgrading the site plans so that they were appropriate for the site which he proposed to build on, he submitted them, at which time a Plan Checker told him that they were now counting a cellar as part of the square footage, because some people are putting in illegal suites in the basement. He advised the Plan Checker that this is not what he had been told earlier. The previous building, which is built and standing at this The Plan Checker told him that this was something time does have a cellar. that they had decided to start doing without any direction from Council. The existing structure is on Grassmere Street. My client would like to have a decision made on this because it is quite important that he start building before the end of the month. His plans have been in the Building Department for almost a month now and it will be a large financial loss to him if construction is not started within the next week.

The Chief Building Inspector advised that an application for a semi detached, two family dwelling on the above property was taken on 1982 May 03 from a contractor acting on behalf of Shafer-Haggart Ltd., property owner.

On 1982 May 04, Mr. Shafer was contacted by telephone by Mr. Grant Davey, Plan Checking Supervisor, to be informed that plans submitted showed a maximum gross floor area in excess of 1247.30 square feet per dwelling unit due to the suite of rooms proposed to be finished in each cellar of the two family dwelling. This was subsequently confirmed at a meeting between Mr. Davey and Mr. Shafer's designer, Intarsia Design Ltd. on 1982 May 06.

The main floor dwelling unit contains approximately 1190 square feet in a three bedroom dwelling unit. When the finished cellar floor area is taken with the main floor area, an aggregate area of some 2010 square feet is developed by each dwelling unit of this semi detached two family dwelling.

This is still Mrs. Maniago's plan and she objects strongly to the proposed change in zoning.

After purchasing this property, in good faith, for the purpose of eventually developing it, Mrs. Maniago felt that it would be unfair of the municipality to unnecessarily change the zoning, thereby drastically reducing the value of her investment in the property.

Item 5, Municipal Manager's Report No. 35, 1982, pertaining to this subject, was brought forward for consideration at this time.

WHEREAS every policy decision, every separate program during the year should be viewed in relation to:

- 1. Its demand upon the financial resources of the municipality;
- 2. Its impact upon all of the municipality's existing program services;
- 3. Its relationship to medium and long term municipal goals; and

WHEREAS the Municipal Council of Burnaby does not have a vehicle to continuously review and monitor the financial impact of its actions; and

WHEREAS the creation of a new Finance Advisory Standing Committee would provide an interface between the Municipal Council, its committees, its departments and staff; and thus create an organizational structure which would review municipal policies, programs and their impact on the municipal budget; and

WHEREAS the function of the new Finance Advisory Committee would be to assist the Municipal Council in an advisory role and would not negate the principle of Council supremacy as the only enacting or decision making body:

THEREFORE BE IT RESOLVED that the Municipal Council of The Corporation of the District of Burnaby appoint, on the nomination of the Mayor, a Finance Advisory Committee of no fewer than three nor more than five members of Council which shall include the Mayor; the primary purpose of which is to assist and advise the Municipal Council on the following:

- 1. The review of major policy decisions in relationship to existing programs and goals of the municipality.
- 2. The review of major policy decisions in relationship to their impact on the municipal budget."
