 - (b) Construction of two driveway accesses across the drainage ditch on the south side of Willard Street.
 - (c) Preparation of the survey plans required to provide two consolidated parcels as shown on figure 1 in the report.
- (3) THAT Council authorize the preparation and introduction of a Road Closing Bylaw as shown on figure 3 in the report.
- (4) THAT Council allow the vendors to continue farming at 8955 Royal Oak Avenue rent free for a period of two years.

9. Approval of Internal Signs in Interior Malls of Shopping Centres - Burnaby Sign Bylaw 1972

The Municipal Manager submitted a report from the Director Planning and Building Inspection concerning a recently conducted review of the provisions of the Burnaby Sign Bylaw as they apply to the special case of interior signs in shopping centre malls.

The Municipal Manager recommended:

- (1) THAT a bylaw be prepared to amend the Burnaby Sign Bylaw 1972, Bylaw No. 6163, in accordance with the terms outlined in Section 3.1 of the report.
- (2) THAT the proposed text amendment bylaw be brought forward for Council consideration in conjunction with the recommendations of the Burnaby Sign Bylaw Review Committee for review and coordination.

10. Sanitary Sewer Rates

The Municipal Manager submitted a report from the Treasurer outlining the findings of an annual review of rates carried out in connection with Council's objective to make the sanitary sewer system self-liquidating. The report recommends ten percent increase in sewer rates in 1983, which would increase the charge for a single family home by \$7.60 - from \$75.70 to \$83.30 in 1983. Although this increase would not make the sewer system self-liquidating in 1983, it is expected that a further increase of ten percent in 1984 would achieve that goal.

The Municipal Manager recommended:

- (1) THAT bylaws to amend Bylaws Nos. 6232 and 4231, being Burnaby Sewerage System Parcel Tax Bylaw 1973, and Burnaby Sewer Charge Bylaw 1961, be brought down to incorporate the taxes and rates shown under the column in Schedule A attached to the report and headed "1983 Effective January 01".
- (2) THAT a further report be placed before Council in 1983 October concerning rates recommended for 1984.

11. Exemptions from Taxation

- (2) THAT the properties listed in Section 4 be exempted from taxation in 1983.

The Municipal Manager submitted a report from the Treasurer regarding the eligibility of the South Burnaby Golden Age Society to be granted exemption for 1983 taxes on the building and property that they lease at 5024 Rumble Street.

The Municipal Manager recommended:

(1) THAT the Burnaby Taxation Exemption Bylaw No. 2, 1982, Bylaw No. 7973 be excluded from recommendation No. 1 of Item 11, Manager's Report No. 62, 1982 November 08.
