 (a) Mr. Kenneth Cox, President, Sullivan Heights Ratepayers Association, then addressed Council on the subject of the traffic patterns in northeast Burnaby. The following is the substance of Mr. Cox's submission:

"I would like to speak this evening on behalf of the Sullivan Heights Ratepayers Association regarding the study recently done on traffic patterns in northeast Burnaby. Firstly, I would like to commend Council for holding the Public Meeting at Cameron School on May 12. The large turnout reflected the high level of concern regarding traffic problems in our area. After reviewing this report, I feel that the Planning Department has done a good job of interpreting citizens' input at that meeting, although there was no mention that homeowners do not want further encroachment by multiple dwelling units north of Cameron Street. This item that was raised at the meeting was not strictly a traffic issue, but I would like to bring it up. The main items that I would like to comment on tonight are the proposed Beaverbrook extension and the existing Broadway extension. It is a fact that the Sullivan Heights Ratepayers group does not support any Beaverbrook

extension. We feel that it does nothing to solve residential traffic problems, but only adds to a worsening commuter problem. However, if Council and Planning are adamant about providing Coquitlam residents easier access through our neighbourhood by way of a streamlined Beaverbrook extension, we would apreciate a full study and close cooperation with all affected residents before any decision is made to finalize any route, be it one that runs behind the Cameron Recreation Centre, or the one that links diagonally with Cameron Street before the Centre. It is also our desire that the area have the least amount of negative impact possible and that future expansion of the Community Centre and adjacent parkland will not be jeopardized.

Turning to East Broadway, the residents along that street deserve Council's most earnest attention as the plight they have to put up with is indeed a sorry one. We recommend that along with the other three recommendations proposed by the Planning Department that this matter be also looked at immediately to see what relief can be afforded them, either through municipal or provincial government action. The other items, the closure of Bell Avenue, the provision of a crosswalk, other possible access routes in the area, stricter enforcement of traffic regulations, must all be dealt with if we hope to maintain a high standard of livability in our neighbourhood. I am sure that Council feels as strongly as I do about getting some relief in those areas as quickly as possible. That is basically what I have to say, but I understand that Council was also on a tour of the area this afternoon and if there are any questions that Council may have that I could possibly answer I would be pleased to do so."

#### CARRIED UNANIMOUSLY

 (a) Greater Vancouver Regional District, Chairman, G.V.R.D. Board, Re: British Columbia Place Proposal and its Regional Transportation Implications

A letter dated 1982 July 14 was received advising that the G.V.R.D. Board's principal concern with the British Columbia Place proposal is its regional transportation implications. Much of the proposal is in keeping with regional policies - increased housing downtown, enhancement of waterfront areas for public use, added cultural, entertainment and recreational facilities - and the project has the potential to make a significant contribution to Greater Vancouver's livability. The contemplated large office component, however, signals the loss of a valuable opportunity for the provincial government to improve the regional distribution of employment and thereby assist in reducing regional transportation problems. It is the Board's view that government leadership should be encouraging employment growth in regional town centres.

The G.V.R.D. Board welcomes full and open review of the British Columbia Place development concept currently in process and the Chairman was pleased that the G.V.R.D. can contribute constructively to those discussions.

# (b) L.J. Stupak Re: Train whistles in Government Road area at Cariboo Road, Piper Avenue and Sperling Avenue

A letter dated 1982 July 20 was received concerning the passage of an anti-whistle bylaw to minimize train noise at level crossings in the Government Road area, specifically in respect to level crossings at Cariboo Road, Piper Avenue and Sperling Avenue. The writer urged Council to pass this bylaw as soon as possible in order to improve the quality of life in the neighbourhood.

Item 9, Municipal Manager's Report No. 46, 1982, pertaining to this subject, was brought forward for consideration at this time.

The Municipal Manager provided a report from the Director Engineering concerning an anti-train whistle bylaw on the B.N.R. Central Valley rail line.

The Director Engineering advised that the rail line of concern to L.J. Stupak, the Burlington Northern's Central Valley line, now has signals and/or signals and crossing gates at all public road crossings and would thus appear to meet the requirements for approval of an anti-train whistling bylaw.

In view of the above, we will be applying to the Canadian Transport Commission regarding the feasibility of enacting an anti-train whistling bylaw to cover just the B.N.R. rail lines in the Central Valley and the Lake City Industrial Park spurs.

(e) Government of Canada, Environment Canada, Minister, to Corporation of Delta, Re: Fraser River Estuary Study

A letter dated 1982 July 20 addressed to the Municipality of Delta was received regarding municipal input to the proposed management program for the Fraser River Estuary.

In addition to municipalities which have an important role in decisions regarding the use of the estuary, there is a wide spectrum of federal and provincial agencies, user groups and citizens concerned about the river's future. Accordingly, a review process is underway to provide an opportunity for all affected interests to contribute to the proposals before implementation.

Municipal comments or questions may be directed to the representatives on the Federal-Provincial Review Committee.

Item 10, Municipal Manager's Report No. 46, 1982, pertaining to this subject, was brought forward for consideration at this time.

The Municipal Manager provided a report from the Director Planning & Building Inspection concerning the Fraser River Estuary Study.

The Director Planning & Building Inspection advised that at this point in time staff have not had an opportunity to review these reports in detail and, therefore, a further report will need to be submitted to Council summarizing those aspects of its study which may impact Burnaby and providing specific recommendations where required.

A letter dated 1982 July 22 was received expressing concerns about the conditions suffered by animals at the Pet Shop in the Lougheed Mall.

Item 1, Municipal Manager's Report No. 46, 1982, pertaining to this subject, was brought forward for consideration at this time.

The Municipal Manager provided a report from the Chief Licence Inspector concerning conditions in the Pet Shop located in the Lougheed Mall.

The Chief Licence Inspector reported that provincially, the responsibility for the humane care and welfare of animals rests with the S.P.C.A. as authorized by the Society's own Act. A copy of Ms. Scott's letter has been forwarded to C. Jack Homes, Secretary-Manager, Vancouver Regional Branch, S.P.C.A. In discussion with Mr. Homes, we are advised that an investigation will be carried out and that action will be taken as warranted. Further, that pertinent information resulting from the investigation will be forwarded to Mr. Robinson and Ms. Scott by Mr. Homes.

For Council's further information, the Chief Public Health Inspector advises that the sanitary conditions at the Pet Shop are satisfactory. Following receipt of the letter, an inspection of the shop determined that puppies and kittens in cages were active and readily responded to the Inspector's attention. At the time, the temperature in the cages was  $24^{\circ}$  C ( $74^{\circ}$  F).

A petition dated 1982 July 22 was received seeking Council's assistance regarding the absolute lack of sanitary and property maintenance at 6211 Sumas Street, Burnaby, B.C. by the owner and resident, Anthony Wilden.

The petition noted that the Burnaby Department of Health and Environment had been contacted several times regarding this. The Inspector has done his utmost to persuade the owner to clean up the site. However, there is little improvement except that the garbage is removed temporarily and then allowed to accumulate once again.

The surrounding properties are reasonably well maintained and it is felt that this establishment is depreciating the value of the immediate neighbourhood.

Council was advised that a staff report on this subject would be available on 1982 August 23 and further consideration of the matter was deferred until that time.

(n) T. Niccoli, Re: Grant to Vancouver Opera Society

A letter dated 1982 August 03 was received requesting that Council reconsider its earlier decision not to approve a grant to the Vancouver Opera Association.

The writer considered that the Vancouver Opera Association is a serious, professional and cultural entity, that merits the attention and support of responsible citizens.

 (o) Province of British Columbia, Ministry of Provincial Secretary and Government Services, Minister, Re: Amendment to Library Act

A letter dated 1982 July 29 was received drawing Council's attention to an amendment to the Library Act which was recently passed by the Legislature. In this amendment, the province is responding to a resolution by the Union of British Columbia Municipalities which urged that Municipal Councils right of approval of public library budget requests be clarified.

This power was implicit in the Library Act. However, the language was not specific and the amendment is intended to remedy this situation.

The normal process of negotiations and consultation between Library Board and Municipal Councils will continue to serve as it has in the past. This amendment simply defines where the authority of final approval lies.

The Acting Municipal Manager feels that a preferable alternative would be to construct a chipwalk on Burnwood at this time, rather than a concrete sidewalk, and the chipwalk so constructed would serve as a base for a future concrete sidewalk. The \$10,000.00 (approximately) cost would be charged to the 1982 budget provision in Code 60-09-Special Road Projects.

# ENQUIRIES

# ALDERMAN NIKOLAI:

Alderman Nikolai expressed concern regarding the methods currently used by Council in handling rezoning applications and the subsequent readings of zoning bylaw amendments. Alderman Nikolai was particularly concerned that the interests of an applicant for a rezoning could be severely compromised by the absence of one or more Council members from the Council Meeting at

which a rezoning application or an amending bylaw was considered. As an example of his concern, Alderman Nikolai drew Council's attention to Rezoning Reference #10/82 covering 6750 Cariboo Road. Rezoning Reference #10/82 had been considered by Council at its meeting on 1982 July 26 at which time both Alderman Nikolai and Alderman Emmott had been absent. At that meeting the recommendation of the Municipal Manager that a bylaw covering Rezoning Reference #10/82 be brought forward for consideration on 1982 August 09 and advanced to a Public Hearing on 1982 August 24 was not adopted by Council. Alderman Nikolai suggested that the Municipal Manager investigate the procedures currently used by Council in this regard and submit a further report on the subject to Council.

# ALDERMAN BROWN:

Alderman Brown drew Council's attention to two enquiries that he had raised at the last Council Meeting concerning the use of firecrackers in the northwest Burnaby area and the erection of steel posts in the lane adjacent to the Kentucky Fried Chicken Shop at Kingsway and Burlington Avenue.

With regard to Alderman Brown's first enquiry, His Worship, Mayor Lewarne, advised that we were now in possession of the Prince George bylaw covering residental nuisances. Included in this bylaw was reference to firecrackers. The Prince George bylaw was currently being examined by various municipal departments to determine its applicability to Burnaby.

With reference to Alderman Brown's second enquiry, the Acting Municipal Manager advised that the municipality had gone about as far as they could go in this matter without creating a very serious precedent.

#### ALDERMAN McLEAN:

Alderman McLean noted that members of Council had recently attended the dedication ceremonies for the Islamic Temple on Canada Way. Following the completion of this Temple, Alderman McLean noted that it would likely become a major tourist attraction in the municipality and the resultant traffic problems would be horrendous. Alderman McLean suggested that the Director Planning & Building Inspection examine alternate means of access and egress from the site. Alderman McLean further suggested that the possibility of obtaining access and egress to the Temple site through Discovery Parks should be investigated.
