(a) Leroy P. Stinar, 1983 June 06, Re: Business Taxation Spokesman - Leroy P. Stinar

MOVED BY ALDERMAN BROWN: SECONDED BY ALDERMAN STUSIAK:

(a) Mr. Leroy P. Stinar, 4352 Victory Street, then addressed the members of Council and advised that he is the Vice-President of Mafco Imports Ltd., a local Burnaby company, and he was appearing before Council tonight to express his concerns over the heavy tax burden being placed upon businesses in the municipality. The text of Mr. Stinar's presentation is contained hereunder:

"I am here to protest personally the high taxes that are being placed on businesses in Burnaby, especially in the last three years. We lease buildings, and I received this year's tax bill from the gentleman we lease the building from, and while the taxes have gone down a small percentage, I still feel as I did last year, that the taxes are an unfair burden on the business community. I would like to know what Council is going to do in the years ahead to reduce these taxes. As an example, I got a letter from the owner of the building that I would like to read. I last year approached him to talk to the municipality and appeal the taxes, but it was too late last year, and I have made various phone calls to all levels of government without any satisfaction, there was nothing that we could do. This year when I received notice of the taxes I did the same thing, being very irate, and finally was fortunate enough to get hold of Alderman Brown, who suggested that I come here tonight. The letter that I have solicited is from Roadwest Properties, the owner of the property which we lease, and they write: 'We enclose a letter to the Corporation of the District of Burnaby for your appeal to the 1983 taxes as you requested, we have added our dissatisfaction on the 1983 taxation amount and trust that it will be of some assistance to your appeal. Good luck in your pursuit.' The letter received from Roadwest Properties goes on as such: 'As owners of the above property, we hereby authorize our tenant, Mafco Imports Ltd., permission to submit their appeal on the 1983 taxes. We realize that such appeals are heard in February each year, however, since we did not receive an assessment notice this year we were unable to submit our appeal in the usual manner and in our opinion we feel the 1983 taxes are exceptionally high considering the property has devaluated in the past few years. We would appreciate your cooperation in giving this matter a thorough review.' I am not aware whether the assessment notices went out and were not received by this company, I received my residential assessment, I do not know if they received their assessement. However, they have made several appeals on property they own, except ours was unfortunately not among them. trying to represent is a building, a building that we are part occupant of, of 50,000 square feet. There are five tenants, including ourselves, we represent twenty percent of the occupancy of the building. My problem is with this one building, where the five tenants are expected to pay \$52,000.00 in property taxes to the Municipality of Burnaby. Last year the taxes were \$56,000.00, and if I wanted to rate this ahead a few years we could be looking at, in a ten year period, a minimum of \$540,000.00, or more likely, with increases, we could be anywhere up to \$750,000.00 to \$1 million in property taxes if any more revenue is required by the Municipality of Burnaby. I think this is an unrealistic figure to expect businesses to operate and to generate a profit and pay the Municipality of Burnaby potentially \$1 million in a period of ten years. There doesn't seem to be anything that is going to be left after the ten year period. Now I realize today we are looking at \$108,000.00 in two years, could you explain to me how you expect the businesses of Burnaby to carry on if they have to pay this type of tax burden year after year, or could anyone at Council?

I would like to, if I may, summarize or close with the statement that I know it is a difficult task, though I do not accept that it is an impossible task to reduce the taxes in Burnaby. As a businessman, you know that if it costs you more to operate than you are earning you must do something, you do not reach out and find money that is somewhere else designated to another purpose, you know that as well as I do. Therefore, I think the tax situation, the tax structure in Burnaby, must be looked at even closer in the year ahead because I don't accept that it must continue to rise, I believe that we can cut some of the programs that we want and get back to some of the programs that we need. Thank you."

ENQUIRIES

ALDERMAN BROWN:

Alderman Brown enquired as to the current status respecting the property at 1387 Holdom Avenue whereby the municipality is to install ripple bars to protect the property from vehicles that end up in the front yard or crashing into the home as a result of accidents at the intersection of Holdom Avenue and Kitchener Street. Vehicles travelling west along Kitchener Street down the steep grade are sometimes unable to stop at the intersection and end up travelling across Holdom Avenue up over the curb and sidewalk and onto the property of Mr. and Mrs. Rizzo. Alderman Brown advised that there has been a further accident since this matter was last discussed and something should be done immediately.

Alderman Brown further enquired as to whether anything can be done with respect to the access to Marine Way from Trapp Avenue.

In response to Alderman Brown's enquiry, the Director Engineering advised that his department has been in contact with the Department of Transportation and Highways and advised the province that there are a number of unhappy people in this area and have asked the department to revise their design. The municipality is unable to do anything more than this as it is a provincial government responsibility. The Director Engineering further stated that he would contact the Department of Transportation and Highways in the morning to determine if the department has contacted people in the area and advised them of what can be done to help alleviate the problem that exists.

Alderman Brown further enquired as to whether or not a house being renovated on Monarch Street is within the guidelines of all municipal bylaws.

In response to Alderman Brown's enquiry, His Worship, Mayor Lewarne advised that he has looked into this matter and the home is indeed within all the municipal bylaw requirements.

ALDERMAN STUSIAK:

Alderman Stusiak enquired as to why the two lots known as 7945 12th Avenue have not been offered on the market. Alderman Stusiak requested a report back for the information of Council.

ALDERMAN McLEAN:

Alderman McLean enquired as to the possibility of looking at a new classification for houses such as the one on Monarch Street that are being built to such a height as to obstruct the views from surrounding properties. Alderman McLean advised that he would be bringing forward a notice of motion respecting this matter.

Alderman Lawson then referred to an article entitled "Joint Adventures Public/Private Partnerships" on page 10 of the newspaper, which included a description of the LEAP Program (Loaned Executive Assistance Program) which has been operating in Burnaby for a number of years.
