- (c) Mrs. Gladys M. Brundrett, 7978 Lakefield Drive, Program Coordinator for the Burnaby Meals on Wheels, then addressed the members of Council. The following is the text of Mrs. Brundrett's submission:

"Burnaby Meals on Wheels has not had to ask the Municipality of Burnaby for funding in all of its almost 15 years of operation. We have been delivering meals to Burnaby shut-ins since 1968 May, in ever-increasing numbers. Meals on Wheels has approximately 100 volunteeers who give freely of their time and energy. Our volunteers gave approximately 8,700 hours of time in 1982. Based on minimum wage of \$3.50, this would be \$30,450.00. Our volunteers are not compensated for gas.

Since 1974, the Provincial Government, through the Ministry of Health, has provided a grant to pay a part time coordinator and maintain an office. However, it is the policy of the Provincial Government not to subsidize the cost of the meal to the recipient. Until 1983 this was not a problem for our program as Simpsons Sears, our caterer since 1968 September, had always made up the difference between what was charged to the client and what it cost Sears to produce. This difference has increased over the years to a staggering \$28,000.00 in 1982.

Sears, like most corporations, has been very much affected by the economic situation. Sears headquarters in Toronto advised Sears Burnaby that the deficit in future would only be covered by 50 percent. Sears proposed then to increase the cost of the meal to \$3.25 starting 1983 February 01. This would have meant an increase of 75¢ per meal to the recipient. Meal cost was already increased once in 1982 in August, from \$2.25 to \$2.50 to cover increases in labour and food. Thus, in less than 12 months, the meal cost would have been increased by \$1.00 - a very large increase to the clients, who in most cases are old-age pensioners on fixed incomes.

If clients discontinue Meals on Wheels and thus require homemaker service to prepare meals, the cost to the public purse increases dramatically. If one-quarter of the 18,900 meals delivered in 1982 were prepared by homemakers, the cost would have been \$42,525.00 (4,725 meals x \$9.00). Also, Meals on Wheels provides a preventative measure by keeping nutritional levels up, thus keeping the clients out of acute hospitals and long term care facilities for a longer time. Often the Meals on Wheels volunteer is the only person to visit the client - reporting back to the office any changes that might require a visit from the Health Department.

Sears in Burnaby has negotiated with Toronto to decrease the cost from \$3.25 to \$2.90. While this was a much better proposal to our clients, it is still a hardship to those on fixed incomes. When we made our first proposal to the Grants Committee, we thought our shortfall would be about \$1,000.00 per month. Thanks to Sears' reconsideration, it will be about \$600.00 (based on 1,400 meals per month) and it is now being paid by the client. The price to the client was increased to \$2.90 1983 February 01.

The reduction in meals delivered when the price was increased is significant. Sears has also advised that they will no longer be able to cater for us after the end of 1983. This means a new caterer at possibly a higher cost.

We ask that Burnaby Council consider funding the packaging of the meals. This portion of the meals cost is $26 \, \text{c}$ per meal. This would be \$364.00 per month (based on 1,400 meals/month) depending on the case load, or \$4,368.00 per year.

In summary:

- 1. This is a Burnaby service to Burnaby residents through Burnaby volunteers (no gas/mileage compensation).
- 2. This is an alternative to costly homemakers' services, which would cost \$42,525.00 for one-quarter of the meals.
- 3. This is a preventative service and a support service to the Health Department and Long Term Care Program.
- We are, therefore, proposing that Burnaby Council fund the packaging of the meals at 26¢ per meal (\$4,368.00 per year).

The Municipal Manager submitted a report from the Director Planning and Building Inspection advising that the primary purpose of the registered Burnaby symbol is to represent the Corporation of Burnaby. If Council wish to extend the privilege of use to other community groups, it is recommended that appropriate criteria be established to assist in the evaluation of proposals.

It is suggested that Council support for requests to use the Burnaby logo be extended only where Council is satisfied that the following criteria is met:

- (a) Use is proposed by a broadly based, non-profit community group or government sponsored agency that serves, in some significant way, the interest of a substantial segment of the population of Burnaby, and not by a business enterprise.
- (b) The organization seeking permission is exclusively or primarily composed of Burnaby residents, or is based in and primarily operating for the benefit of Burnaby and its citizens.
- (c) The proposed application is strictly for non-profit, noncommercial purposes.
- (d) Council is satisfied that the use and application of the logo by the organization will not unduly dilute the public impact of Corporation use, nor detrimentally affect the public's reponse to the display of the logo by The Corporation of the District of Burnaby.
- (e) The application design is consistent with the design standards employed in the creation of the symbol and the preparation of its approved applications.
- (f) It is agreed that Burnaby retains ownership and reserves the Copyright to the logo, and reserves the right to automatically withdraw its permission if the use ceases to meet the criteria as established.

10. Hastings Street Urban Renewal
Rezoning Reference #142/81
Hastings/Pender/Ingleton/MacDonald
Residential/Commercial/Recreational Proposal
Public Square Development

The Municipal Manager submitted a report from the Director Planning and Building Inspection advising that on 1982 November 22 Council received a status report on the Hastings Street Urban Renewal Rezoning Reference #142/81. Council was informed that the 1982 November 05 date for entering into a new purchase agreement has passed without the agreement being signed by the applicant/developer. The proposed dates for completion of the rezoning proposal and of the land sale were 1983 January 17 and 18. Staff had waited until these scheduled dates had passed on the chance that the developer would be able to obtain sufficient financing to proceed with the project. However, it is now clear that the developer will not be proceeding.

In light of the fact that the subject Rezoning Reference #142/81 is virtually complete, including the submission of a suitable plan of development, it was considered appropriate to suggest that other developers may be willing and able to carry on with and complete the rezoning proposal, including the purchase of Site 3. The project architect has interested a developer in making a bid for the site, subject to compliance with the prerequisites of Rezoning Reference A minimum upset purchase price of \$1.65 million is outlined #142/81. by the Legal and Lands Department. It is proposed that Site 3 be offered for sale by public tender. The concurrence of the Province and CMHC, the other partners in the Hastings Street Urban Renewal Partnership, will be obtained prior to the initiation of the public tender.

The Municipal Manager recommended:

- (1) THAT Site 3 be offered for sale by public tender.
- (2) THAT the sale be subject to the terms of this report, including the determination of a minimum upset price of \$1,650,000, and the completion of the prerequisites for Rezoning Reference #142/81 requiring compliance with the suitable plan of development prepared by Russell Vandiver Architects and Torrence Vagelatos Ltd., Landscape Architects, and the deposit of the necessary charges, the servicing deposits and bonding including that related to the public square development.
- (3) THAT the other partners of the Hastings Street Urban Renewal project, the Province and CMHC, be requested to concur with the sale of Site 3 according to the terms outlined in the report.

AND WHEREAS The District of Burnaby has received an application from David J. Ho, Architect, to construct a garage, install a driveway entrance door to the basement of the existing residence, enclose portion of the veranda and extend the existing porte cochere;

THEREFORE BE IT RESOLVED that the additions and alterations as more specifically noted in the report be approved by Council, subject to conformance to the applicable provisions of the Bylaws and Codes and any minor variance that may or may not be authorized by the Board of Variance relative to siting of the alterations and additions."

- (2) THAT prior to the issuance of Municipal Approval a Restrictive Covenant pursuant to Section 215 of the Land Title Act be registered against the title of the property to preclude outside storage of vehicles, commercial use associated with the storage activity and mechanical repair of vehicles on the property.
- (3) THAT a copy of the report be sent to the present owner of the property, Dr. S. Karim.
