- (a) This delegation did not appear before Council at this evening's regular Council Meeting.
- (b) Mr. Richard C. Lupton, 7938 Edson Avenue, then addressed the members of Council regarding an apparant traffic hazard at the intersection of Portland Street and Sussex Avenue. Mr. Lupton, using a model of the intersection at Portland Street and Sussex Avenue that he prepared, illustrated to Council the location of hedges that encroach onto a highway right-of-way and cause a vision clearance problem at the intersection. Mr. Lupton referred to his prior appearance before Council as a delegation and his appearance before the Traffic Safety Committee on two occasions as a delegation to express his concerns with respect to this problem. The speaker advised that in his opinion there was no room for compromise and both the laurel hedge and lilac hedge and existing fences that encroach onto the highway right-of-way on the southeast corner of the intersection should be removed. Mr. Lupton requested that Council take action to eliminate the existing traffic hazard at this intersection.
- (c) Mr. Frank F. Still, 4637 Pender Street, then addressed the members of Council and requested that Council support the recommendation of the Traffic Safety Committee to install permanent roundabouts at the intersections of Pender Street and Gamma Avenue, Pender Street and Alpha Avenue and Pender Street and Beta Avenue. Mr. Still felt that the temporary roundabouts that were installed approximately six months ago served the purpose intended and reduced vehicular traffic speeds and volumes along Pender Street.

AND WHEREAS the Minister of Municipal Affairs has confirmed in a letter dated October 13, 1983 that Council may contribute to the continuation of this service through an agreement with the Greater Vancouver Regional District under Section 770(2) of the Municipal Act;

NOW THEREFORE BE IT RESOLVED that (The Corporation of the District of Burnaby) agrees to enter into an agreement with the Greater Vancouver Regional District to provide development coordination and development information services;

AND BE IT FURTHER RESOLVED that such agreement shall commence on January 1, 1984 and terminate on December 31, 1988 unless earlier terminated either by mutual consent or by one of the parties;

AND BE IT FURTHER RESOLVED that, in the event that one party wishes to terminate the contract, such party shall provide the other party with one year's notice of such action by November 30;

AND BE IT FURTHER RESOLVED that by October 1 of each year, Greater Vancouver Regional District shall forward to (The Corporation of the District of Burnaby) a list of services to be provided in the following year and an estimate of the cost of such services to (The Corporation of the District of Burnaby), and that such list be subject to the approval of (The Corporation of the District of Burnaby) by resolution within 30 days of its receipt;
