(f) His Worship, Mayor Lewarne, Re: Outcome of the recent meeting with the Minister of Transportation and Highways in Victoria

His Worship, Mayor Lewarne, provided members of Council with a verbal report regarding the meeting that took place between representatives from The Corporation of the District of Burnaby and the Minister of Transportation and Highways in Victoria on 1982 November 30. The following is the substance of the Mayor's report:

"I have a verbal report to make respecting the meeting we had with the Minister of Highways between the Chairman of the Traffic Safety Committee, the alternate to the Chairman of the Transportation Committee, the Municipal Manager and myself. There is an item of correspondence which was addressed to myself from the Minister that provides us with a response to our meeting. The topics that we discussed in Victoria, there were nine of them, were:

- Parking on Hastings Street there is a response in the letter that states that the Ministry is in total agreement with the parking ban in the a.m. westbound on the north side of Hastings and that they will be meeting with our staff in that regard. Concerning the easterly flow of traffic in the afternoon, the Ministry will be looking at left turns at various locations without creating a total parking ban. They will also be looking at the signalization of Hastings Street.
- 2. The waterfront road we talked about this matter and they were not prepared to take any action at this time.
- 3. Broadway we talked about this matter and they were not prepared to take any action at this time.
- 4. Highway #1, the Freeway I am sorry to report that there will be no action taken respecting this matter.
- 5. Traffic signalization Co-ordination as I mentioned earlier, they will be reviewing the signalization on Hastings Street, but with respect to the signalization on Kingsway, they advised that they had a more pressing problem with respect to the blacktopping of Kingsway as the road is in very poor condition, when this is done they will also be looking into the matter of curbing and rewiring for signalization. With respect to the traffic signalization on the Lougheed Highway, they said that they didn't feel that this had a priority high enough to be concerned about. On the Lougheed Highway at Bell Avenue, they are prepared to look at a left turn holding bay, but not signalization and they will be meeting with our staff to review that.
- 6. The Kingsway and Edmonds Street intersection we did discuss this matter and we said that we felt that it was overdesigned. They stated that they would be reviewing this matter.
- 7. The Burris and Canada Way intersection it was in last year's budget and was taken out because of a lack of funds. They said that they will review it and see if they can't put it in the 1983 budget.
- 8. The North Road project it was not supported from the secondary highway funds last year and we are still working on that. The Manager and I had a discussion today and we will see if we can't work out something on this with the programs that were announced by the Federal Finance Minister and the Provincial Finance Minister when these programs come down. They did indicate that it was for diking and bridging and part of the North Road project is bridging.

9. The Canada Way and Edmonds intersection - we had correspondence to show that was going forward so we had no problems there.

So it does look like we came out of the meeting with about three or four items of the nine that we discussed."

His Worship, Mayor Lewarne, at this juncture in the meeting, introduced to Council Mr. Jack E. Herrmann, the new Manager of the Burnaby Chamber of Commerce, who will be taking over from the former Manager, Mr. Angus Macdonald, who has served in such a capacity for 21 years.

 - Proposed land exchange involving lands required for the Riverway Golf Course and municipal lands designated for agricultural use

The Acting Municipal Manager submitted a report from the Municipal Solicitor written in response to a request from Council for a further report from staff regarding the proposed land exchange involving lands required for the Riverway Golf Course and municipal lands designated for agricultural use. - (4) THAT Council allow the vendors to continue farming at 8995 Royal Oak Avenue rent free for a period of two years.
