4. Acquisition of municipal lands to facilitate relocation of B.C. Hydro Railway relative to A.L.R.T. Maintenance Yard construction

The Municipal Manager submitted a report from the Director Planning and Building Inspection advising that in the course of reviewing the drawings for the A.L.R.T. Maintenance and Storage facility, staff noted that it was B.C. Transit's intention to relocate the B.C. Hydro rail line to permit the construction of the A.L.R.T. guideway adjacent to the Maintenance Centre. By and large, this relocation could be accomplished within the existing railway right-of-way, however, in the area between Twelfth Avenue and Tenth Avenue, it is evident that B.C. Transit would have to acquire municipal lands. Therefore, B.C. Transit was requested to prepare and submit a plan outlining the actual required area and to submit a formal request to acquire these lands.

The Municipal Manager recommended:

- (1) THAT B.C. Transit be given permission to enter a portion of Lot 74, Block 9, District Lot 171, Group 1, Plan 57312 N.W.D. (as shown on the attachment to the report as Figure 1) for the purpose of commencing the relocation of the B.C. Hydro Railway line.
- (2) THAT the granting of the foregoing permission to enter the subject lands does not constitute final approval for the sale of these lands which will be subject to agreement on land value.
- (3) THAT the Legal and Lands Department be requested to submit a further report on the sale of the subject lands, including a recommendation on the amount of compensation to be paid by B.C. Transit.
- (4) THAT a copy of this report be forwarded to Mr. Lionel Mercier, Manager, Property Services, B.C. Transit, 874 Four Bentall Centre, P.O. Box 49297, 1055 Dunsmuir Street, Vancouver, B.C., V7X 1P6.

5. Concept Submission Drawings - Comments A.L.R.T. System in Burnaby Patterson/Metrotown/Royal Oak/Edmonds Stations Rezoning Reference #47/82

The Municipal Manager submitted a report from the Director Planning and Building Inspection advising that the Planning and Building Inspection Department reported to Council on 1982 November 08 advising that the broad parameters of the A.L.R.T. system were becoming fixed and that municipal staff had been involved in reviewing preliminary design submissions to ensure that they conform with municipal technical/policy requirements. More detailed concept design submissions had been received on the four A.L.R.T. stations in Burnaby and staff had sent comprehensive comments to B.C. Transit on these drawings. B.C. Transit has now replied to a number of the highlighted comments. A few other related A.L.R.T. issues which have been under recent discussion are also outlined for the consideration of Council.

The Municipal Manager recommended:

(1) THAT staff be authorized to work with B.C. Transit to assure the acquisition of the remaining required portion of N. Beresford Street right-of-way west to Silver Avenue off the property 6102 Silver Avenue from the owner, GTE Sylvania (Electrolier) and the provision of the necessary roadworks to serve the Metrotown A.L.R.T. Station and bus loop by B.C. Transit.

- (2) THAT B.C. Transit be requested to acquire the 33 foot widening for the 18th Avenue right-of-way off the property at 7445 19th Street and to provide the necessary 18th Avenue cul-de-sac roadworks to serve the Edmonds A.L.R.T. station and bus loop.
- (3) THAT staff be authorized to initiate rezoning applications for the Metrotown and Edmonds bus loops on a similar basis as the arrangements pursued with B.C. Transit on the four A.L.R.T. stations in Burnaby.
- (4) THAT B.C. Transit be requested and municipal staff be authorized to work together to obtain the approval of B.C. Hydro and/or to achieve the necessary legislation to permit landscaping and park/trail development within the B.C. Hydro right-of-way and that B.C. Transit be requested to provide appropriate landscape provisions in identified areas where there is no legal problem.
- (5) THAT within the Byrne Creek Ravine the top of the two subject footings be lowered by B.C. Transit as required for ravine preservation.

### NEW BUSINESS

His Worship, Mayor Lewarne, advised that Honourable Alexander V. Fraser, Minister, Ministry of Transportation and Highways, announced the following items at a press conference that was held in the Burnaby Municipal Hall Council Chamber on 1983 March 30:

- (1) The Municipality of Burnaby will receive a grant of \$532,799.00 for itself and the District of Coquitlam under the Ministry's secondary highway program. The grant will be applied to the cost of a new railway overpass on North Road.
- (2) A grant of \$3,767,221.00 will go to the Municipality of Burnaby under the Province's Revenue Sharing Act for continuing work on the overpass at Kensington Avenue of both the Burlington-Northern Railway and the Lougheed Highway.
- (3) The Province has provided funding for major highway work which includes the repaving of the section of Kingsway involving 7.5 kilometres from Boundary Road to Edmonds Street.
- (4) Funds are also being provided for the paving of Highway No. 1 for a distance of 6.2 kilometres from Port Mann to Deer Lake in which various sections will be recapped.
- (5) A day labour project will also involve reconstruction and general improvement of the intersection of Canada Way and Burris Street. The Ministry will provide left turn slots and improve the intersection for greater traffic capacity.
