On 1983 August 22, Council received a letter from several petitioners and two reports from staff on the occupancy of premises at the subject address. Following is a report from the RCMP on this same subject.

RECOMMENDATION:

1. That a copy of this report be forwarded to Maria PERKO, 5310 Manor Street, Burnaby, B.C. V5G 1B7, for the information of the complainants.

SUMMARY:

The letter to council dated 83/08/12 signed by a number of residents of Manor Street registers a formal complaint identifying alleged unlawful activities by occupants and/or visitors at noted residence on Manor Street.

REPORT:

The spokes person for the petitioners was personally visited by a member of the R.C.M.P. assigned to investigate this written complaint. The purpose was to review the circumstances first hand, where it referred to police involvement, and to explain what concrete evidence is needed before prosecutor action can be entertained, along with the need for witnesses to be able to positively identify offenders; from the aspect of parking infractions, these can be dealt with on site when police are called to the scene.

Burnaby Detachment records indicate attendance was made to 5294 Manor Street on the following dates:

83/06/10 - Detachment members responded to a noisy party complaint in which 50-60 people were involved. Members had to re-attend three additional times before the party was terminated.

83/06/17 - A complaint was received from one of the concerned neighbours who had been approached by one of the occupants of 5294 Manor Street. The neighbour felt threatened by the occupant who was upset by the fact neighbours had called the police to a previous noisy party which also resulted in the Health Department becoming involved with 5294 Manor Street.

83/08/17 - Members attended to investigate an alleged assault upon one of the residents of 5294 Manor Street.

83/08/19 - Burnaby Drug Section attended 5294 Manor Street with a search warrant, however, were unsuccessful and no charges laid.

With respect to information supplied by neighbours concerning a noisy party at 12:37 A.M. on 83/08/21 on Manor Street, reveals our members attended at a residence in the 4900 block of Manor Street.
