(b) Greater Vancouver Regional District, Chairman, G.V.R.D. Board of Directors, 1983 October 26, Re: The Municipal Amendment Act (1983) and the G.V.R.D.'s Planning Function

A letter dated 1983 October 26 was received advising that the Greater Vancouver Regional District Board of Directors has decided to ask each member Council to consider entering into an agreement under Sections 770(2) of the Municipal Act to undertake the continuation of the activities presently provided by the Regional Planning Function, minus the regulatory role.

Item 11, Municipal Manager's Report No. 67, 1983 November 07, was brought forward for consideration at this time.

The Municipal Manager submitted a report from the Director Planning and Building Inspection providing clarification on a number of points raised by Council at the regular Council Meeting held on 1983 October 31 in connection with Council's consideration of a proposed resolution adopted by the Greater Vancouver Regional District Board of Directors at their meeting of 1983 October 26 respecting Bill 9, the Municipal Amendment Act (1983).

The Municipal Manager recommended:

(1) THAT Council adopt the following resolution passed by the Greater Vancouver Regional District Directors at their meeting of 1983 October 26:

"WHEREAS the provincial legislature has enacted The Municipal Amendment Act (1983) which removes the statutory authority of regional districts to undertake regional planning and to enact Official Regional Plans;

AND WHEREAS it is the desire of The Corporation of the District of Burnaby to receive the benefits of the non-regulatory development coordination and development information services provided by the Greater Vancouver Regional District;

AND WHEREAS the Minister of Municipal Affairs has confirmed in a letter dated October 13, 1983 that Council may contribute to the continuation of this service through an agreement with the Greater Vancouver Regional District under Section 770(2) of the Municipal Act;

NOW THEREFORE BE IT RESOLVED that The Corporation of the District of Burnaby agrees to enter into an agreement with the Greater Vancouver Regional District to provide development coordination and development information services;

AND BE IT FURTHER RESOLVED that such agreement shall commence on January 1, 1984 and terminate on December 31, 1988 unless earlier terminated either by mutual consent or by one of the parties;

AND BE IT FURTHER RESOLVED that, in the event that one party wishes to terminate the contract, such party shall provide the other party with one year's notice of such action by November 30;

AND BE IT FURTHER RESOLVED that by October 1 of each year, Greater Vancouver Regional District shall forward to The Corporation of the District of Burnaby a list of services to be provided in the following year and an estimate of the cost of such services to The Corporation of the District of Burnaby, and that such list be subject to the approval of The Corporation of the District of Burnaby by resolution within 30 days of its receipt;

AND BE IT FURTHER RESOLVED that the list of services to be provided in 1984 contained in Schedule A attached hereto is hereby approved by The Corporation of the District of Burnaby, provided that the cost of the services to The Corporation of the District of Burnaby shall not exceed \$109,065.00 in 1984;

AND BE IT FURTHER RESOLVED that appropriate officers of The Corporation of the District of Burnaby be directed to enter into such an agreement on behalf of The Corporation."

- (4) THAT a copy of this report be forwarded to the Parks and Recreation Commission for information.

In response to Alderman McLean's enquiry, the Municipal Manager, Mr. M.J. Shelley, advised that the apportionments established by the Greater Vancouver Regional District are based on the assessed values as established by the British Columbia Assessment Authority.

ALDERMAN NIKOLAI:

Alderman Nikolai enquired as to whether other members of Council are aware of the unsightly condition of property at 5137 McKee Street. Alderman Nikolai suggested that Council review the unsightly premises bylaw in order that the municipality may take further action against property owners who attempt to circumvent the existing bylaw.

Alderman Brown advised that the delegation that was scheduled to appear before Council this evening regarding a lane behind the 200 block North Gamma Avenue did not appear for the reason that a spokesperson was not selected as all the residents involved expressed concern over their anticipated nervousness in appearing before Council. Alderman Brown requested that the Municipal Engineer again look into the matter of providing a turnabout at the end of the subject lane to allow vehicles to reverse their direction at the end of the lane.

In response to Alderman Brown's enquiry the Director Engineering, Mr. E.E. Olson, advised that he would again look into this matter and advise Council of his findings.
