Hopkins, Executive Director of the Vancouver Neurological Centre, then addressed the members of Council in regards to the Centre's grant application that was denied by Council at the Council Meeting held on 1983 June 13. Mr. Hopkins provided Council with the following information:

Administers the affairs of five societies

B.C. Epilepsy Society
Children's Rehabilitation and Cerebral Palsy Association
B.C. Parkinson's Disease Association
Myasthenia Gravis Foundation of B.C.
B.C. Neurological Group Homes Society

- VNC operates an outpatient rehabilitation centre in Vancouver.
- VNC provides the majority of therapy treatment in the home, school and community.
- VNC is a critical link in the paramedical treatment of the neurologically disabled.
- VNC currently provides services to 34 Burnaby residents.

In Burnaby, there are:

204 persons with cerebral palsy)	estimates of average incidence

In Burnaby, VNC active caseload as of December

17 persons with epilepsy
17 persons with cerebral palsy

IN BURNABY, one infant (nine months) and two children (3 years) with cerebral palsy and one teenager (17 years) with epilepsy are currently wait-listed.

- In 1982 VNC provided \$78,840 in direct treatment service to 34 Burnaby residents.
- Presently VNC provides 98 one hour treatments per month to Burnaby children. As well, another 23 Burnaby residents receive assistance through special education and social service counselling.
- In 1982, 11 percent of VNC's active caseload resided in Burnaby.
- Presently, there are 4 wait-listed for treatment now residing in Burnaby.

Our grant request to Burnaby Council was for \$4,400 or 5.5 percent of actual costs.

Previous grant allocations from Burnaby Council have been \$3,500.

On behalf of those Burnaby citizens presently receiving treatment, as well as those citizens who are wait-listed, we urge Council to reconsider their previous decision and reinstate our grant status."

- (b) This delegation's request to appear before Council at tonight's Council Meeting was WITHDRAWN.
- (c) Mr. J. Stewart Alsbury then addressed the members of Council and advised that he has been designated as the spokesman for the managers and residents of the four apartment blocks in the 7100 block Fulton Avenue. Mr. Alsbury advised that over the last few years the people in this area have been harassed continuously by young people utilizing the Richmond Park. The residents have asked for assistance from the Parks and Recreation Commission but seem to have come up against an insurmountable barrier, and hence the request to appear before Council as a delegation at tonight's Council Meeting. Mr. Alsbury then advised Council of the specific problems which the residents are being faced with. A summary of these problems is contained hereunder:
 1. The existing four and a half foot chain link fence separating the lane behind two of the apartments and Richmond Park is in a state of disrepair.

2. The two and a half foot chain link fence from Richmond Park to the cul-de-sac on Fulton Avenue is not high enough. The residents wish to see a fence built to a sufficient height to prevent individuals from easily jumping over the existing fence.
3. Vehicles are continuously parked adjacent to the only fire hydrant in the area.
4. The parking problem on Fulton Avenue may restrict access to the apartments of emergency vehicles.
5. Garbage is continuously strewn about the lane connecting Vista Crescent to Holly Street.
6. Vehicles are driving down the dead-end lane adjacent to the park and parking. The people in the vehicles then jump over the broken down fences, or have beer parties in their vehicles and throw the empty bottles on to the apartment lawns. On occasion these individuals have driven their vehicles over the apartment lawns in order to turn round.
7. The Parks and Recreation Department installed two posts at the eastern end of the walkway between Richmond Park and the cul-de-sac at Fulton Avenue and though these posts prevent vehicles from proceeding down the walkway, motorcycles are still able to travel along the walkway.

In response to Mr. Albury's presentation, Council requested that staff prepare a report dealing with the items presented by both Mr. Alsbury and Council at tonight's meeting.

Staff do not foresee in the future suitable space for archives storage being available within any of the recreation facilities.

- (1) THAT the Municipal Solicitor be authorized to draft the appropriate amendments to the text of the Burnaby Sign Bylaw to define ICMS signs, to permit them as facia signs in the C3, C4 and P2 Districts, and in CD Districts based on C3, subject to the applicable existing standards; and also to permit them in freestanding form in major shopping malls only, subject to the applicable existing standards.

Section 3.5:

- (2) THAT Council confirm its decision to retain the present definition of "Sign Area".

Section 3.18:

- (3) THAT Council confirm its decision to retain the present provisions of the Sign Bylaw relating the maximum number of freestanding signs per street frontage.

E N Q U I R I E S

ALDERMAN CONSTABLE:

Alderman Constable enquired as to the purpose of a substantial amount of fill and rubble located on Greystone Drive east of the intersection of Duthie Avenue and Greystone Drive.

In response to Alderman Constable's enquiry, the Director Engineering advised that the material was being used as pre-load to a small number of lots in the area. The Director Engineering believed that the pre-loading had been completed and he would see to it that the material is removed as soon as possible.

ALDERMAN BROWN:

Alderman Brown enquired as to the status of the widening of Broadway with particular concern for the island that has been created as a result of the alterations to the road.

In response to Alderman Brown's enquiry, the Director Engineering advised that there have been no changes from the original plans and the construction along Broadway is nearing the completion stage with the curbing being installed at this time and the paving work to follow very shortly.

1983 August 08

ALDERMAN McLEAN:

Alderman McLean enquired as to the procedures used for booking Burnaby facilities. Alderman McLean was concerned specifically with the booking of the Burnaby Lake Pavilion. Alderman McLean felt that procedures could be instituted which would result in a far more efficient booking procedure for the facility.

In response to Alderman McLean's enquiry, Alderman Constable advised that as a member of the Parks and Recreation Commission he has looked into this matter many times. The Burnaby Lake Pavilion is a very popular facility and is now booked a year in advance. The procedures which are in place right now are very fair and appear to be appropriate for this facility. Alderman Constable advised that he would provide Alderman McLean with the latest report that the Parks and Recreation Commission received on this matter and he would further discuss the problem with staff once again.

ALDERMAN LAWSON:

Alderman Lawson enquired as to whether the municipality has responded to a request received from the U.B.C.M. to submit innovative new ideas or programs that have been initiated within Burnaby.

In response to Alderman Lawson's enquiry, Mr. A.L. Parr, Acting Municipal Manager, advised that he would look into this matter and inform Alderman Lawson of his findings.

ALDERMAN STUSIAK:

Alderman Stusiak enquired as to whether a response had been received to a letter that the Municipal Manager wrote to Mr. Larry Miller of B.C. Transit regarding the financing of the ALRT. Alderman Stusiak requested that the letter be made available to Council at the next Council Meeting to be held on 1983 August 22.

Alderman Stusiak further enquired as to the reason why the Stormont/Newcombe connector has not been given a specific time frame within the five year capital budget.

In response to Alderman Stusiak's second enquiry, the Director Engineering advised that the province has not been specific with respect to a time frame, but the municipality included, in a group, a number of roads for which the province has responsibility. The grouping was done so that the five year capital budget was not silent regarding responsibility for the road projects. To provide a time frame for the work without receiving any information from the province would be entirely guesswork.

Alderman Stusiak requested that the Chairman of the Transportation Committee include the question of the Stormont/Newcombe connector on the agenda for the next meeting of the Transportation Committee.

"THAT this regular Council Meeting do now adjourn."

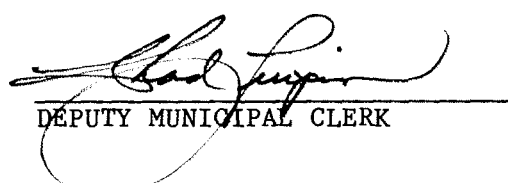
