(a) Mr. Lindsay McDonnell, 3651 Lindell Crescent, then addressed the members of Council on behalf of the Board of Directors of the Century Park Museum Association. Mr. McDonnell advised that it is the considered opinion of the Board of Directors and of the museum staff that the proposed Park Drive road layout would provide the access and visibility required by the museum and enclose an adequate amount of land for its future expansion. Mr. McDonnell then referred to a map which had been circulated to members of Council which showed the boundary outline of the proposed expansion lands agreed to in 1981 June. At that time what was proposed was an expansion at some future date to the area west of Deer Lake Avenue, but the trade-off of this area for a smaller but more suitable area east of Dale Avenue would fulfill their foreseable needs. This area would be north of the new proposed road and bounded by Sperling Avenue and Canada Way. It should be noted that included along side the museum's expansion plans is the expansion of the model railway along the Canada Way area.

Mr. McDonnell requested that priority be given to completing the "Park Drive" by constructing first the new road from Sperling Avenue across the Hart property and secondly, the new bridge from Dale Avenue to link up with Deer Lake Avenue. This will define the museum's boundaries and allow for the museum's expansion to proceed and to be concluded to coincide with Expo '86.

In conclusion, Mr. McDonnell requested that Council, if possible, grant some of the land from the Hart property from Sperling Avenue and bordering Canada Way to Heritage Village in order that a new road could be put through behind part of this property and that Heritage Village be granted approval to plan the final details for the proposed expansion.

> The Fire Services Committee submitted a report advising that Council, on 1983 November 07, referred back to the Fire Services Committee the recommendations respecting relocation of No. 1 Hall firefighting operations to the site at Canada Way and Banff Avenue and the construction of a firehall in the Big Bend area. In addition, Council at an informal budget meeting held on 1983 November 07, referred the question of whether or not the Public Education Officer should be included within the 1984 budget for the Fire Department to the Fire Services Committee.

Council then voted on the recommendations contained in the report of the Fire Services Committee. The recommendations were presented in the following three categories, being 1. relocating No. 1 Hall firefighting operation, 2. construction of firehall in the Big Bend area and 3. Public Education Officer in the Fire Department.

The Fire Services Committee recommended:

- 1. Relocating No. 1 Hall Firefighting Operation
  - (a) THAT Council reaffirm the relocation of No. 1 Hall firefighting operations to the site at Canada Way and Banff Avenue.
  - (b) THAT Council direct staff to proceed with the negotiation for the acquisition of the site at Canada Way and Banff Avenue.

- (5) The Vancouver Regional Transit Commission direct staff to prepare the necessary amendments to the transit tariffs contained in the 1984-85 Annual Operating Agreements with the Metro Transit Operating Company and West Vancouver to reflect the recommended fare plan;

be now adopted."

Overpass project and, as such, is eligible for a portion of the available surplus revenue sharing funds which had been allocated to the original overpass project terminating at Laurel Street. The project extension from Laurel Street to Sprott Street was included in the 1983 - 1987 Capital Budget and in the 1984 Provisional Capital Budget at a very rough preliminary estimated cost of \$250,000; this amount will be increased to \$300,000 in the 1984 Capital Budget to reflect a more realistic estimate, including appropriate median and boulevard treatment.

The Municipal Manager recommended:

(1) THAT the Municipal Solicitor be directed to bring forward a Capital Works Machinery and Equipment Reserve Fund Bylaw in the amount of \$300,000., being Burnaby's estimated cost of reconstruction of Kensington Avenue between Laurel Street and Sprott Street.

6. Trans Mountain Pipe Line Company Ltd.'s Request for a Permanent Easement Through Park Property West of Cliff Avenue

The Municipal Manager submitted a report from the Director Recreation and Cultural Services advising that the Parks and Recreation Commission at its meeting of 1984 January 04 received a staff report relating to a request from Trans Mountain Pipeline for a permanent easement, approximately 300 feet by 30 feet, through park property west of Cliff Avenue as shown on Sketch OP13-2-3s. Trans Mountain wishes to transport a partially refined petroleum product from Edmonton to the Shellburn Refinery at 201 Kensington Avenue. In 1981 January, the Engineering Department gave Trans Mountain approval for the installation of a 16 inch diameter pipeline in the road and lane rights-of-way along Cliff Avenue. Trans Mountain is now reconsidering that route and instead is seeking permission for an easement through park lands. The installation of the pipeline is still subject to Preliminary Plan Approval through the Planning Department. Installation is scheduled for the spring of 1984.

The Parks and Recreation Commission, at its meeting of 1984 January 04, subsequently approved the following recommendations:

- (1) THAT the Commission approve Trans Mountain Pipe Line Company Ltd.'s request for a permanent easement through park property west of Cliff Avenue.
- (2) THAT the Parks and Recreation Commission so recommend to Council.

Further, the Director Recreation and Cultural Services also advised that the Municipal practice of charging for easements was being researched and once this information was obtained the Municipal Solicitor would recommend an appropriate charge. The Parks and Recreation Commission has agreed to this procedure and the Municipal Solicitor has now recommended that the Trans Mountain Pipe Line Company be charged \$1,500 for the easement. This amount is considered reasonable compensation to the Municipality.

The Municipal Manager recommended:

(1) THAT Council approve Trans Mountain Pipe Line Company Ltd.'s request for a permanent easement of approximately 300 feet by 30 feet through park property west of Cliff Avenue as illustrated on Sketch OP13-2-3s and that the terms of the easement be as outlined in this report.

Authority was also granted to appropriate officers of The Corporation of the District of Burnaby to enter into such an agreement on behalf of The Corporation. The adoption of the resolution followed clarification that should a given Municipality decide not to participate in the program, the program would have to be reduced accordingly rather than increasing Burnaby's apportionment which for 1984 is set at \$109,065.00. The Planning and Building Inspection Department is now in receipt of an agreement including a Schedule of Services to be provided in 1984, the budget for each program item, and the apportionment of costs for 1984. The agreement also provides for an individual Municipality to withdraw from participating in the program if it is unable to reach agreement on the services to be provided and the costs thereof in succeeding years of the agreement which terminates on 1988 December 31. The document is the product of a cooperative process involving the participation of the Manager and technical staff from each Municipality and the Director Planning and Building Inspection has no hesitation in recommending that the agreement be executed as directed by Council at its meeting of 1983 November 07.

The Municipal Manager recommended:

- (1) THAT Council authorize the execution of the Agreement <u>attached</u> to the report including the Schedule of Development Services and Apportionment of Costs.
- (2) THAT Council endorse the Management Process for Intermunicipal Development Services described in the report and illustrated in Appendix A <u>attached</u> to the report.

8. Animal Control - SPCA Contract - 1984

The Muncipal Manager submitted a report from the Director Finance which reviews the services that will be provided and the costs for the S.P.C.A. to act as the Corporation's poundkeeper in 1984. Services are unchanged from the 1983 level; costs are essentially at the 1983 level - increased by 3.1%. Further, the Director Finance advised that the contract with the S.P.C.A. in which they were appointed poundkeeper for the Corporation, expired 1983 December 31. At the Council Meeting of 1983 December 12 Council resolved that the S.P.C.A. continue to provide the services of a poundkeeper on a month to month basis until 1984 February 29 under the terms and conditions of the 1983 contract provided, however, that the rate to be negotiated for services to be performed in 1984 shall be retroactive to 1984 Janaury 01. This action was taken to allow the society to finalize a working agreement with their employees. The S.P.C.A. has complied with the Corporation's objective to provide 1984 services at not more than 5% over the 1983 costs. At the same time, there will be no reduction of service.

The Municipal Manager recommended:

(1) THAT the contract with the S.P.C.A. be renewed for the period 1984 January 01 to 1984 December 31 at a basic cost of \$202,659, plus evening patrols for the months of May to August at a cost of \$6,095, plus park patrols during the months of May to August at a cost of \$8,376, plus 25% commission on the total licence fees collected by them.

The Municipal Manager submitted a report from the Municipal Solicitor advising that in 1982 and 1983, as authorized by Council, 41 lots have been sold by public tender in the subject subdivision. The last tender was called in November of 1983. As a result of the advertisement five lots were sold, leaving 13 lots to be sold in this phase of the subdivision. It is the opinion of the Municipal Solicitor that the minimum bid for each of these lots remain at \$79,500.00 as previously advertised. These lots will be advertised in the Sun and Province newspapers for two consecutive weekends. For those successful bidders who wish to purchase by Agreement for Sale the interest rate will be set the first day the advertisement appears in the newspapers.

# The Municipal Manager recommended:

(1) THAT the subject municipally owned lots be offered for sale by public tender. The conditions of sale to be as outlined in this report.

11. Burnaby Commercial Vehicle Licencing Bylaw No. 4418

The Municipal Manager submitted a report from the Chief Licence Inspector advising that the use of plates for the licensing of vehicles used for business purposes is to be supplemented by the use of decal tabs on a four year cycle; new plates will be issued in the fifth year. This will reduce the annual cost of supplies. An amendment to Bylaw No. 4418 is required to provide for the use of the decals. At the same time, some minor "housekeeping" items are proposed. The minor "housekeeping" items proposed constitute updating bylaw reference to division and section number of the Municipal Act to current numbering, and to express gross vehicle weights in metric terms.

The Municipal Manager recommended:

(1) THAT an amending bylaw to provide for the issuance of decal tabs for the annual renewal of Municipal vehicle licence plates be brought down.

12. Urban Transportation Assistance Program Grants to North Road Grade Separation and BNR Kensington Projects

The Municipal Manager submitted a report from the Director Engineering advising that Council, in 1983 August, was advised that approval had been given to transfer \$170,085.00 of surplus of U.T.A.P. funds from the North Road Grade Separation project to the B.N.R. Kensington project. Another application was made about a month ago to transfer a further \$80,000.00 from North Road to B.N.R. Kensington, which was made possible by favourable cost experiences on the North Road project and by delays caused by the B.C. Hydro strike which of necessity moves some work beyond the final U.T.A.P. deadline of 1984 May 31. Because both projects are underway at the same time, this allows the transfer to take place. The Director Engineering has now received formal ratification of this further transfer including a new agreement amending former U.T.A.P. Project Contribution Agreements; the amending agreement requires the signatures of the Mayor and the Municipal Clerk.

The Municipal Manager recommended:

(1) THAT the Mayor and Municipal Clerk be authorized to execute the amending U.T.A.P. Agreement No. 2, which amends previous Agreements for the North Road Grade Separation and B.N.R. Kensington Projects, as more particularly detailed in this report.

NEW BUSINESS

## Alderman Lawson

Alderman Lawson advised that she wished to bring back for reconsideration the item of correspondence dated 1984 January 30, which was received by Council at the regular Council Meeting on 1984 February 06, from Mayor Harcourt, Mayor of the City of Vancouver requesting that Council approve two motions that were adopted by delegates attending a public lobby on 1984 January 27 regarding the request for the restoration of the VIA Rail Western Transcontinental Passenger Service.

# MOVED BY ALDERMAN LAWSON: SECONDED BY ALDERMAN DRUMMOND:

"THAT Council approve the request of Mayor Michael Harcourt of the City of Vancouver in approving of the motions which were before the Edmonton meeting of the VIA Rail Lobby Organizational Meeting which was held on 1984 January 27 and which read as follows:

1. THAT WHEREAS exhaustive analysis by the Canadian Transport Commission conclusively demonstrated the passenger rail service between Winnipeg and Vancouver over the southern CP line and northern CN line is required to adequately serve the travel needs of western Canadians;

AND WHEREAS the Federal Government's termination of the Super Continental service has had a serious detrimental effect on travel and tourism throughout the west;

AND WHEREAS the intercity trains which have replaced the Super Continental have proven to be inadequate;

AND WHEREAS Transport Minister, Lloyd Axworthy's recent announcement on the restoration of a Winnipeg/Edmonton through service is a welcome step, but major communities location on the CN line are still deprived of direct service to Vancouver;

THEREFORE BE IT RESOLVED THAT the Federal Government reinstate the entire Vancouver-Jasper-Edmonton-Saskatoon-Winnipeg Super Continental rail service, with connection onward to Central Canada."

# CARRIED OPPOSED:

POSED: MAYOR LEWARNE, ALDERMEN EMMOTT, NIKOLAI AND STUSIAK

## MOVED BY ALDERMAN LAWSON: SECONDED BY ALDERMAN DRUMMOND:

"THAT Council approve resolution No. 2 which reads as follows:

2. THAT WHEREAS VIA's transcontinental trains' rolling stock dates back to the mid 1950's and is now extremely cost inefficient, unreliable and therefore, unable to meet the demands placed on it by the travelling public;

AND WHEREAS VIA is preparing to undertake a \$29 million research program to develop a transcontinental prototype to be ready for 1986;

AND WHEREAS general recent Canandian studies have demonstrated that readily available bi-level equipment, similar to what Amtrak now oeprates, could reduce VIA's operating costs in the 30% to 50% range, with a six year pay back period for the capital investment;

THEREFORE BE IT RESOLVED THAT the Federal Government modernize VIA Rails' equipment and facilities for their Western Transcontinental services."

# ENQUIRIES

## Alderman Stusiak:

Alderman Stusiak requested that members of Council choose a date, within the next 30 days, whereon a tour of completed R9 zoning categories could be conducted.

The Meeting agreed to hold a bus tour of completed R9 zoning categories on Saturday, 1984 March 17 commencing at 09:00 h.

## Alderman Drummond:

Alderman Drummond advised that a considerable number of complaints were received last summer (1983) regarding dog owners who were issued citations in Municipal parks. Alderman Drummond suggested that an article appear in Information Burnaby in which would be stated the hours of patrol during the summer months when the Burnaby Dog Tax and Pound and Animal Regulation Bylaw would be enforced.

# Alderman Lawson:

Alderman Lawson advised that she was in receipt of a memorandum from the Director Engineering regarding 30 km/h speed zones in the Municipality. This information is to be placed before the Traffic Safety Committee for their consideration. Alderman Lawson requested that a copy be distributed to each member of Council for their information.

Alderman Lawson advised that she was in receipt of a letter and had received a number of telephone complaints, with respect to the noise emanating from the Goodwin Johnson Ltd. site in North Burnaby. Alderman Lawson further stated that she would like to see a report come before Council that would address the noise emanating from this site.

The Municipal Manager advised that staff are aware of this problem and will be forwarding a report to Council upon completion of their investigation.

Alderman Lawson advised that she has received a complaint from a resident living north of Canada Way who must cross Canada Way at Rayside Avenue. The complainant stated that considerable difficulty is experienced while crossing Canada Way at this location at any time of the day or night.

His Worship, Mayor Lewarne advised that this matter has been before Council in the past on a number of occasions and that Council is well aware of the problems of crossing Canada Way at this location.

Alderman Lawson requested that the R.C.M.P. be directed to place a radar surveillance unit at this location.

Alderman Lawson further advised that she has received a complaint from a lady who has a handicapped mother who desires to go out on occaision on the weekend and that Handi-Dart service does not operate on the weekends. Alderman Lawson stated that the lady was able to call a cab company in Vancouver to pick her mother up on the weekends and in two instances was delivered to New Westminster and Richmond, however, when the cab company was called to pick her up at these locations she was advised that they were unable to do so.

Alderman Lawson queried that if there are private cabs available to the handicapped how could Council assist in seeing that this service is available for handicapped residents of Burnaby to travel in and out of the Municipality.

The Municipal Manager advised that he would have staff investigate this matter.

## Alderman Drummond:

Alderman Drummond requested that the report which is to be brought forward with respect to noise levels at the Goodwin Johnson Ltd. site, include the intentions of Goodwin Johnson Ltd. with respect to reducing the level of noise emanating from their site.

MOVED BY ALDERMAN STUSIAK: SECONDED BY ALDERMAN McLEAN:

"THAT this regular Council Meeting do now adjourn."
