Mr. Smith first reviewed the activities of the Club and history of its programs and community involvement. Mr. Smith advised of his Club's opposition to the proposals by the Planning and Building Inspection Department as contained in Item 8, Municipal Manager's Report No. 64, 1984 October 15 to be considered by Council later this evening. The delegation noted that Bonsor Park, with its central location, will continue to be a major youth and adult centre and demands for its facilities would increase with the development of Metrotown. Concern was expressed regarding the proximity of the proposed Central Boulevard alignment and it was noted that sixty seven percent of the park users reside south of Bonsor Park and would therefore have to cross Central Boulevard.

Mr. Smith then read a portion of a 1966 letter from the Burnaby Parks and Recreation Commission to the South Burnaby Men's Club in which the Commission advised of its awareness of the lack of space and the need to enlarge the park in view of the expanding population growth in the area. In addition, Mr. Smith noted the Club's specific opposition to Items 1, 2, 3, 4, 5, 7, 8 and 9 of Appendix B of Item 8, Municipal Manager's Report No. 64, 1984 October 15 and details of the Club's opposition were reviewed point by point.

The delegation advised of the Club's willingness to work with the municipality to find alternatives to the traffic problems and suggested there be some means of replacing the loss of parkland or to negate the effects of the roadway alignment.

Mr. Smith then submitted a petition consisting of over 2,000 names, to be held in trust by the municipality, the text of which is contained hereunder:

The Planners for the Corporation of the District of Burnaby have recommended to the Council and received first reading approval that an extension of Beresford Street be made through Bonsor Park. The purpose of the extension is to allow a four lane access road from Imperial Street near Nelson to the Metrotown development. There are many negative aspects of this proposal.

1. Parkland will be used to allow access to a commercial venture.
2. Numerous large evergreen trees will have to be cut down.
3. The safety of children and adults will be greatly hampered through the closeness of a high volume road near the park.
4. Air and noise pollution in the park will be higher as a result of high traffic volume.
5. Parking spots eliminated by the road extension will only be regained through elimination of more parkland in favor of the parking lots. This is presently a good baseball field for the Bronco Division as well as a good field for younger soccer teams.
6. Easy access to the adjoining Maywood School yard will be virtually eliminated as will the easy use of these grounds for related sports activities.
7. Crowding of fields, tennis courts and pool will result in a less desirable, less aesthetic park.
8. Playing fields will have to be relocated unnecessarily at great expense (approximately \$210,000).

It is our opinion that under no circumstance should we give up Parkland in Burnaby and especially to the proposed Beresford Street extension which is unnecessary as alternate access routes are already available through existing roads.

We strongly recommend the Council reject any motion to eliminate Parkland at Bonsor Park.

8. Central Boulevard Alignment
Across Southern Frontage of Bonsor Park

The Municipal Manager submitted a report from the Director Planning and Building Inspection with respect to the proposed alignment of Central Boulevard across the southern frontage of Bonsor Park. The report provides discussion of the various alignment options and concludes that, in this particular instance, the need to have an effective transportation system takes priority in this rare case where parkland is affected. The reports suggests it is imperative that Central Boulevard be a strong, direct easily recognizable linkage serving the Metrotown ALRT station, the proposed focusing of the bus transit system on the ALRT, and major commercial redevelopment proposed for the Metrotown core. It was also noted that since Central Boulevard was proposed to take traffic pressures from the Metrotown stretch of Kingsway, a Provincial highway, the desirability of the optimum alignment would be significant in securing Provincial cost sharing.

The Municipal Manager recommended:

4. Taxation of School Board Property

The Municipal Manager submitted a report from the Director Finance regarding taxation of School Board property, more specifically as this relates to use by volunteer organizations of vacant space in closed school premises. The report advised that under existing legislation, the municipality was obliged to levy property taxes, although the majority of tenants might not be able to pay them. The report discussed tax exemption bylaws passed annually by Council to exempt from taxation a variety of community organizations, including churches. Owing to inconsistencies in the Municipal Act, it was not possible at present to grant tax exemption under Section 400 of the Municipal Act.

The report further advised that staff had been in contact with the Ministry of Municipal Affairs with respect to this matter and the School Board had communicated its concerns to the Provincial Government Ministries involved and to the three Burnaby MLAs. Attached to the report from the Director Finance was a copy letter sent by the Secretary-Treasurer of the School Board, informing affected tenants of the current situation. Staff endorsed the Secretary-Treasurer's advice that lessees direct their concerns to the Minister of Finance and/or Minister of Municipal Affairs.

NEW BUSINESS

Mayor Lewarne:

His Worship, Mayor Lewarne, then reported orally to Council regarding the opening of "Gateway Park" (located at Gilley and Rumble in Burnaby) on Friday, 1984 October 12 by the Minister responsible for Transit, Honourable Grace McCarthy. The demonstration park project, constructed within the ALRT right-of-way, was designed to illustrate the concept of a proposed linear park system along much of the ALRT right-of-way between Vancouver and New Westminster. It was hoped that the linear parks would be funded by way of private sector donations and, at no cost to the taxpayer, would provide such recreational facilities as hiking and jogging trails and bicycle paths.

ENQUIRIES

Alderman Rankin:

Alderman Rankin enquired as to the status of Council's request to the Vancouver Transit Commission with respect to the transit boundary issue in Burnaby.

In response, His Worship, Mayor Lewarne, advised that Alderman Stusiak, on behalf of Council, made a strong submission to the Commission on Friday, 1984 October 12 urging a more equitable fare zone structure. His Worship further advised that the Transit Commission had referred this matter back to its staff for discussion with staff of the municipality and subsequent report to the next regular meeting of the Commission.

Alderman Rankin enquired as to the present status of the Kask Bros. property rezoning application.

In response, His Worship, Mayor Lewarne, advised that the application was proceeding in a normal manner and would come forward to Council in due course.

Alderman Lawson:

Alderman Lawson enquired with respect to water quality monitoring by the Greater Vancouver Regional District in view of recent publicity surrounding the deaths of nine grey whales in Boundary Bay. Recent press reports had indicated a possible link between the deaths and discharge of toxic effluent into the Serpentine River in south Surrey which is part of the Greater Vancouver Sewerage and Drainage District area.

His Worship, Mayor Lewarne, then directed staff to contact the Pollution Control division of the G.V.R.D. and requested that particulars of water quality monitoring be provided to Alderman Lawson.
