3. Class "D" Neighbourhood Public House Application
1405 Greystone Drive
Neighbourhood Public House Application #1/84
Rezoning Reference #58/82A

The Municipal Manager submitted a report from the Director Planning and Building Inspection advising that the municipality is in receipt of a formal application to establish a Class "D" Neighbourhood Public House within the Greystone Shopping Centre located at 1405 Greystone Drive which is in the final stages of construction. Preclearance for the proposed pub has been issued by the Liquor Control & Licensing Branch. It is necessary to have the requisite survey conducted amongst all the eligible voting residents living within a 1/2 mile radius of the proposed neighbourhood pub site. The results of the survey will be submitted to Council for consideration prior to a resolution being made on the neighbourhood public application.

4. Hastings Street Parking
Boundary Road to Delta Avenue

The Municipal Manager submitted a report from the Director Engineering advising that the procedure approved by the Minister of Transportation and Highways for increasing the vehicular carrying capacity on Hastings Street from Boundary Road to Delta Avenue was by the use of painted left turn channelization at designated intersections and the prohibitions of left turns during the A.M. and P.M. peak periods at the remaining intersections. This work is progressing to the point where the sign davits are now in place. During the next week or two the existing bus stop zones located at those intersections where left turn channelization is to be introduced will be relocated and the curb space adjacent the left turn channelization will be posted for "No Stopping Anytime". Upon completion of this signing the Ministry of Transportation and Highways will then paint the designated left turn channelization.

The Ministry of Transportation and Highways have also advised that they have received the necessary equipment to now program the existing traffic signal controllers to a progression mode.

The Municipal Manager submitted a report from the Officer-In-Charge, Burnaby Detachment, Royal Canadian Mounted Police written in response to a letter received from Mr. John E. Beltz, received by Council at the regular Council Meeting held on 1984 March 26 regarding the Society for Soundscape Awareness and Protection and concerning the disturbance of peace and quiet unnecessarily by the noisy operation of motor vehicles particularly at night.

E N Q U I R I E S

Alderman Drummond:

Alderman Drummond advised that he had been contacted this past weekend by a long time resident of the Stride Avenue pit area enquiring as to whether the municipality was burning materials in the Stride Avenue pit during the past weekend. Alderman Drummond enquired as to whether the municipality was in fact burning some material in the Stride Avenue pit during the weekend.

In response to Alderman Drummond's enquiry the Director Engineering, Mr. E.E. Olson, advised that the municipality was using both the smokeless pit burner and open burning to dispose of landscape and garden type refuse brought in by residents of the municipality and large tree stumps and branches that were stockpiled by the municipality at the Stride Avenue pit until they could be disposed of.

Alderman Drummond also received a number of complaints regarding outdoor burning that was permitted this past weekend. Alderman Drummond felt that it would be appropriate for Council to review the existing policy regarding outdoor burning.

Acting Mayor Brown advised that he had been contacted by the Elders of the United Church on Sperling Avenue regarding the effect that the existing traffic barricade has upon vehicles turning off of Canada Way onto Sperling Avenue and wishing to enter the church parking lot. At the present time this cannot be done and those vehicles travelling along Canada Way must travel up to Burris Street and down Buckingham Avenue in order to enter the church parking lot. Acting Mayor Brown enquired as to whether the barricade could be moved so as to permit members of the church who are driving in an easterly direction on Canada Way to turn right onto Sperling and then enter the church parking lot off Sperling Avenue.

In response to Acting Mayor Brown's enquiry the Assistant Director - Current Planning, Mr. D.G. Stenson, advised that the traffic patterns in the area has been the subject of a previous report and in that report the location of the subject barricade had been changed. Mr. Stenson advised that a further report will be forthcoming in approximately one month's time which will provide further details regarding the traffic patterns in the Deer Lake area.


