(a) Mr. Robert Ritchie, 1069 15th Street, West Vancouver, B.C. then addressed the members of Council on behalf of the British Columbia Provincial Council of Carpenters. The following is the text of Mr. Ritchie's presentation:

"I appreciate this opportunity to speak to you this evening on what is indeed a life or death issue. I am appealing on behalf of the B.C. Provincial Council of Carpenters, representing 50 and one half thousand members in this province. Our Council is affiliated to the 'End the Arms Race' who are endorsed by over a 180 organizations. On April the 10th of this year I wrote a letter to the Municipal Clerk, and if I may I would like to quote from same...'At our 1983 Convention many resolutions were passed opposing the arms race and the proliferation of nuclear weapons. One of these resolutions read as follows:

That the B.C. Provincial Council of Carpenters reiterate its commitment to peace and complete nuclear disarmament by all nations.'

Checking our convention records I find that we have passed resolutions on disarmament and the testing of nuclear weapons since 1970 and that year the issue was the testing of a nuclear bomb on Anchitka Island. We are happy that this Council has endorsed this year's Walk for Peace but would ask this Council to go a step further; we would extend an invitation to His Worship and all Council members to participate in the march behind a municipal banner and, to cap it off, to declare Burnaby a nuclear free zone.

Your Worship and Council members, time is running out. Alone the social cost is enormous and the arms race consumes an ever increasing slice of all countries' budgets irrespective of their social and political systems. All kinds of statistics can be quoted but I would like to end with one from the United Nations...'The money required to provide food, water, education, health and housing for everyone in the world has been estimated at \$17 million per year, about as much as the world spends on arms every two weeks.' Thank you very much."

On Friday, 1983 April 14, temporary borrowing amounted to \$2,255,894.00. This exceeded the \$2,000,000.00 authorized under "Burnaby Temporary Borrowing Bylaw No. 2, 1983" by the \$255,894.00. On Monday, 1983 October 17 temporary borrowing was reduced to nil.

Item 06, Municipal Manager's Report No. 31, 1984 April 24 was brought forward for consideration at this time.

6. Letter from Touche Ross & Co., 700 - 1177 West Hastings Street, Vancouver, B.C., V6E 2L2 Overdraft

The Municipal Manager submitted a report from the Director Finance written in response to the item of correspondence appearing on tonight's Council agenda from Touche Ross & Co., the municipality's auditors. The Director Finance reported that the municipality exceeded the overdraft authority because of a payment to the Burnaby School Board of \$2,046,115.00 made on 1983 October 14. This was the monthly instalment of residential school taxes which, in accordance with the Education (Interim) Finance Act, must be paid on our about the 15th day of each month. The municipality had projected this payment to be made on Monday, 1983 October 17, the 15th being a Saturday, with investments maturing on that date to cover the payment. The School Board was expecting the cheque on 1983 October 14, and because we had taken advantage of the extra days on past payments, we felt obliged to release the cheque. The overdraft was not covered by calling in investments because it would have cost more than paying the overdraft charges.

The Burnaby Health Department, Environmental Health Division staff are continuing to liaise with the Greater Vancouver Regional District on ambient air quality within this municipality and are reviewing applications for air emission permits for individual levels of contaminants and those which could contribute to measurements of ozone in the ambient air.

7. B.C. Transit Request for Aerial Right-of-Way Central Park - Patterson Street Station

The Municipal Manager submitted a report from the Director Recreation and Cultural Services advising that at its meeting of April 18, the Parks and Recreation Commission received a report recommending that an aerial right-of-way be granted to B.C. Transit in perpetuity for approximately 93.4 square feet in Central Park to accommodate the Patterson A.L.R.T. station.

The construction of the A.L.R.T Patterson station requires B.C. Transit to obtain permanent aerial right-of-way for that portion of the station which overhangs Central Park.

The Municipal Manager recommended:

(1) THAT Council consent to the Ministry of Lands, Parks and Housing granting an aerial right-of-way, in perpetuity, to B.C. Transit for approximately 93.4 square feet in Central Park to accommodate the Patterson Street A.L.R.T. station.

MOVED BY ALDERMAN NIKOLAI: SECONDED BY ALDERMAN BROWN:

"THAT the recommendation of the Municipal Manager be adopted."

8. 1984-1988 Capital Budget

The Municipal Manager submitted a report from the Director Finance presenting the 1984-1988 Capital Budget.

The overall five year program reflects the integrated longer term plan of capital works for the municipality. A good degree of accuracy is built into the 1984 program, and it is based on the 1984 Provisional Capital Budget which was adopted by Council on 1984 December 12. The program for 1985 through 1988 is, except for those projects which are well defined, a planning document and subject to continuous review.

The 1984-1988 Capital Budget was distributed to Council under separate cover.

The Municipal Manager recommended:

(1) THAT the 1984-1988 Capital Budget be received, approved and the necessary budget bylaw be brought forward.

9. 1984 Annual Operating Budget

The Municipal Manager submitted a report from the Director Finance presenting the 1984 Annual Operating Budget for Council's consideration.

On 1983 December 12, Council adopted the 1984 Provisional Operating Budget which called for a tax levy of \$46,769,598.00. At that time there were a number of unknowns that could affect the levy. Since that time many of the unknowns have been resolved and are reflected in this budget. The 1984 Annual Operating Budget calls for a Municipal Tax of \$46,989,312.00 and a median home municipal purpose tax increase of 2.77 percent.

The 1984 Annual Operating Budget was distributed to Council under separate cover.

The Municipal Manager recommended:

- (1) THAT the 1984 Annual Operating Budget, with a Municipal tax levy of \$46,989,312.00 be received and approved and that the authorization bylaw be brought forward for three readings on 1984 April 30; and
- (2) THAT a property tax rating bylaw based on the variable tax rates shown in the 1984 Annual Operating Budget be brought forward for three readings on 1984 April 30.

MOVED BY ALDERMAN STUSIAK: SECONDED BY ALDERMAN McLEAN:

10. 1984 Assessment Rolls and Variable Tax Rate Selection

The Municipal Manager submitted a report from the Director Finance advising that with the introduction of the variable tax rate system for municipal purposes in 1983, Council must decide each year what percentage of the tax levy each class of assessment will bear. This report presents the authenticated assessment roll for 1984, discusses the various alternatives and relationships between the different classes of assessment and variable tax rates, and makes a recommendation as to the variable tax rate for each class of assessment for 1984. The report also summarizes the proposed changes to the tax rate system for other rate setting bodies for 1984.

The Municipal Manager recommended:

(1) THAT the variable tax rate by class for 1984 be kept in the same relationship by class relative to residential as for 1983.

As part of the review, staff from the Engineering, Health and Fire Departments met to discuss the Outdoor Burning Policy.

The Municipal Manager recommended:

(1) THAT a copy of this report be sent to all persons who have made their views known on this matter, including the City of New Westminster.

12. Renegotiation of Lease Rate Lower Mainland St. Leonard's Society Lots 11-12, Block 56, D.L. 98, Group 1, Plan 2066, N.W.D. 5023 Victory Street

The Municipal Manager submitted a report from the Municipal Solicitor advising that on 1969 April 01 the municipality leased two vacant lots at 5023 Victory Street to the Action Line Children's Village Society for a period of 60 years at an annual rental of \$1.00. Provision was made for the lease rate to be renegotiated after an initial period of ten years and every subsequent five years thereafter.

On 1976 November 08, the lease was transferred, with the consent of Council, from the Action Line Children's Village Society to the Lower Mainland St. Leonard's Society.

The lease was due for renegotiation on 1984 April 01 and the municipality has now received an application for the renewal of the lease for a further period of five years at \$1.00 per annum.

The Municipal Manager recommended:

(1) THAT the lease rate be set for a further period of five years as set out in the report.

13. Tenders for Contract #8406 Asphaltic Concrete Supply F.O.B. Plant

The terms of this contract shall be in effect from 1984 May 01 to 1985 April 30, both dates inclusive.

The Municipal Manager recommended:

(1) THAT the lowest tender submitted by Winvan Paving Limited in the amount of \$159,118.62 be accepted with final payment to be based on unit prices tendered and actual quantities used.

The Municipal Manager recommended:

(1) THAT the lowest tender submitted by Kask Bros. Ready Mix Limited for the sum of \$102,317.10 be accepted with the final payment to be based on the actual quantities received and the unit prices tendered.

15. Contract #8408 - Gravel Supply

The Municipal Manager recommended:

(1) THAT the lowest tender submitted by Jack Cewe Limited in the amount of \$202,449.00 be accepted with final payment to be based on unit prices tendered and actual quantities used.

Additional material respecting this matter was distributed to Council under separate cover.

The Municipal Manager recommended:

(1) THAT the Strategic Plan for Information Management as prepared by Mr. Robert Liley receive general approval; and

- (2) THAT an Information Services function with staffing as outlined in the Strategic Plan for Information Management and reporting to the Director Administrative and Community Services be established, with this function being responsible for all information management activities within the Corporation; and
- (3) THAT the Engineering and Finance computing equipment be consolidated under this Information Services function; and
- (4) THAT a Request for Proposal be issued in accordance with the Strategic Plan for Information Management to selected computer vendors for computer equipment to replace the existing Finance computer equipment; and
- (5) THAT the existing Engineering computer be upgraded from a DEC PDP 11/70 computer to a DEC VAX 11/750 computer along with an upgrade in the Synercom mapping software; and
- (6) THAT a Human Resources Management system for Payroll and Personnel and a General Accounting/Budgetting/Accounts Payable packaged system be selected and implemented; and
- (7) THAT Mr. Robert Liley, Robert Liley & Associates be engaged to assist as outlined in this report; and
- (8) THAT the Strategic Plan for Information Management be reviewed annually and its requirements included in the annual budgetting process.
- (9) THAT a Tax Sales Monies Bylaw be brought down to appropriate \$2,500,000.00 for the purchase of computer equipment.
