(a) Mr. Sean C. Farrell, #1 - 7321 Montecito Drive, then addressed the members of Council on behalf of the Parent Advisory Committee of Montecito School. Mr. Farrell advised Council of the concerns that the Parent Advisory Committee has with respect to the recommendations of the Traffic Safety Committee. These recommendations resulted from an appearance before the Traffic Safety Committee on 1984 January 17 whereat the Parent Advisory Committee of Montecito School requested that specific actions be taken to create a safer environment on the streets surrounding Montecito School. The speaker advised that a number of programs have been instituted at Montecito School in order to educate both the students and the parents in proper safety procedures. The Royal Canadian Mounted Police have also done an excellent job in teaching the school patrols about safety. However, there are two components which remain outside the parent's domain. Increasing traffic volumes and the speed with which traffic proceeds along the streets adjacent to the school are beyond the control of the Parent Advisory Committee and require the assistance of Council.

Mr. Farrell requested that Council reject recommendation No. 1, which was to deny the installation of a 30 km/h speed zone on Duthie Avenue, and approve the installation of such a speed zone. With respect to recommendation No. 2 Mr. Farrell urged Council to adopt the recommendation as presented by the Traffic Safety Committee. Concerning recommendation No. 3 Mr. Farrell urged Council to change 'painted crosswalk' to 'painted crosswalk with asphalt markings'. In addition, Mr. Farrell advised that Montecito School would like to be considered as the pilot for the silhouette sign program if such a program is to be instituted in Burnaby.

Mr. Gurney stated that the comments of the Engineering Department in its report dated 1984 January 04 and the subsequent recommendations of the Traffic Safety Committee do not answer the concerns of the Marlborough Elementary School Parent Advisory Committee relating to traffic volume and vehicular speed.

Mr. Gurney requested that Council approve the Traffic Safety Committee's recommendation No. 1 which was to relocate the existing marked crosswalk on Royal Oak Avenue at Arrow Street to Royal Oak Avenue at Sanders Street, north leg. Mr. Gurney further requested the installation of a pedestrian actuated traffic signal at the relocated crosswalk at Royal Oak Avenue and Sanders Street. With respect to recommendation No. 3 of the Traffic Safety Committee report Mr. Gurney requested that Council reverse the decision of the Traffic Safety Committee to not install a 30 km/h speed zone on Royal Oak Avenue in the vicinity of Marlborough School. Mr. Gurney felt that the installation of a 30 km/h speed zone is required. Concerning recommendation No. 4 the Parent Advisory Committee is in concurrence with the Traffic Safety Committee regarding the monitoring of speeds on Royal Oak Avenue, particularly during school hours, by the Royal Canadian Mounted Police. In connection with recommendation No. 5 Mr. Gurney advised that the School Parent Advisory Committee did not ask for a fully actuated traffic signal to be installed on Royal Oak Avenue at Dover Street and requested that this matter be referred back to the Director Engineering for further study.

# School Crosswalk on Royal Oak Avenue at Arrow Street for Marlborough School

The Traffic Safety Committee submitted a report advising that at its meeting held on 1983 October 25 the Committee heard a delegation from Mr. J.G. Gurney, Marlborough Parent Advisory Committee, advising of the Committee's concerns regarding a serious safety problem associated with the school crosswalk on Royal Oak Avenue adjacent to Marlborough Elementary School. Arising out of Mr. Gurney's presentation, Traffic Safety Committee members requested staff to provide additional information respecting this matter.

The Traffic Safety Committee recommended:

- (1) THAT the existing marked crosswalk on Royal Oak Avenue at Arrow Street be relocated to Royal Oak Avenue at Sanders Street, north leg.
- (2) THAT all pavement markings and signing associated with the above crosswalk be installed at the new location.
- (3) THAT the requests for a pedestrian operated traffic signal and a 30 km/h speed limit be denied.
- (4) THAT the R.C.M.P. be requested to monitor the speeds on Royal Oak Avenue, particularly during school hours, and to issue violation notices where required.
- (5) THAT a fully actuated traffic signal be installed on Royal Oak Avenue at Dover Street.
- (6) THAT Mr. J.H. Gurney, c/o Marlborough Parent Advisory Committee, 6269 Denbigh Avenue, Burnaby, B.C., V5H 3R6 be sent a copy of this report.
