Plan 1312, N.W.D.
To the Action Line Housing Society

The Municipal Manager submitted a report from the Municipal Solicitor regarding the lease of 5706 Irmin Street to the Action Line Housing Society. The report advised that the lease to the non profit social housing society was now renewable on a five yearly basis and the lease rate remained at \$1 per annum up to 1983 November 01.

Review of the rental structure of the project revealed that rents were only \$230 per month whereas market value of the units would be closer to \$600 per month. Furthermore, some units contained families no longer in need of financial assistance and, although attempts had been made by Action Line Housing to request their tenants to move, it was not the policy of C.M.H.C. to evict tenants no longer in need of subsidized housing. The report then outlined negotiations with the Society to ensure that the project continues to be rented to people only on a low income and summarized actions taken by the municipality to restore the low rental objectives of the project. Further report would be forthcoming when the matter was resolved.

The Municipal Manager recommended:

The report advised of details of the plan proposing a major restructuring of transit groups throughout Burnaby in the forthcoming year. The Service Plan proposes implementation of the North Burnaby Area Plan in accordance with the transit focus concept of the municipality's Comprehensive Transportation Plan. It was noted that the 1985/86 Service Plan will also include the start of service of A.L.R.T. with consequent major reorganization of bus routes in South Burnaby to intergrate bus service with the system.

The report then provided further details regarding the North Burnaby Area Plan, A.L.R.T. and bus systems integration and municipal concerns with respect to implementation of commuter rail and further extension of A.L.R.T. to the Lougheed Mall. Staff concluded that the current draft of the 1985/86 Service Plan was largely responsive to and in accordance with municipal policies defined in the Comprehensive Transportation Plan. Further details of the A.L.R.T./bus integration in South Burnaby will be reported to Council at a later date along with any possible outstanding concerns. It was suggested that the major reorganization of routes throughout the municipality should result in an improved transit system for Burnaby residents.

The report advised that the Parks and Recreation Commission had defeated a recommendation to approve a design of Bonsor Park which would allow for extension of Central Boulevard along the southern boundary and requested Council to consider an alternate road system through Metrotown.

The Director Recreation and Cultural Services recommended:

(1) THAT Council consider an alternate road system for the extension of Central Boulevard through Metrotown, leaving Bonsor Park as it presently exists.

The Municipal Manager recommended:

(1) THAT the report of the Director Recreation and Cultural Services be tabled.
