(a) Mr. Arthur F. Jones, residing at 430 Mulgrave Place, West Vancouver, and speaking as the President and Chief Executive Officer of the Greater Vancouver Convention and Visitors Bureau, then addressed the members of Council regarding the grant application for the Greater Vancouver Convention and Visitors Bureau.

Mr. Jones advised Council that the requested grant was needed to assist in meeting the Bureau's mandate of marketing the total area as a destination for visitors and direct selling of the total area as a convention/conference destination. Prior to maps, guides and other information being disseminated to tourists, they must first be persuaded to come to the area. The speaker considered the tourism marketing process to be complex and competitive but one that the Bureau has been effective in for a number of years.

In conclusion, Mr. Jones requested Burnaby's financial support in order to assist the Greater Vancouver Convention and Visitors Bureau to meet their mandate of encouraging the overall tourism business into the area.

(b) Mr. David A.R. Wallace, residing at 7511 Imperial Street, Burnaby, and speaking as the President of the Burnaby Chamber of Commerce then addressed the members of Council with reference to the grant application from the Burnaby Chamber of Commerce for the Tourist Information Services Centre located on Sprott Street.

Mr. Wallace considered that a community the size of Burnaby should create an identity and have representation in the tourism industry. In addition to the people served at the Tourist Information Centre, the speaker advised that, during the previous year, telephone calls and mail enquiries totalling 5,373 had been handled.

In conclusion, Mr. Wallace advised that 1984 was the first full year of operation of the Tourist Information Services Centre and this involvement in the tourism industry has placed a heavy financial burden on the Burnaby Chamber of Commerce and therefore a request for financial assistance to meet these demands is submitted.

His Worship, Mayor Lewarne, then advised that the question before the meeting was the adoption of the motion as moved by Alderman Brown and seconded by Alderman Nikolai at the regular Council Meeting held on 1985 February 11, being;

"WHEREAS no apparent benefit to the Municipality is derived from the Greater Vancouver Convention and Visitors Bureau;

THEREFORE BE IT RESOLVED that the \$5,000.00 annual grant to the Greater Vancouver Convention and Visitors Bureau be terminated as of this year, 1985, and a letter be forwarded to this organization informing them of this action."

A vote was then taken on the motion as moved by Alderman Brown and seconded by Alderman Nikolai, being;

"WHEREAS no apparent benefit to the Municipality is derived from the Greater Vancouver Convention and Visitors Bureau;

THEREFORE BE IT RESOLVED that the \$5,000.00 annual grant to the Greater Vancouver Convention and Visitors Bureau be terminated as of this year, 1985, and a letter be forwarded to this organization informing them of this action,"

The grant to consist of the original \$20,000.00 allocated to the Greater Vancouver Convention and Visitors Bureau; the original \$500.00 allocated to the New Westminster Tourist Bureau; the original \$5,000.00 allocated to the Burnaby Chamber of Commerce, and a further \$14,500.00 not to be obtained from the Grants and Publicity Budget."

- (c) Reverend Frank Ward, residing at 314 North Delta Avenue, Burnaby, and appearing on behalf of the Burnaby Christian Peace Council then addressed the members of Council and requested Council's participation in the "Walk for Peace" on Saturday, 1985 April 27 and further that Burnaby make available a large banner representative of the municipality of Burnaby to be displayed at the Walk. Reverend Ward further requested financial assistance from Council to cover the cost of producing a promotional leaflet which would advertise the Peace Walk and thereby encourage the citizens of Burnaby to participate.
- (d) Ms. Gayle Gavin, residing at 3746 Cambridge Street, Burnaby, and appearing as the Chairperson of the Steering Committee of the Burnaby Peace Coalition then addressed the members of Council and expressed her appreciation for Council's past support on the issues of peace and bringing these issues to the attention of the citizens of Burnaby. The speaker recalled Council's endorsation of the Peace Walk for the past two years and therefore requested Council to demonstrate, as political leaders, further support so that the citizens may have confidence and survive as a human race and put a stop to the nuclear threat to human existence.

The speaker further requested the municipality to be very visible by providing a Burnaby Municipal banner stating that The Corporation of the District of Burnaby supports peace. Further to this, the speaker requested that Council have an official presence as well as a visual presence and walk with the Burnaby contingent in this year's March for Peace. In conclusion, Ms. Gavin requested financial support by covering the cost of the Burnaby Peace Coalition's production of a small handbill stating that Burnaby has a contingent and invites the citizens of Burnaby to walk with the Burnaby Peace Coalition for peace and the survival of mankind. The cost to produce such a handbill would be approximately \$600.00 and the cost to produce the Burnaby banner would be approximately \$200.00.

(e) Ms. Dian Dougan, appearing as the Chairperson of the Burnaby Peace Committee, 3724 Cambridge Street, Burnaby, then addressed the members of Council and read from the following prepared brief:

"The Burnaby Peace Committee was formed three and one half years ago by residents of Burnaby because we felt that we as individuals as well as people everywhere in small rural communities, in municipalities or in large cities must have a say in the continuing build up of nuclear military arsenals which threaten the existence of the entire world. It was our feeling then and it is our profound belief now that no group of people can or should sit idly by while this insane threat exists. The hopes and aspirations that we all have for ourselves, the hopes and dreams that we have for our sons and daughters demand that we collectively and individually do whatever it is that we can to stop this mad continuation of development and deployment of nuclear weapons.

The April Walk for Peace is one collective statement by thousands of people from the Lower Mainland in the hope that our government and governments everywhere will listen and reverse their position. Last year one hundred thousand people walked for peace. This year the 'End the Arms Race' Committee anticipates that two hundred thousand people will join in. Last year the Burnaby Peace Coalition of which the Burnaby Peace Committee is a part began the process of building a Burnaby contingent in the April walk. There were several hundred Burnaby residents who joined us at that time. This year it is our hope that hundreds more from Burnaby will participate behind our banners.

On behalf of the membership of the Burnaby Peace Committee I wish to thank you for your endorsation to build a bigger than ever Walk for Peace. Your endorsation is very important because by this you show your support and agreement to our objectives. But your participation and concrete assistance will also greatly our efforts to reach more residents of Burnaby to join the April Walk. We ask, as it has been suggested earlier, that you walk with us in your official capacity as the government of our community. We ask that you bring a Municipal banner and we ask for a small donation of \$600.00 to assist us in the printing of an advertising flyer which we will distribute to the residents of Burnaby. We thank you for your consideration and past assistance and for your hopefully continued support."

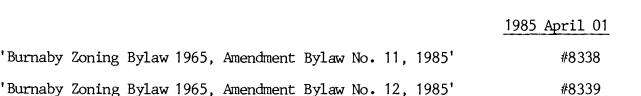

A letter dated 1985 March 16 was received whereby the writer advised that he was in receipt of information regarding housing for senior citizens from the Abbeyfield Society of Great Britian who attempt to provide small scale housing for seniors still able to look after themselves. The writer enquired if the Burnaby Zoning Bylaw would deal with this type of housing and if it allowed for these types of institutions or would a special zoning designation be necessary.

Item 13, Municipal Manager's Report No. 25, 1985 April 01 was brought forward for consideration at this time.

13. Letter from Mr. Rick Bennett, #45 - 7180 Pandora Street, Burnaby, B.C. V5A 1B7

The Municipal Manager submitted a report from the Director Planning and Building Inspection prepared in response to the letter received from Mr. Rick Bennett concerning the possibilities for the provision of small scale housing for senior citizens in the municipality under the regulations of the Burnaby Zoning Bylaw. The current Zoning Bylaw regulations offer a number of opportunities for the accommodation of senior citizens, however, the small scale family type housing approach would be most appropriately met by the provisions of the Residential District (R5). The Residential District (R5) is the most extensive of the Residential Districts in terms of numbers of units and area covered and would, therefore, provide considerable scope for the housing of elderly persons in single family dwellings in a neighbourhood environment that should blend in well with surrounding residences.

5. Sale of 8621 Armstrong Avenue (Closed Portion of Coquitlam Avenue) for the Consolidation with adjacent Church site
Road Closure Reference No. 5/76

The Municipal Manager submitted a report from the Director Planning and Building Inspection regarding the proposed sale of municipal property at 8621 Armstrong Avenue for the purpose of consolidating with the adjacent Burnaby Chineese Alliance Church site.

The Municipal Manager recommended:

The writer advised that detachment members carry out regular bar checks and if any violation is observed, a report is made to the Liquor Control Board Inspector with a copy to management of the North Burnaby Inn. Cooperation between police and management has greatly improved over what existed when there were serious concerns with former management at the North Burnaby Inn.

Applications from qualifying organizations will be included in the annual tax exemption report submitted for Council's consideration and such exemptions may be granted by resolution or bylaw and must be in place by August 31 each year to be in effect for the following year.

The Municipal Manager submitted a report from the Director Planning and Building Inspection providing details of a Preliminary Plan Approval application from Chevron Canada Ltd. for a proposed alkylation plant project at their Burnaby refinery site located at 5201 Penzance Drive. The unit is required in order for Chevron to comply with the proposed reduction in lead usage in gasoline blends and the proposed alkylation plant technology has been used by refineries for several years. The project has been reviewed by the Environmental Health Department and the Fire Department with favorable comments and as a result it is intended that the Preliminary Plan Approval and the necessary Building Permits be issued shortly for construction of the proposed alkylation plan in accordance with the prevailing zoning bylaw and other pertinent municipal regulations.

The Municipal Manager recommended:

The Municipal Manager submitted a report from the Director Engineering who advises that due to the considerable increase in disposal charges for the municipalities who are now using the transfer station at the old Coquitlam landfill site there is a large difference between disposal costs for Burnaby and municipalities such as Surrey and Delta. When comparing our service with other municipalities it should be noted that the residential portion of the service is used and that disposal costs are governed by different circumstances and cannot be compared.

The Municipal Manager recommended:

The Municipal Manager submitted a report from the Director Planning and Building Inspection requesting that a bylaw be prepared under Section 735 of the Municipal Act to authorize the removal of six outstanding illegal portable signs where the owners or occupants have failed to remove them following proper notice.

The Municipal Manager recommended:

(1) THAT a bylaw be prepared and presented to Council for the removal of illegal portable signs.
