The Municipal Manager submitted a report from the Director Engineering which was written in response to correspondence received from Mr. Frank Helden regarding specific complaints in connection with lighting on Boundary Road, Smithrite garbage truck pickup times and unfair parking restrictions. The report advises that it was hoped to proceed with a joint project with the City of Vancouver to upgrade the subject section of Boundary Road, including ornamental street lighting. In the event that cost sharing approval is not forthcoming from the Province in 1986, the municipality will attempt to improve lighting for the interim until approval is received.

The report further advises that the complaint regarding refuse collection by a private contractor could not be acted upon by staff as there was no violation of any bylaw in picking up refuse at 7:00 a.m. The report suggests that the correspondent pursue the matter directly with his apartment complex manager.

With respect to parking restrictions on the south side of the 4200 block Grange Street, the report advises that the present parking prohibition needs will be reviewed and as much additional on-street parking time as is practicable will be provided.

The Minister advised the F.C.M. of his regret that Statistics Canada is unable to meet all of the Federation's information requirements but suggests the proposal will be reviewed prior to the 1991 Census.

A letter dated 1985 November 06 was received from Mr. Brian W. Yates in which the writer complains of an unacceptable noise level generated by the Advanced Light Rapid Transit System (ALRT). The report provides details of a proposed sale of municipal lands for the establishment of a vegetable pressure cleaning, packing, cooling, storage and distribution facility to serve Burnaby's agricultural community. The report notes that although the lands are situated within the Agricultural Land Reserve, they have been industrially filled and cannot support soil-bound agriculture. It was suggested that the proposed use would enhance the viability of agriculture in the Big Bend area.


