 Subdivision Reference No. 18/83 and Road Closure Reference No. 11/84 - Pandora Street -Ridgeview Drive - Hastings Street Dedication of Municipal Land - Highway Exchange Bylaw - Land Exchange - Cost Sharing

The Municipal Manager submitted a report from the Approving Officer with respect to Subdivision Reference #18/83 in connection with proposed extension of the subdivision pattern in the Ridgeview Drive area. The report discusses dedication of municipal lands, a proposed Highway Exchange Bylaw, municipal and private land exchanges, cost sharing and funding sources. The report advised that the prospective subdivider had been successful in securing the consent of more than one half the owners in order to proceed with the first phase of the project.

The Municipal Manager recommended:

- (1) THAT dedication of municipal lands from a portion of the Burnaby Mountain Conservation Area and adjacent land be authorized to provide the extension of Ridgeview Drive, thus enabling further subdivision to occur to the south and west, as more particularly outlined in the report.
- (2) THAT a Highway Exchange Bylaw be introduced in order to implement closure of the portion of the Pandora Street road allowance in exchange for the necessary road and lane dedications within the subdivision.
- (3) THAT the Municipal Solicitor be authorized to negotiate a land exchange which will enable suitable development lots to be achieved, both by the municipality and the subdivider; any costs arising from such negotiations to be the subject of a further report.
- (4) THAT the Municipal share in the cost of road construction abutting the municipal lots and one half the walkway in an amount not to exceed \$118,100.00, based on approved design drawings and approved contract, with a further report to be submitted when the additional modest costs to remove overhead B.C. Hydro and B.C. Telephone poles on Pandora Street can be confirmed, as more particularly described in the report.
- (5) THAT authority be given to expend funds for the cost sharing under the Tax Sale and Corporate Land Reserve designated for land assembly and development programs.

4. Local Improvement Paving Program Schedule

The Municipal Manager submitted a report from the Director Engineering advising of the Local Improvement Paving Program schedule covering a two year period, 1985/86. Construction will be in three phases with phases I and II scheduled for 1985 and phase III scheduled for 1986 construction.

The Municipal Manager recommended:

(1) THAT the report be received for information purposes.

5. Burnaby Development Cost Charges Bylaw No. 7328

The Municipal Manager submitted a report from the Director Finance advising of the requirement under the Municipal Act for a bylaw to expend funds from the Development Cost Charges Reserve. The amount to be covered by the proposed bylaw totalled \$249,622.69 for expenditures made during the calendar year 1984.

The Municipal Manager recommended:

(1) THAT a bylaw be brought down to authorize the expenditures from the Development Cost Charges Reserve as listed in the report.

MOVED BY ALDERMAN BROWN: SECONDED BY ALDERMAN STUSIAK:

 Letter from Mr. Beazley Which Appeared on the Agenda for the 1985 February 18 Meeting of Council (Item No. 10) Removal of Illegal Sign, Westcoast Mobile Locksmiths Ltd.

The Municipal Manager submitted a report from the Director Engineering written in response to correspondence received from Westcoast Mobile Locksmiths Ltd. regarding removal of an illegal sign from the street outside the company's property. The report sets out procedures followed in removing illegal signs from public road allowances in the municipality and proposes establishment of a new section in the Burnaby Street and Traffic Bylaw to protect the municipality from claims of damage to remove signs. The authority to enact the proposed new section of the bylaw is provided under Section 120(1)(k) of the Motor Vehicle Act.

The Municipal Manager recommended:

- (1) THAT Council approve the above noted procedure for the removal of illegal signs from the streets of Burnaby.
- (2) THAT Council approve the proposed addition to the Burnaby Street and Traffic Bylaw clarifying our authority to remove illegal signs from the streets.

7. Burnaby Youth Services Report -1984 Annual Report

> The Municipal Manager submitted a report from the Officer-In-Charge, Burnaby Detachment, R.C.M.P., being the 1984 Annual Report from the Supervisor, Burnaby Youth Services. The report notes that Youth Services dealt with 275 youths and families in 1984. Statistics indicated that the program had been successful in preventing delinquent behaviour in first time offenders and staff was maintaining close contact with police administration and community agencies to determine the best ways to adapt to changing needs and demands.

The Municipal Manager recommended:

(1) THAT the unedited annual report be accepted for information purposes.

The Municipal Manager submitted a report from the Director Engineering with respect to Work Orders for storm sewer extensions in the amount of \$160,000.00 and servicing municipal property on Roseberry Avenue in the amount of \$265,000.00.

The Municipal Manager recommended:

9. Letter from Gillian Neumann which appeared on the Agenda for the 1985 March 11 Meeting of Council Ledger Avenue - Parking in 4200 Block

The Municipal Manager submitted a report from the Director Engineering written in response to a letter from Ms. Gillian Neumann with respect to parking restrictions on Ledger Avenue. The report advised that restrictions had been imposed as a result of complaints of driveway and visual obstructions in the area.

The Municipal Manager recommended:

(1) THAT Gillian Neumann, 3150 Bainbridge Avenue, Burnaby, B.C., V5A 2S8, receive a copy of the report.

MOVED BY ALDERMAN NIKOLAI: SECONDED BY ALDERMAN LAWSON:

10. Lease of 5706 Irmin Street (Lot "C", Block 32-33 District Lot 97, Group 1, Plan 1312, NWD) To the Action Line Housing Society

The Municipal Manager submitted a report from the Municipal Solicitor recommending authorization for execution of a new lease with the Action Line Housing Society for property located at 5706 Irmin Street. The new lease reflects Council policy to assist in the provision of social housing only for qualified tenants under C.M.H.C. income guidelines. Accordingly, the land lease would yield \$30,000.00 annually but would be reduced by one twentieth (1/20), or \$1,500.00 for each family qualified by reason of income.

The Municipal Manager recommended:

 THAT authority be given for the execution of a new lease with Action Line Housing Society as more specifically outlined in the report.

MOVED BY ALDERMAN EMMOTT: SECONDED BY ALDERMAN BROWN:

NEW BUSINESS

Mayor Lewarne

His Worship, Mayor Lewarne, reported briefly to Council on matters relating to recent transit fare increases and a meeting of Mayors in Victoria with respect to the Provincial Government's "Partners in Enterprise" program for Provincial/Municipal cooperation. His Worship advised that particulars of both items were available for perusal of members of Council in the Alderman's Lounge. A lengthy discussion then ensued regarding debt financing of the new ALRT system and its possible impact on the municipal taxpayers.

Alderman Drummond retired from the Council Chamber at 8:06 p.m.

Alderman Brown:

Alderman Brown reported orally on the meeting arranged by the management of "Coconuts" nightclub with surrounding residents following complaints to Council from residents of the 7200 Randolph Street. The club management had expressed a willingness to cooperate with the R.C.M.P. and Licence Inspection Department and minutes of the meeting with local residents would be provided to His Worship, Mayor Lewarne.

ENQUIRIES

Alderman Rankin

Alderman Rankin advised that he had received complaints from homeowners residing on Kraft Crescent and Kraft Place regarding the flushing of certain substances down Eagle Creek thus presenting a possible ecological threat to Burnaby Lake.

In response, His Worship, Mayor Lewarne, advised that one industrial pollution source had already been identified and urged that residents report any similar concerns to the Environmental Health Department through its emergency number for immediate response.

Alderman Stusiak

Alderman Stusiak, in his capacity as Council liaison member for Finance, requested income/expenditure control information at the earliest opportunity.

In response, the Municipal Manager advised that staff anticipated receiving property tax information with respect to the ALRT guideway within the next two weeks, thereby enabling staff to complete all necessary calculations. His Worship, Mayor Lewarne, also advised that he was attempting to meet with the Minister of Finance in this regard in order to expedite completion of property tax estimates.

MOVED BY ALDERMAN STUSIAK: SECONDED BY ALDERMAN McLEAN:

"THAT this regular Council Meeting do now adjourn."
