(a) Mr. Ken Thorpe then addressed the members of Council on behalf of TR Services Ltd., 7 West 7th Avenue, Vancouver. In his presentation Mr. Thorpe referred to a number of items contained within Item 7, Municipal Manager's Report No. 66, 1985 October 21 which was earlier tabled by Council and appears as a Tabled Matter on the agenda for this evening's Council Meeting. Mr. Thorpe clarified several issues concerned with TR Services' proposal to the municipality with special emphasis being placed upon the requirement to rewire the Municipal Hall. In concluding Mr. Thorpe advised that the stated figure of \$517,630 represents a complete, turn-key system for The Corporation of the District of Burnaby.

The information packet submitted to Council with its agenda package and the material distributed by the delegation prior to this evening's Council Meeting are on file in the Office of the Municipal Clerk.

(b) Mr. Wes Henderson, 1802 Nanaimo Street, New Westminster appeared on behalf of Rolm Canada Inc., to request that Council postpone its decision on the corporation's pending switchboard installation. The delegation suggested that a more detailed investigation of his company's product was required and further suggested that the corporation's consultant and the Selection Committee do not currently have the necessary technical or operational knowledge of the products to make a truly informed decision.

The delegation reviewed details of his company's products, noting the flexibility and reliability of the new digital telephone systems, particularly their ability to handle data through integration with computer systems. The delegation therefore requested that the corporation postpone its decision, to enable two seminar sessions to be held for the Selection Committee to evaluate Rolm's products and services.

A copy of the information material, distributed to the members of Council at this evening's Council Meeting, is on file in the office of the Municipal Clerk.

15. Supplement to the Municipal Telephone System Report

The report provides some additional information regarding proposal price quotations and further clarification of the partial quotation made by Rolm.

The report concludes with advice that bids have had an extensive review by the Corporation's technical consultant who recommends that the BTE bid is the lowest acceptable one in terms of all criteria, although it is technically not quite the lowest bid for the alternative recommended by staff.

7. Municipal Telephone System

The Acting Municipal Manager submitted a report from the Director Administrative and Community Services regarding installation of a new municipal telephone system.

The report advises that the current municipal telephone system is outdated and inefficient and that new functions, using electronic components and computer software, can improve office efficiency while the improved flexibility facilitates change as required to meet new demands. New equipment is available at a cost which is the same or lower than the existing system and the replacement should proceed as quickly as possible, with minimal disruption to the business of the Corporation.

The Acting Municipal Manager recommended:

- (1) THAT the proposal of Business Telecon Equipment be accepted to install telephone equipment to meet The Corporation's specification, subject to the successful negotiation of a contract and suitable financial arrangements as determined by the Corporation.
- (2) THAT a bylaw in the amount of \$650,000.00 be brought forward to fund the installation as outlined in the Funding Section.

(c) Mr. Robert Baker, 5387 Willingdon Avenue addressed the members of Council on behalf of Mr. James D. Ells of 5389 Willingdon Avenue regarding improved street lighting and crime prevention matters. The delegation had also submitted a petition, a copy of which is on file in the Municipal Clerk's office, from residents of the 52-5800 Blocks of Willingdon Avenue from Grange to Burke, including Samara and Saratoga Crescents, requesting that the corporation install 14 street lamps on existing power poles in the lane west of Willingdon Avenue and to increase the power of lighting on Willingdon Avenue to prevent further incidents of crime.

The delegation advised that because there is no vehicular access from Willingdon Avenue in the subject section, residents were obliged to use the back lane as a "street". The delegation then further advised of various incidents of fighting, break-ins of cars and homes and arson. The delegation also made reference to a murder victim whose body was found concealed in shrubbery in the front yard of 5387 Willingdon Avenue.

Accordingly, Council was requested to consider installing lighting on existing hydro poles in the lane and to improve the standard of street lighting on Willingdon Avenue.

(d) Mr. Douglas B. Oldham, #109 - 2544 Douglas Road, then addressed the members of Council as President of Burnaby Select Taxi Limited and requested that consideration be given to issuance of a spare licence to his company to ensure full service during repairs and/or maintenance of the existing licenced vehicle. The delegation further requested that Council give consideration to the issuance of a temporary additional licence to cover the period 1986 January to October (with possible extension to 1986 December) in order to ensure competitive operations during the busy Expo'86 period. Finally, the delegation urged Council to oppose the issuance of licences to operators from surrounding municipalities on the basis that this would represent unfair competition. Alderman Lawson entered the Council Chamber at 8:00 p.m. and took her place at the Council Table.

(e) Mr. Paul Mutton, #111 - 5777 Willingdon Avenue, then addressed the members of Council regarding the decision taken on 1985 October 15 to declare Burnaby a Nuclear Weapons Free Zone. The delegation spoke in opposition to the declaration, suggesting that in times when national defence is at stake, the declaration would be rendered meaningless. The delegation contended, further, that public awareness was not broadened by the declaration and that the real purpose had been lost. Details of areas of conflict in the world since the end of World War II were then reviewed and the delegation noted that nuclear weapons had not been used in any of those conflicts. It was suggested that the toxic waste by-products of nuclear power plants and medicine uses represented an equal threat to the Earth's survival as nuclear weapons. The delegation contended that Council was wrong and naive in its decision to declare the municipality a Nuclear Weapons Free Zone and suggested that silence on the issue does not represent apathy or fear on the part of many citizens who may be opposed to the declaration.

Major changes proposed include revised coverage regulations to include all buildings on the lot, a change in the way building heights are measured and a moderate reduction in building heights and the redefining of 'half-storey', 'basement', 'cellar' and certain other bulk related items. The report also contains proposed Zoning Bylaw amendments for Council's consideration.

The Municipal Manager recommended:

The report further advises that staff is working with the rezoning applicant and the developer towards a development plan which reflects municipal objectives for Metrotown and the applicant's desire to construct a high quality, major commercial development.

The report further notes that the development will be submitted to a Public Hearing following establishment of the parameters and prerequisites of the project which is considered a key one which, together with the Sears/Woodwards'/Cal Investments proposal now under construction on the adjacent site to the east, will assure the solid establishment of Metrotown as a prime municipal and regional focus.

The report provides Council with an update on action taken regarding problems resulting from obnoxious odour emissions as a result of the shipment of certain petroleum products by Trans Mountain Pipe Line Company Ltd. The report provides and overview of current refinery operations in the Lower Mainland and specific details of Trans Mountain Pipe Line Company Ltd.'s operations together with a review of the regulatory authorities involved. The report also notes that at present, there is some considerable lack of clarity regarding the degree of regulatory authority possessed by the municipality, the G.V.R.D., the National Energy Board, the National Harbours Board and various environmental officials at both provincial and federal levels.

It was noted that officials of Trans Mountain Pipe Line Company Ltd. had made a significant effort to come to terms with the problem, however, municipal staff had made it clear that concerted efforts must be continued and that solutions to the problem must be found. Staff will continue to monitor the process on a high priority, ongoing basis and, in the event problems are identified in the process, Council will be notified immediately and recommendations offered for further action.

"WHEREAS, there have been numerous complaints from the citizens of Burnaby related to the loading of 'Off Spec Crude' at the Trans Mountain Terminal on Burrard Inlet during 1985 September 28, 29 and 30; and

WHEREAS, these complaints were related to the nauseating and obnoxious odours escaping into the atmosphere as the result of storage and loading of this 'Off Spec Crude'; and

WHEREAS, the noxious vapours, which permeated the homes of North Burnaby residents, caused extreme discomfort to the inhabitants who suffer from allergies, lung and heart conditions; and

WHEREAS, Trans Mountain received another shipment of unprocessed 'Off Spec Crude' and proceeded to load on 1985 October 15; and

WHEREAS, on October 17 and October 18, nauseating and obnoxious odours escaped during loading and spread throughout residential areas of North Burnaby; and

WHEREAS, the Trans Mountain Terminal does not possess the technology to stop these vapours from escaping into the atmosphere;

THEREFORE, BE IT RESOLVED that Municipal Council of the The Corporation of the District of Burnaby petition both the Federal Government of Canada and The National Energy Board of Canada to stop any further shipment of 'Off Spec Crude' until Trans Mountain has constructed facilities which will eliminate the escaping obnoxious and nauseating vapours during storage and loading.

Alderman Brown

Alderman Brown enquired with respect to reported damage to the lane between Cambridge and Eton Streets in the 4800 block during construction of two new homes.

The Director Engineering, Mr. E.E. Olson, undertook to investigate the complaint.

Alderman McLean

Alderman McLean enquired as to the status of construction of the route for handicapped persons between Moscrop and Kingsway. Alderman McLean also observed that only one corner remained to be blacktopped on Patterson Avenue between Kingsway and Moscrop.

In response, the Director Engineering, Mr. E.E. Olson, advised that a decision had already been made to complete construction of the subject corner. The balance of the route was said to be moving slowly towards completion.

Alderman McLean advised of complaints received with respect to noise disturbance caused to a resident of Neville Street as a result of ALRT experimentation.

In response, His Worship, Mayor Lewarne, advised that Environmental Health Department staff already have this matter in hand and are presently conducting sound tests. Alderman McLean enquired with respect to pipes protruding from the sidewalk at the Oakland/Gilley intersection.

The Director Engineering, Mr. E.E. Olson, undertook to investigate the matter.

Alderman McLean then enquired with respect to possible installation of landscaping on the Oakland/Grange connector.

In response, the Director Engineering, Mr. E.E. Olson, advised that each case is dealt with on its merits. If possible, the root structure is trimmed and the tree is saved; however, it was not always possible to save all such trees but any work undertaken is conducted in consultation with Parks and Recreation Department staff.
