E N Q U I R I E S

Alderman Drummond

Alderman Drummond referred to a recent mishap in which three men had fallen from a cliff on Burnaby Mountain after climbing a fenced area. Alderman Drummond suggested that the following questions be posed to staff in view of the incident:

- (1) It is possible to build a device to catch persons falling from the cliff face?
- (2) Does the Burnaby Fire Department have sufficient cable to reach a distance of 300 feet for rescue purposes?
- (3) Does the Burnaby Fire Department possess walkie/talkies (portable communication devices) which are adequate for use during such rescue operations?

1986 February 10

In response, the Director Administrative and Community Services, Mr. J.E. Fleming, advised that he was unable to answer question no. 1 relating to possible construction of a catching device. In answer to question no. 2, the Director advised that the Fire Department is investigating the possible redesign of winching and cable equipment for use in any similar accident situations; however, the existing cable does not stretch to 300 feet. In response to question no. 3, the Director advised that the existing hand held portable radios used by the Fire Department were inappropriate for use in mountain rescue type operations but the budget will be reviewed to determine the possible acquisition of more appropriate radio communication devices such as walkie/talkies.

Alderman McLean:

Alderman McLean referred to a Traffic Safety Committee item regarding complaints of poor visibility at the intersection of Fir and Halley.

In response, the Deputy Director Engineering, Mr. W.C. Sinclair, undertook to investigate the matter further.
