Mrs. Ann Watson, 584 E. Braemar Road, North Vancouver then addressed the members of Council and read from a prepared text submitted by the Burnaby Historical Society regarding proposed establishment of a Municipal Heritage Advisory Committee. A copy of the text is on file in the office of the Municipal Clerk. The delegation advised that Burnaby has no comprehensive inventory of heritage resources nor a heritiage policy. Pertinent facts considered by the Burnaby Historical Society were then reviewed and the delegation noted that the Director Planning & Building Inspection has twice recommended the establishment of a Municipal Heritage Advisory Committee and its establishment is also supported, in principle, by the Heritage Advisory Study Committee of Council. The delegation also noted that the Burnaby Village Museum Association, the Heritage Conservation Branch of the Ministry of Provincial Secretary and Government Services, the Burnaby Village Museum Director and various other individuals have agreed to support and/or assist in the establishment of a Municipal Heritage Advisory Committee.

The delegation suggested that the proposed Committee would have considerable expertise to draw upon and ideally would include all or some of the following people:

Architects, Archeologists, Historians, Planners and Aldermen or other Council Appointee.

If the Municipal Heritage Advisory Committee were established now, the delegation suggested it could assist with plans for both Burnaby's 95th Birthday and the 100th Anniversary which will be celebrated in 1992. If established, the Committee could also apply immediately to the B.C. Heritage Trust for financial assistance to conduct a comprehensive inventory of Burnaby's heritage resources, man-made and natural, thereby creating and sustaining public awareness of Burnaby's heritage resources, its history and its upcoming special birthday. The delegation concluded that Burnaby is the only sizeable community in the Lower Mainland without a Heritage Advisory Committee under its governing agency. Council was therefore urged to approve the establishment of such a committee so that it might approach the Heritage Trust Fund for a grant.

(b) Petition, 1986 December 03 Re: Parking in Noelani Place

A letter dated 1986 December 03 was received from the residents of Noelani Place providing additional information with respect to their request for angle parking in the cul-de-sac. The letter included a diagram illustrating lot frontages and the present parking layout. The letter further responds to some points raised during previous consideration of this matter by Council at the regular meeting held on 1986 November 24.

Item 07, Municipal Manager's Report No. 74, 1986 December 15 was brought forward for consideration at this time.

7. Letter from Residents of the 6800 Block Noelani Place Parking in Cul-de-Sac

The Municipal Manager submitted a report from the Director Engineering which was written in response to a submission from a delegation at the regular Council Meeting held on 1986 November 24 regarding a request from residents of the 6800 Block Noelani Place to permit angle parking in the cul-de-sac. The report provides a detailed response to questions and concerns raised during the previous Council Meeting and concludes with advice that the primary purpose of a cul-de-sac is as a turnaround and, therefore, right-angle parking should not be permitted in any cul-de-sac. Furthermore, the report advises that Section 191 of the Provincial Motor Vehicle Act precludes angle parking and requires that vehicles be parked only in a parallel fashion.

The Municipal Manager recommended:

(c) Mr. Arthur Lowther, 6857 Noelani Place, then addressed the members of Council regarding a request from a group of residents to permit angle parking in the cul-de-sac turnaround, 6800 block Noelani place. The delegation appealed for a relaxation of the Municipal bylaw to permit angle parking in the cul-de-sac turnaround rather than the parallel parking as recommended in the report from the Director Engineering which was submitted to the regular meeting of Council held on 1986 November 17. The delegation noted that the subject cul-de-sac has no sidewalks and parallel parking would result in passengers disembarking from automobiles directly onto front yards and gardens. The delegation further advised that he had contacted the Burnaby Fire Department with respect to emergency vehicle access and had been informed that in most instances, fire trucks would drive straight into the cul-de-sac and reverse straight out.

Council was advised that parking vehicles at the rear of residences in the subject cul-de-sac was an unsatisfactory solution in view of the number of vehicle break-ins and vandalism due to poor lighting.

Alderman Stusiak retired from the Council Chamber at 8:22 p.m.

The Municipal Manager submitted a report from the Director Engineering which was written in response to a petition received requesting relaxation of the Municipal Bylaw to kpermit kangle parking in a cul-de-sac turnaround, 6800 Block Noelani Place. The report advises that presently, residents are parking their vehicles at right angales to the curb which is a violation of Section 191 of the Provincial Motor Vehicle Act and also completely negates the possibility of a fire vehicle turning around. The report advises that the Fire Department suggested that no right angle parking be permitted in any cul-de-sac because of the extreme obstruction it creates. Staff therefore concluded that only parallel parking be allowed in the subject cul-de-sac in view of the fact that all properties have lane access except one which as access to off-street parking by means of a driveway from the cul-de-sac.

The Municipal Manager recommended:

The report concludes that the Planning and Building Inspection Department staff is of the opinion that rezoning the subject area to the R2 District would present a more compatible zoning designation for an area abutting the stable R1 Residential Area to the northeast and the properties to the north, which are designated for future park use in the Park Acquistion Program.

Staff was also of the opinion that the R2 District would be more appropriate than the current R4 District zoning for recognizing the unique attributes of the residential enclave on the south side of Capitol Hill.

19. Excessive, Illegal Accommodations in Single- and Two-Family Residential Dwellings

The report notes that the most frequently cited concerns include increased density, increased demand for parking on streets, increased traffic and a perceived reduction in property values. The report includes a list of potential actions to bolster the municipality's ability to prevent residential dwelling misuse and to correct situations where misuse has already occurred. Staff proposed to pursue items which lie within the municipality's jurisdiction immediately and report back to Council. It was also intended to commence discussions on items involving other jurisdictions to determine the feasibility of the action proposed, also followed by a report to Council.

Alderman Stusiak

Alderman Stusiak advised of his intention to bring forward a motion regarding a proposed Performing Arts Centre for the Municipality at the regular Council Meeting to be held on 1987 January 05. Alderman Stusiak's proposed motion reads as follows:

"WHEREAS Burnaby is a suburban/urban community of approximately 140,000 people and;

WHEREAS over the years, successive elected Councils, appointed Boards and Committees and a professional staff have enacted and implemented programs and policies to provide for the needs of the citizens of Burnaby.

These programs and policies have put in place a full range of functional facilities and equipment, Settlement Plans, Transportation Plans, and an efficient management and operations work force, all of which will compare favorably with any like public body and;

WHEREAS the Community Cultural and Recreational policies and programs have put emphasis on acquisition of land for parks purposes, parks and parks facilities with a strong athletic capability. Library policies are directed to provide facilities and services throughout the community with a main central library to be located in Metrotown. Burnaby Village Museum with expanded facilities will provide the appropriate community involvement in museum and historical related matters and;

WHEREAS Burnaby Parks and Recreation has supported an arts program for years, such programs have been carried out in buildings which were not intended to handle arts programs and;

WHEREAS the Parks and Recreation Commission has been petitioned on numerous occasions by the Burnaby Arts Council and interested arts groups for Burnaby to provide a new facility for the performing arts and;

WHEREAS the Parks and Recreation Commission in recognition of such a need have a provision in the 1987 budget for development of a design concept for such a facility and;

WHEREAS the Municipality of Burnaby in the Metrotown Community Plan has indicated a need for public facilities to be located in Metrotown, such facilities could be a headquarters library, public square, public parking, cultural facilities etc. Therefore it would be desirable to determine whether a centre for the performing arts should/could be located in Metrotown and;

WHEREAS a centre for the performing arts is in the context of this resolution deemed to be a facility which would be used by:

- A. Theatrical all types
- B. Musical, vocal and instrumental
- C. Dance Groups
- D. Any cultural endeavour generally requiring the opportunity to demonstrate their individual artistic talents to the public at large

THEREFORE FOR BE IT RESOLVED THAT

- 1. Burnaby Municipal Council approve in principle that a referendum be placed before the citizens of Burnaby for the authority to borrow money to locate and construct a "Centre For The Performing Arts", such referendum to be put concurrent with the next Municipal Elections 1987 November.
- 2. That a Committee be struck consisting of two members of Council and two members of the Parks and Recreation Commission with power to add members to this Committee from the appropriate citizen groups. This Committee to function through the Operations responsibility of the Director Recreation and Cultural Services, such Committee to be empowered to elect the chairman of the Committee.
- 3. The Committee shall consider and study all elements and needs for such a facility and will report to Council by no later than 1987 April 30 on the following:
 - A. The concept and configuration of such a facility
 - B. The estimated capital cost and the estimated ongoing operations cost of such a facility
 - C. Where this facility should be located, i.e. Metrotown or Deer Lake Park.
 - D. What appropriate municipal body should operate the facility.
- 4. That a copy of this resolution be sent to the Parks and Recreation Commission."

ENQUIRIES

Alderman Veitch

Alderman Veitch enquired as to the status of provision for a left turn delay arrow on the traffic signal at the Willingdon/Kingsway intersection. In response, the Director Engineering, Mr. E.E. Olson, advised that the Municipality has made application to the Provincial Ministry of Transportation and Highways but has to date received no response. The Director Engineering then undertook to further pursue the matter with the Ministry.

MOVED BY ALDERMAN STUSIAK: SECONDED BY ALDERMAN DRUMMOND:

"THAT the regular Council Meeting do now adjourn."
