Your Committee would report on the following outstanding grant applications remaining in our 1985 file which were received well past the May 15 deadline provided for in our Policy and Guidelines:

The Clef Society of Burnaby is a well known organization that has contributed to the Municipality's cultural life over a period of 36 years.

For a great number of those years (until 1982), Council approved a small annual grant. We have now received a request for financial assistance towards the cost of a piano which the Society has found necessary to purchase for the musical programmes that are held in the Burnaby Art Gallery. Generous contributions have been made by the members and friends in the amount of approximately \$3,000., but the amount outstanding to be paid is over \$5,000.

Your Committee has determined that there are still sufficient funds in the 1985 budget and would recommend that Council approve a cultural grant of \$1,000. to the Clef Society to help defray the cost of the new piano. We would further recommend that the \$1,000. be charged to the 1985 Budget Code No. 40 00010 0000 7160.
