Alderman Emmott

The guest speaker for the evening will be Mr. Hugh Curtis speaking on his experiences a municipal politician, a Provincial Government Cabinet Minister, and currently as a member of the business community. Alderman Emmott encouraged members of Council to attend this dinner meeting.

ENQUIRI ES

Alderman Rankin

Alderman Rankin enquired as to what affect the policing requirements for the recently held Commonwealth Conference in Vancouver had on the Burnaby Detachment of the R.C.M.P. Alderman Rankin requested that an analysis be done with respect to response times during the period of the Commonwealth Conference.

In response to Alderman Rankin's enquiry, the Director Administrative and Community Services, Mr. R.H. Moncur, advised that the Burnaby Detachment was fully manned and that the level of service was not affected in any way by the Burnaby Detachment's participation the policing of the Commonwealth Conference.

Alderman Drummond

Alderman Drummond, in referring to the recently approved traffic diverter on Cambridge Street at Esmond Avenue, enquired when the review of the overall plan for the Burnaby Heights area will take place.

In connection with this enquiry Alderman Nikolai requested that staff also review the possibility of dividing the North Burnaby area into four quadrants with extensive use of cul-de-sacs. Alderman Nikolai further requested that staff consider the possible impact that a waterfront road may have on this North Burnaby area.

In response to these enquiries the Director Engineering, Mr. E.E. Olson, advised that staff are reviewing this matter and will be reporting to the Traffic Safety Committee in due course.

Alderman Drummond further enquired as to when the report would be available which responds to enquiries made at the Public Hearing with respect to the proposed high rise development on Halifax Street in the Montecito area.

In response to this enquiry the Director Planning and Building Inspection, Mr. A.L. Parr, advised that staff were proposing to meet with area residents prior to submitting a report to Council.
