RE: HOSTING OF 1987 CONFERENCE OF FAMILY COURT COMMITTEES

RECOMMENDATIONS:

1. THAT Council authorize the expenditure of four hundred six dollars and sixty cents (\$406.60) to cover the cost of a hospitality suite for the Family Court and Youth Justice Committee.
2. THAT Council authorize the expenditure of four hundred ninety-five dollars (\$495.00) to cover the registration cost of eight members and one ex member of the Family Court and Youth Justice Committee to attend the 1987 Family Court Committee Conference.

R E P O R T

As Council is aware, the Family Court and Youth Justice Committee will be hosting the 1987 Family Court Committee Conference at the Sheraton Villa Inn, 4331 Dominion Street, Burnaby, B.C. on 1987 February 27, 28 and March 01.

At a meeting held on 1987 January 28, the Committee discussed the need for a hospitality suite and a suite to accommodate the Chairman and Sub Committee Chairman on Friday, February 27 and Saturday, February 28.

The Sheraton Villa Inn has advised that they have a suite, which includes two separate bedrooms, that would be used as a hospitality suite and also accommodate the Chairman and Sub Committee Chairman on Friday and Saturday, February 27 and 28. In addition, this suite would also be used to process late registrations and any other administrative functions. The cost for this suite is one hundred ninety dollars (\$190.00) per night, plus seven percent tax, or four hundred six dollars and sixty cents (\$406.60) for both nights.

With respect to recommendation 2, please be advised that Mrs. Yvonne Neubert was a member of the Committee up to 1986 December 08 when she was replaced by Reverend Bruce Robertson and appointed to the Parks and Recreation Commission. Mrs. Neubert has provided a tremendous amount of expertise with respect to planning and organizing the Conference and has in fact agreed to continue working with the Committee up to and including the Conference.
