- (b) Ms. Joan Sawicki, 4695 Garden Grove Drive, addressed the members of Council on behalf of citizens living in the Royal Oak/Deer Lake/Oakalla Prison Lands area who are concerned with respect to proposed developments associated with the Royal Oak road alignment and Deer Lake Park. The delegation spoke from a prepared brief, copies of which were circulated to the members of Council immediately prior to the Council Meeting. A copy of the brief is on file in the office of the Municipal Clerk.

The delegation advised that area residents were dissatisfied with the bridge proposal contained in Option C which was tabled by Council at the regular Council Meeting held on 1987 March 02. The delegation requested that Council leave decision on the alignment on the table until it can be put into perspective with surrounding planning initiatives and legitimate public concerns. It was suggested that the Oakalla redevelopment and Royal Oak alignment are inseparable matters and must be planned in an integrated fashion. Furthermore, the delegation stressed the necessity of citizen input from area residents in addition to the public hearings related to the forthcoming Community Plan.

Accordingly, Council was urged to initiate a public information and discussion process to address concerns relating to development of the Oakalla Lands and Deer Lake Park and to provide an assessment of the neighbourhood concerns and priorities.

The meeting agreed to deal with Item 11 of the Tabled Matter for this evening's meeting at this time.

(a) Royal Oak Avenue Alignment

The following matter was TABLED at the regular Council Meeting held on 1987 March 02:

11. Royal Oak Avenue Alignment

The Municipal Manager submitted a report from the Director Engineering regarding proposed realignment and subsequent redesignation of Royal Oak Avenue as a secondary arterial route in Burnaby's Comprehensive Transportation Plan. The report notes hazards and limitations associated with the steep grade on a portion of Royal Oak Avenue which, to date, have precluded its ability to function as a secondary arterial route. The report provides an outline of the evaluation of various alternatives considered to upgrade the road and discusses the most acceptable choice in terms of impacting the surrounding land use while still addressing the major traffic and safety criteria for a secondary arterial route. The report advises that designation of the future realignment of Royal Oak Avenue is required in connection with the Community Plan presently under preparation for the Oakalla Prison lands intended for residential redevelopment.

The Municipal Manager recommended:

(1) THAT Council adopt Option C as further detailed in the report as the design concept for the realignment of Royal Oak Avenue.



The Municipal Manager submitted a report from the Director Recreation and Cultural Services regarding the proposed new Royal Oak Avenue alignment. The report further advises of the Commission's concerns with respect to certain design features, specifically the importance of a substantial pedestrian underpass to provide pleasant and easy access to the park areas on both sides of Royal Oak Avenue. Also, the Commission suggested that amenities such as bicycle paths be provided for. The report concludes with advice that the Commission would appreciate the opportunity to participate in the continued planning for the development of the Oakalla Lands.

The report advises that the Planning and Building Inspection Department is currently in contact with other development interests who believe that the entire site can be consolidated. The report further notes that the consistent approach of the muncipality has been to ensure that remnant lots with inappropriate development are not retained.

Community Plan for Downtown New Westminster
