(a) Mr. Tom Currelly, 4228 McGill Street then addressed members of Council and advised that he was speaking on behalf of the residents of the 4100 and 4200 blocks McGill Street. Mr. Currelly advised that there has been a marked increase in crime in the area especially concerning the breakins of houses, automobilies and garages. The speaker went on to cite a number of instances of breakins which have occurred during the past year. In concluding his presentation Mr. Currelly requested additional police patrols for the area and street lighting to be provided in the lanes. Mr. Currelly requested that the police drive through the lanes as well as the streets both day and night and use their patrol lights during the evening as an added method of surveillance.

His Worship, Mayor Lewarne, upon conclusion of the delegations presentation requested that the delegate contact Alderman Nikolai, Chairman of the Crime Prevention Committee and Council Liaison with the Burnaby R.C.M.P. Detachment, in order that the reported problems could be investigated.

His Worship, Mayor Lewarne, then introduced Mr. Harry Christie, Burnaby's Supervisor of mapping and drafting within the Engineering Department, who in turn introduced a delegation from Budapest, Hungary visiting the Municipality in order to learn about Burnaby's mapping technology in particular and the Municipal operation in general. Mayor Lewarne extended official greetings to the Hungarian delegation and welcomed them to this evenings Council Meeting.

Mr. George Bancroft, 7671 Griffiths Avenue then addressed members of Council advising that he was representing the Bancroft family concerning the property at 7671 Griffiths Avenue. Mr. Bancroft went on to apprise Council of a number of concerns he had with respect to the development of their property specifically with the proposed park dedication to the rear of his property, the planned road access, and the intent to develop the property in conjunction with development on adjacent properties. Mr. Bancroft felt the road access to the property should be obtained through two municipal lots located immediately east of the Bancroft property. The speaker also indicated that the land required for the proposed park was to be used for the purpose of providing a trail. Considering that Hart Street is approximately 50 feet wide and the strip to be dedicated is some 80 feet wide, he felt a 130 foot wide strip was somewhat wider than necessary when considering the property is to be used only for the creation of a trail. The delegate further advised that the size of the property would seem to warrant development on its own and therefore in conclusion Mr. Bancroft asked that the property at 7671 Griffiths Avenue be set aside as an individual site and developed as such.

The Municipal Manager submitted a report from the Director Planning and Building Inspection responding to points raised in a letter from Mr. George Bancroft which was received by Council at the regular Council Meeting held on 1987 November 02. The report provided details with respect to redevelopment potential, Rumble Street widening, and the park area. In conclusion the report advised that Planning and Building Inspection staff will continue to work towards a redevelopment plan for the subject site with Northmark Development Corporation, the applicant for the subject rezoning application as authorized by the owners of the properties involved.

The Municipal Manager recommended:

(1) THAT a copy of this report be sent to Mr. G. Bancroft, 7671 Griffiths Avenue, Burnaby, as well as to the applicant for Rezoning Reference #78/87.

(c) Mr. Frank Heldon, #311 - 5868 Olive Avenue then addressed members of Council and suggested that improvements be made with respect to street lighting in the Municipality. Mr. Heldon further went on the advise of traffic concerns at the intersections of Burris and Canada Way and 49th Avenue/Imperial Street and Boundary Road.

The Director of Engineering, Mr. E.E. Olsen, responded to the delegate's concerns with respect to the two intersections referred to and further responded to the matter of street lighting within the Municipality.

His Worship, Mayor Lewarne, requested that an article be placed in the next issue of Information Burnaby advising citizens of the steps required in order to obtain street lighting through a local improvement program.



(d) Mr. David Bullis, 1380 Burrard Street, Vancouver, then addressed members of Council and advised that he was speaking on behalf of Mr. Peter Withers who was unable to attend this evening's meeting as a result of illness. Mr. Bullis requested that Council give consideration to two changes to the Preliminary Plan Approval for the Station Square Development in Metrotown. The first request was to permit the inclusion of a "drive thru" window associated with a regular fast-food sit-down restaurant. The delegate suggested that such a provision would not be classed as a drive-in restaurant, and would be a permitted use under C.D. provisions governing Station Square. It would only be a minor amendment to the C.D. Plan and would not require having to embark on a further rezoning application. The second minor amendment the delegate requested was the removal of the median division on Silver Avenue at the Kingsway intersection. This amendment would permit, in the delegation's opinion, better traffic movement within the development. If the median were to remain it would be a problem for cars entering the surface parking area, adjacent to Kingsway, from the east. Should the surface parking area be full, cars would then have to proceed through the parking lot and exit to the west. At the westerly exit they would be forced, should the median remain, to turn right and proceed out onto Kingsway again and then circle the entire development before being able to find additional parking. With the median removed the cars could exit the surface parking area from the west by turning left and proceeding to the underground parking area. The delegate advised that the Ministry of Highways has indicated its approval of the median. In conclusion the delegation requested that Council give consideration to these two matters.

His Worship, Mayor Lewarne, advised that the Director Planning and Building Inspection will be preparing a report in response to the delegation's request which will be ready for submission to Council at the next regular Council Meeting to be held on 1987 November 16.

14. E911 - Emergency Telephone System

The Municipal Manager submitted a report from Director Engineering providing basic background information leading up to the recommendation to the Greater Vancouver Regional District Board of Governors from the Regional Administrative Advisory Committee that an Enhanced 911 Emergency Telephone System is a desirable public service which should be provided to and paid for by the taxpayers of the Vancouver Toll Free area. This report, in turn, recommends that Burnaby agree to become part of the new system and to pay its appropriate and proportionate share of "local equipment" and "common equipment" costs, respectively.

The Municipal Manager recommended:

(a) Crime Prevention Committee Re: Crime Prevention

The Crime Prevention Committee submitted a complete report on the activities of the Crime Prevention Committee since its inception in 1986 December and provided recommendations for short and long term actions.

The Crime Prevention Committee recommended:

- (1) THAT Council endorse the Greater Vancouver Regional District's pursuit of the enhanced "911" emergency telephone number for Burnaby.
- (2) THAT Council authorize the development of an informational brochure, for public distribution on the subject of crime prevention.
- (3) THAT Council authorize staff to further study the Crime Prevention Through Environmental Design (C.P.T.E.D.) concept and report back by 1988 March Ol with a proposed strategy for implementing a voluntary C.P.T.E.D. program in the municipality.
- (4) THAT Council provide continuing support for the development of a Block Watch pilot project for a specifically targeted area within the municipality, with the goal of expanding the program throughout the Municipality.
- (5) THAT the Crime Prevention Committee be an ongoing Committee of Council in order to undertake the long term goals as noted in the report.

(b) Municipal Clerk
Re: Certificate of Sufficiency

The Municipal Clerk provided a Certificate of Sufficiency respecting the 1986 Local Improvement Program for ornamental street lighting. The report advised that petitions have been received against projects No. 86 - 032 and 86 - 052 and therefore Council is precluded from proceeding with these two projects. In addition, Council's attention was drawn to the fact that, with respect to Project 86 - 039, the required number of objections to defeat the project were received however, the combined land value did not represent 50% of the value of the parcels which are liable to be specially charged.

The Director Engineering advised that he had reviewed the relative seriousness of the public need to provide the lighting as indicated on project 86 - 039 and concluded that the wishes of the two residential property owners should be given precedence and therefore recommended that Council not proceed with this project.

The Municipal Clerk recommended:

- (1) THAT Council receive the Municipal Clerk's Certificate of Sufficiency covering the 1986 Local Improvement Program Ornamental Street Lighting;
- (2) THAT Council authorize the preparation of Local Improvement Construction Bylaws for each of the projects.

The nurses pay for the gasoline and the Corporation provides insurance coverage.

The Corporation currently leases a total of 56 cars. The lease for 34 of these units expires 1988 January 31, another 20 units will come up for renewal at various dates between 1988 March 07 and August 15 with the remaining two units not expiring until 1990 June.

These changes and modifications, as well as updates on reserve balances as at the end of 1986, have been incorporated into the updated 1987 Reserves Policy, a copy which was presented to Council under separate cover.

In his presentation, Mr. Shiels discussed the matter of payment of compensation for the proposed Kyle Street road closure area. Council referred the matter for a report outlining a possible method of making the road allowance available to the subdivider at a nominal value.

The matter of selling the property for nominal value was comprehensively addressed in an information report from the Approving Officer which council received on 1987 June Ol. That report advised that the payment of compensation at market value for land that becomes available from road closures is consistent with both past Council Policy and requirements as established by the Ministry of Municipal Affairs.

Mr. Shiels desires the road closure area in order to enable him to create four single-family lots. Without the inclusion of the road closure area into the site, only three lots can be achieved.

Payment for road closure areas is the normal requirement where subdivision of privately—owned lands is involved. Accordingly, it is recommended that this condition be implemented in the subject case, as this is a normal subdivision with servicing requirements which are standard for similar residential subdivisions along Lougheed Highway.



The Municipal Manager recommended:
