

MOVED BY ALDERMAN DRUMMOND: SECONDED BY ALDERMAN BEGIN:

- (a) Mrs. Elizabeth Elwood, 8134 Fourteenth Avenue, Burnaby, B.C. appeared before Council to comment on public hearing processes. The speaker requested that Council review public hearing processes, particularly as they relate to staff initiated proposals, to ensure that the process is fair, comprehensive and explains clearly and in plain language to the public, the ramifications of any proposed changes.
- (b) Mr. Les Barnes, 5426 Killarney Street, Vancouver, B.C. appeared before Council as a representative of the South Burnaby Church of Christ regarding a proposed change to the zoning designation for the block bounded by Edmonds, Salisbury, 21st Avenue and 19th Street from RM4 to RM3. The speaker advised that the Church would be willing to relocate in view of the proposed redevelopment of the area, but that in order to obtain the full value of the property the Church would require the property to be designated RM4.



Council as a representative of land owners in the west end of the "Edmonds Triangle" area bounded by Edmonds, Salisbury, 21st Avenue and 19th Street. The owners are concerned about the potential effect of a change in zoning designation from RM4 to RM3 relative to the current value of their properties.

The speaker advised that the current owners would like a final decision made as to the property designation and that the preferred designation is RM4.

- Mr. Douglas S. Porter, 3782 Thurston Street, Burnaby, B.C. appeared before Council to present his viewpoint with regard to the proposed co-operative housing development at Boundary Road and Thurston Street. Mr. Porter advised that he is opposed to any changes to the area which will result in crowding and increased noise in the neighbourhood. The speaker advised that he does not favour increased population density, the construction of tall buildings within the neighbourhood, any increase in vehicle traffic or any increase in on street parking. Mr. Porter states that he was not advised of meetings between the local residents, the Planning Department and the developers even though Thurston Street would provide primary access to the development. In conclusion, the speaker advised that what he would like is a quiet, stable, low density neighbourhood such is that which currently exists and that the current R5 zoning be retained.
- (e) Elain Duvall, Executive Director, Columbia Housing Advisory Association appeared before Council as a representative of the Open Boundaries Housing Cooperative. Ms. Duvall addressed the issue of whether or not to expand Metrotown Area 11 to accommodate the development of a housing cooperative at Boundary and Thurston. It is the contention of the association that multi family development is the best use of this site. The one outstanding issue still to be addressed is the access and egress onto Thurston Street. The cooperative has been unsuccessful in acquiring additional property to provide a 100 foot right-of-way on Thurston Street. The speaker advised that if Council requires the elimination of construction within the current municipally-owned 100 foot right-of-way on Thurston, the project will no longer be viable. In conclusion, the speaker requested Council agree to the expansion of the Area 11 boundaries and to instruct staff to process the development permit application which would allow development of the 100 foot municipal lot for access as well as housing units.
- (f) Mr. Brian Stride, 5282 Christopher Court, Burnaby, B.C. appeared before Council to express continued opposition to the expansion of the area bounded by Thurston Street and Boundary Road within Metrotown Area 11. Mr. Stride stated that he is not objecting to the nature of cooperative housing developments but that in 1988 March, residents of Christopher Court expressed opposition to rezoning of the area before cooperative development had been proposed, and that they are now continuing this earlier opposition. Mr. Stride concluded his address by reiterating the request to retain R5 zoning in this area.
- Mrs. Randi Hodgkins, 3785 Thurston Street appeared before Council to express various concerns with regard to the proposed cooperative housing development in the area bounded by Boundary Road and Thurston Street. Mrs. Hodgkins visited seventy (70) homes in the area to obtain various viewpoints on the development and a consensus developed as to common concerns such as; increased vehicle traffic, overcrowding of on street parking, the potential of an increase in traffic accidents, access for emergency vehicles and lowering of property values in the area. Finally, Mrs. Hodgkins requested that Council delay a decision with regard to this matter to afford residents of Thurston Street the opportunity to meet with staff and the developer to discuss the project.

Council requested that staff bring forward a report with regard to the parking situation at and around the B.C. Telephone building in Burnaby.

37. Metrotown Area 11 - Discussions
Request to Expand the Community Plan Boundary

The Acting Municipal Manager submitted a report from the Director Planning and Building Inspection advising that the majority of outstanding issues with regard to the Thurston Street/Boundary Road cooperative housing development have been resolved, except for the access to the potential development site from Thurston with an appropriate property consolidation. The Planning Department advised that it is staffs intention to continue to work with the affected residents and property owners in the area in order to bring forward a final recommendation on the potential expansion of the community plan area.

The Acting Municipal Manager recommended:

- (1) THAT Council agree to consider the expansion of the Metrotown Area 11 Development Plan boundary provided that the orderly development of the site north of Thurston Street can be achieved as outlined in Section 2.4 of the report.
- (2) THAT Council authorize staff to meet with the residents of the area who have previously corresponded or attended meetings on this subject within 2 weeks of the submission of a plan of development that reflects the objectives outlined in this report, for the purpose of receiving public feed back and preparation of a final report to Council on the advisability of expanding the area boundaries.

(h) Mr. Allan Gould, of Peterson, Stark and Fowler, legal counsel for North Burnaby Inn, appeared before Council regarding the application for a retail beer and wine store submitted by the North Burnaby Inn. Mr. Gould was the General Manager, Liquor Control and Licencing Branch, Victoria, for six years ending in 1987. Mr. Gould was in attendance to provide information with regard to evolution of the beer and wine store regulations effecting the North Burnaby Inn. In closing, the speaker reiterated the need for a Council resolution of support to be submitted to the Liquor Control and Licencing Branch in order to receive approval for the retail Beer and Wine Store.

Arising from the discussion Alderman Corrigan was granted leave by Council to introduce the following motion:

The Acting Municipal Manager recommended:

(i) Mr. Haje Protais, External Relations Officer, Simon Fraser University Student Society appeared before Council to request support for student fare cards for University Students. Mr. Protais provided a brief history of fare card fees, which have increased 150% in recent years. The speaker requested Council take into consideration several recommendations regarding transit routing and park and ride facilities in the University region in discussions with B.C. Transit.





32. Rezoning Reference #54/86
Metrotown Centre - Phase II
Metrotown - Area 1
Addresses and Legal Descriptions:

The Acting Municipal Manager submitted a report from the Director Planning and Building Inspection providing details of a proposed Rezoning Bylaw which would permit the development of a Phase II expansion of the Metrotown Centre Shopping Centre, a future office tower, two apartment towers, a relocated outo centre and gas bar, and a relocated fireman's club, together with a revised community plan for the site which will provide further future office, apartment and retail development.

The Acting Municipal Manager recommended:

- (1) THAT the plans presented to Public Hearing include an amendment plan to the Community Plan for the subject site adopted in conjunction with Rezoning #9/85, as outlined in Section 4.0 of the report.
- (2) THAT Council authorize the introduction of Highway Exchange Bylaws, according to the terms outlined in Section 3.8 of the report, contingent upon the granting by Council of First and Second Readings of the subject Rezoning Bylaw.
- (3) THAT a Rezoning Bylaw be prepared and advanced to First Reading on 1988 September 26, and to a Public Hearing on 1988 October 18 at 7:30 p.m.
- (4) THAT the following be established as prerequisites to the completion of the rezoning in accordance with the terms of the report:
 - (a) The submission of a suitable plan of development.
 - (b) The deposit of sufficient monies to cover the costs of all services necessary to serve the site and the completion of a servicing agreement covering all requisite services. All services are to be designed to Municipal standards and constructed in accordance with the Engineering Design. One of the conditions for the release of occupancy permits will be the completion of all requisite services.
 - (c) The installation of all electrical, telephone and cable servicing, and all other wiring underground throughout the development, and to the point of connection to the existing service where sufficient facilities are available to serve the development.
 - (d) The submission of an undertaking to remove all existing improvements from the site within six months of the rezoning being effected but not prior to Third Reading of the Bylaw, subject to the provisions outlined in Section 3.4 of the report. In the event that existing improvements on the site are vacant and considered to be a hazard to life or property, the Fire Prevention Office may issue an order to secure or to demolish such improvements and remove the resultant debris prior to Third Reading.
 - (e) The consolidation of the net project sites.
 - (f) The granting of any necessary easements.
 - (g) The dedication of any rights-of-way deemed requisite.
 - (h) The provision of public pedestrian walkway easements through the development and the construction of a concrete walk and lighting to the approval of the Director Engineering.
 - (i) All applicable condominium guidelines as adopted by Council shall be adhered to by the applicant.
 - (j) The deposit of the applicable per unit Neighbourhood Parkland Acquisition Charge.
 - (k) The deposit of the applicable charge of \$.50 per gross building square foot to go towards the acquisition of public open space in Metrotown.
 - (1) The deposit of the applicable charge of \$.306 per gross building square foot to go towards the cost of pedestrian overpasses of Kingsway in Metrotown.



- (n) Completion of an agreement and guarantees for the provision of an internal mall bridge link between Metrotown Centre and Eaton Centre as outlined in Section 3.1(i) of the report.
- (o) Applicant's schedule for the construction staging of the subject proposal.
- (p) The undergrounding of existing overhead wiring abutting the site.
- (q) Compliance with the Council adopted sound criteria.
