

- 5. Support staff, technical resources and educational opportunities available to members of Council in order to increase the effectiveness of their representation.

Alderman Nikolai



Assistant Director Long Range Planning, Mr. J.S. Belhouse advised that removal of buildings is a requirement during rezoning.

Alderman Begin enquired as to whether or not recourse was available in instances where property was not being rezoned.
