Mr. Wardle also expressed concern with regard to the disposition of impost fees should Council determine not to undertake construction of the Gilley Alternate.

The Committee suggests that the proposed Marine Way/10th Avenue Connector coupled with an improved Griffiths/19th/20th route are much more useful in meeting arterial traffic needs.

The Transportation Committee recommended:

- (1) THAT the 5 Year Capital Budget accord high priority to Marine Way/10th Avenue Connector construction coupled with the Griffiths/19th/20th Street improvement in order to allow for the early declassification of Gilley Avenue as a truck route.
- (2) THAT the construction of the northern portion of the Gilley Alternate that crosses the Byrne Creek Ravine and the B.C. Hydro Right-of-Way and links to Edmonds Street be deleted from the Municipality's 5 Year Capital Budget.
- (3) THAT authority be given to pursue upgrading of Stride Avenue southwest of the 19th Street route in recognition of its function as the major link between Edmonds Town Centre South and the wider Community Plan area and a primary gateway to Edmonds Town Centre South.



WHEREAS since 1982, unconditional grants have been reduced drastically in relationship to the total Revenue Sharing Fund allocation and represent only 42% of the total in 1988; and

WHEREAS, the reduction of unconditional grants can not be attributed solely to the past downturn in the economy of British Columbia; and

WHEREAS, the reduction in unconditional grants are primarily the result of major policy changes related to Revenue Sharing Grant allocation; and

WHEREAS, THE NET EFFECT OF THESE CHANGES IS TO REDUCE THE AMOUNT OF UNCONDITIONAL GRANTS ALLOCATED AND THUS REDUCE REVENUE SHARING ON A PER CAPITA BASIS; and

WHEREAS, the "Report on Real Property Taxation Issues In Greater Vancouver" (as amended 1988 November) addresses a number of other issues which suggest discrimination against G.V.R.D. municipalities and other large metropolitan areas and an unfair allocation of Provincial revenue sharing grants;

THEREFORE BE IT RESOLVED that Burnaby Council write to the Premier to request the Provincial Government to substantially increase the unconditional grant component from 42% to 60% of the total Provincial Revenue Sharing Grant allocations; and

FURTHER BE IT RESOLVED that the Honourable Elwood Veitch, Minister of State, Mainland South West and responsible for Regional Development be requested to bring forward the concerns of Burnaby Council and also those expressed in the Greater Vancouver Regional District "Report on Real Property Taxation Issues in Greater Vancouver" to the Provincial Cabinet; and

FURTHER BE IT RESOLVED that a copy of the letter be sent to the Minister of Finance, the Honourable Mel Couvelier and the Minister of Municipal Affairs, the Honourable Rita Johnston asking them to specifically respond to the request; and

FURTHER BE IT RESOLVED that a copy of the Notice of Motion also be sent to M.L.A.'s Barry Jones and Dave Mercier and to each of the Lower Mainland municipalities."
