#### CARRIED UNANIMOUSLY

(a) Mr. Brian White of the Office and Technical Employees Union, 4740 Imperial Street, Burnaby, B.C. appeared before Council to request support in opposing the Provincial proposal to privatize B.C. Hydro Gas, Rail and Research and Development Divisions.

Mr. White provided an analysis of the perceived impact of privatization in general and in particular the potential negative impact of the privatization of B.C. Hydro in terms of gas rate increases, diminished service and the elimination of local buying policies. The speaker concluded by reiterating the request for Council's support in opposing the privatization of B.C. Hydro Gas, Rail and Research and Development Divisions.

Arising from the discussion Alderman Randall was granted leave by Council to introduce the following motion:

"THAT Burnaby Council advise Premier Vander Zalm and the Burnaby MLAs that we are not in favour of privatization of B.C. Hydro and that we are opposed to the Phase 1 sales of B.C. Hydro as announced by the Provincial Government."

(b) Mr. Nathan Davidowicz, 2924 East 41st Avenue appeared before Council to address various issues concerning transit fare increases and transit fare zones recently proposed by B.C. Transit. The speaker provided background information on established transit fare formulae and the cost sharing breakdowns between the province and municipalities.

Mr. Davidowicz concluded his presentation by requesting that Council approach the Provincial Government to request amendments to the B.C. Transit Act to allow for specific time requirements for notifications of public meetings pertaining to transit fare increases.

Arising from the discussion Alderman Drummond was granted leave by Council to introduce the following motions:

Hydro Transit Levy, non-residential property tax and transit fares, until such time as proper Public Hearing procedures are established, similar to required procedures followed by public and private utility companies.'"

- (c) Mr. Michael Craigen of United Properties Ltd., Suite 201 1195 West Broadway, Vancouver, B.C. appeared before Council to request consideration to extend RM1 zoning to include three single family lots located in the Boundary Road/Thurston Street neighbourhood. These lots are in various stages of being acquired by United Properties for the purpose of constructing a multi-family affordable housing co-operative. Mr. Craigen stated that United Properties would be willing to present a proposal to area residents in order to address their concerns with regard to this development.
- (d) Elain Duvall of the Columbia Housing Advisory Association, Vancouver, B.C. appeared before Council on behalf of the Open Boundaries Housing Co-operative to request Council give consideration to extending RM1 zoning to include the three single family lots located in the Boundary Road/Thurston Street neighbourhood which were the subject of the presentation by United Properties Ltd.

The speaker provided background information on the Columbia Housing Advisory Association and a profile of the Open Boundaries Housing Co-operative. The co-operative has received approval from CMHC to proceed toward development of a seventy unit townhouse project on the three lots designated in the Boundary Road/Thurston Street neighbourhood. Ms. Duvall advised that CMHC approval is site specific and that failure to obtain municipal approval means that the project will not proceed.

(e) Mr. Brian Stride of 5282 Christopher Court, Burnaby, B.C. appeared before Council to voice the opposition of area residents to the Open Boundaries Housing Co-operative proposal for a seventy unit townhouse development in the Boundary Road/Thurston Street neighbourhood.
