# SISTER CITY VISITORS

#### CARRIED UNANIMOUSLY

Mayor Copeland read a letter from Alderman E. Nikolai advising that he will be absent from Council meetings on 1988 October 24, November 01 and 07.

(a) Mr. Nathan Davidowicz, 2924 East 41st Avenue, Vancouver, B.C. appeared before Council to comment on the 1989/90 Regional Transit Plan. Mr. Davidowicz supported Council's resolution of 1988 October 17 which requested an increase in the Transit Operating Budget. Mr. Davidowicz noted that the proposed objectives of the Transit Plan do not include any improvements to the system but merely maintain the present level of service.

Mr. Davidowicz recommended as follows:

- 1. That Council approve the route extension as proposed by B.C. Transit for Route Nos. 142/144 that service S.F.U. and request that these extensions be implemented as soon as possible, i.e. prior to B.C. Transit's proposed implementation date of September 1989 and furthermore, that Burnaby staff bring forward a report on bus stop requirements for Route No. 142 and the associated costs to Burnaby.
- 2. That Council support a start on improvements to North Burnaby and that Council request B.C. Transit bring forward their Transit Area Plan for North Burnaby so that Council, staff and the public can evaluate the proposed first stage changes for September '89 as to how they fit the overall Transit Plan for North Burnaby.

- 3. That Council request the Vancouver Regional Transit Commission improve the hours of service on Skytrain and connecting buses, especially on Saturday morning and Sunday night.
- 4. That Council request that the Vancouver Regional Transit Commission submit to the Municipal Council for comments their Five Year Plan as well as their annual Operating and Capital Budget.
- 5. That Burnaby Council support the Vancouver City Council request for bus service along First Avenue connecting Brentwood with the Main Street ALRT Station.
- 6. That Council request Mayor Tom Baker, Burnaby Representative to the Vancouver Regional Transit Commission meet with Burnaby Council.
- (b) Mr. Haje Protais, External Relations Officer, Simon Fraser University, provided Council with a comparison of the B.C. Transit System with that of other Canadian and international cities of comparable size to Vancouver (Toronto, Montreal, Moncton and Seattle). Mr. Protais supported Council's recommendation regarding the usage of smaller sized buses for public transport. Mr. Protais also provided an analysis of ridership and transit fares over the past 10 years.

Mr. Protais recommended as follows:

- 1. That a student concession card be given which would increase ridership;
- 2. That financially disadvantaged students be given free transit usage;
- 3. That express bus services be provided to Simon Fraser University.

Alderman Begin retired from the Council Chamber at 7:56 p.m.

Arising from the discussion Alderman Rankin was granted leave by Council to introduce the following motion:

Mr. Oldham agreed with the recommendation contained in the report that more taxi cab licenses are needed in Burnaby.

Mr. Oldham also responded to Council's concerns expressed with regard to the percentages of persons using Select Taxi in relation to the number of taxi cabs available. The speaker also requested Council give consideration to the economic impacts of regionalization on taxi cab operators, particularly as it relates to the vehicle age requirements presently imposed by the City of Vancouver.

Of the remaining 61 complaints, 51 were under active investigation at the end of 1988 September.

To date, in approximately 6,700 hours of volunteer time the program has assisted 2,400 victims and witnesses of crimes and their families in Burnaby and provided over 3,800 services to those victims. The services include:

- 1. Assistance and information regarding police procedures and practices.
- Information on court proceedings.
- 3. Preparation for and accompaniment to court.
- 4. Referral to community services.
- 5. Crime prevention.
- 6. Information and applications for criminal injuries compensation.
- 7. Information on police case progress.
- 8. Support after the trauma.

The Municipal Manager recommended:

(1) THAT the R.C.M.P. Victim Assistance progam update report be received for information purposes.

8. Policy for Outdoor Seating in conjunction with Liquor License Establishments

The Municipal Manager submitted a report from the Director Planning and Building Inspection prepared in response to Council's request for a report on the implications of establishing a policy on restricting operating dates and times for outdoor seating at licenced liquor facilities.

Planning Department staff recommend that the assessment made of individual applications for outdoor patio seating in connection with Class "A", Class "D", and Class "F" liquor licences include reference to the physical setting, orientation and relationship of proposed outdoor seating to nearby land uses, as these factors relate to consideration of appropriate operating times and that these aspects be considered by Council in connection with any recommendation for the necessary Council resolution.

The Municipal Manager recommended:

9. Rezoning Reference No. 60/88 311/331/351/371 Duthie Avenue 7161/7171/7181 Hastings Street

The Municipal Manager submitted a report from the Director Planning and Building Inspection outlining the prerequisites established for the above noted rezoning application for a proposed low density, multi-family residential development and recommending preparation of a rezoning bylaw to be brought forward for first reading on 1988 November 01 and to a Public Hearing on 1988 November 22.

  - a) The submission of a suitable plan of development.
  - The deposit of sufficient monies to cover the costs of all services necessary to serve the site and the completion of a servicing agreement covering all requisite services. All services are to be designed to Municipal standards and constructed in accordance with the Engineering Design. One of the conditions for the release of occupancy permits will be the completion of all requisite services.
  - c) The installation of all electrical, telephone and cable servicing, and all other wiring underground throughout the development and to the point of connection to the existing service where sufficient facilities are available to serve the development.
  - d) The submission of an undertaking to remove all existing improvements from the site within six months of the rezoning being effected but not prior to Third Reading of the bylaw. In the event that existing improvements on the site are vacant and considered to be a hazard to life or property, the Fire Prevention Office may issue an order to demolish such improvements and remove the resultant debris prior to Third Reading.
  - e) The consolidation of the net project site into one legal parcel.
  - f) The granting of any necessary easements.
  - g) The dedication of any rights-of-way deemed requisite.
  - h) The approval of the Ministry of Transportation and Highways to the rezoning application.
  - i) All applicable condominium guidelines as adopted by Council shall be adhered to by the applicant.
  - j) The deposit of the applicable per unit Neighbourhood Parkland Acquisition Charge.
  - k) Completion of a noise study related to the Council adopted sound criteria.
