MINUTES

The minutes of the regular Council Meeting and Caucus Meeting "In Camera" held on 1988 April 18 then came forward for adoption.

MOVED BY ALDERMAN NIKOLAI: SECONDED BY ALDERMAN DRUMMOND:

"THAT the minutes of the regular Council Meeting and Caucus Meeting 'In Camera' held on 1988 April 18 be now adopted.

CARRIED UNANIMOUSLY

The minutes of the Public Hearing (Zoning) held on 1988 April 19 then (b) came forward for adoption.

MOVED BY ALDERMAN NIKOLAI: SECONDED BY ALDERMAN YOUNG:

"THAT the minutes of the Public Hearing (Zoning) held on 1988 April 19 be now adopted."

CARRIED UNANIMOUSLY

In view of the recent parkade collapse at the Station Square development in Burnaby, His Worship, Mayor Copeland requested Council suspend the order of proceedings to allow discussion of this event.

MOVED BY ALDERMAN RANKIN: SECONDED BY ALDERMAN DRUMMOND:

"THAT the regular order of proceedings of Council be suspended to allow for discussion of the parkade collapse at the Station Square development located in Burnaby.

CARRIED UNANIMOUSLY

Council members requested clarification on various issues dealing with building permit and inspection processes, the status of the building following the collapse and the ability of the Municipality to investigate the incident to determine the cause of the collapse.

Mr. M. J. Shelley, Municipal Manager provided Council with a review of the permit application and inspection processes followed by the Municipality, the current status of the building and the options available in the investigation process.

Arising from the discussion, Alderman Drummond was granted leave by Council to introduce the following motion:

MOVED BY ALDERMAN DRUMMOND: SECONDED BY ALDERMAN RANDALL:

"WHEREAS the causes of the incident at the Station Square development on Saturday, 1988 April 23 are unknown; and

WHEREAS only the Government of British Columbia has the power to convene an independent public enquiry with the power to subpoena witnesses and compel testimony under oath;

THEREFORE BE IT RESOLVED that the Government of British Columbia be requested to convene a public enquiry as soon as is possible into the causes into the incident at Station Square development in Burnaby on 1988 April 23."

CARRIED UNANIMOUSLY

MOVED BY ALDERMAN DRUMMOND: SECONDED BY ALDERMAN RANDALL:

"THAT Mayor Copeland convey Council's appreciation to those persons assisting in the aftermath of the parkade collapse, including civic employees from outside the Municipality, community organizations and members of the public who provided assistance to the victims of the accident and assisted in securing the area following the collapse."

CARRIED UNANIMOUSLY

The meeting agreed to recess for five minutes at 7:31 p.m.

The meeting reconvened at 7:42 p.m. with Alderman Drummond absent.

"THAT the delegations be heard."

CARRIED UNANIMOUSLY

(a) Mr. Allen Bennett, President of the Amalgamated Construction Association of B.C., 2675 Oak Street, Vancouver, appeared before Council to advise of the opposition of the A.C.A.B.C. to the fair wage policy for Municipal contracts recently inacted by Council.

Mr. Bennett advised that although his organization is not involved in labour negotiations in the construction industry, it is the opinion of the A.C.A.B.C. that the market place should be permitted to determine fair wages.

The speaker concluded his address by requesting Council rescind their previous decision regarding the fair wage policy for Municipal contracts.

Alderman Drummond returned to the Chamber at 7:59 p.m. and took his place at the Council table.

Mr. Mark Angelo, B.C.I.T. Staff Society President, 5390 Moreland Drive, (b) Burnaby, B.C. appeared before Council requesting its support in opposing recent budget reductions imposed on B.C.I.T. by the Provincial Government. Mr. Angelo advised that B.C.I.T. has recently been informed of the need to reduce their current operating budget by 3.5 to 4 million dollars. In view of the significant reductions in the B.C.I.T. operating grant which began in 1982, it is the opinion of staff and students at the Institute that further cuts will have a significant effect on the quality of programs at B.C.I.T.

The speaker noted that while universities and colleges in the Province have been granted increased funding for the 1988/89 fiscal year, B.C.I.T. is the only institution to be directed to reduce their operating budget.

Arising from the discussion Alderman Nikolai was granted leave by Council to introduce the following motion:

MOVED BY ALDERMAN NIKOLAI: SECONDED BY ALDERMAN RANDALL:

"THAT WHEREAS there are insufficient numbers of trained students in trades, technology and business, the Provincial Government be requested to re-examine the budget for B.C.I.T., and rather than decrease the budget, provide a budget increase sufficient to increase the number of trained students in trades, technology and business, and further, that this motion be sent to the Minister of Continuing Education, the Honourable Stan Hagen, Premier W. N. Vander Zalm and the Honourable Elwood Veitch, Provincial Secretary and M.L.A., Burnaby -Willingdon.'

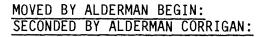

The Inspector advised that at present no food is being sold in Canada which has been treated with ionizing radiation.

The Municipal Manager recommended:

6. Proposed Restriction for Discharges to the Storm Sewer System

The Municipal Manager submitted a report from the Chief Public Health Inspector requesting Council give consideration to amending Burnaby Watercourse Bylaw, 1962, to strengthen the ability of the Municipal Inspection staff to prevent discharges of contaminants from entering the Burnaby storm sewer system and eventually environmentally sensitive areas such as Deer Lake, Burnaby Lake, Still Creek, Brunette River and their tributaries.

The Municipal Manager recommended:

(1) THAT the Municipal Solicitor be authorized to prepare, for Council's approval, an amendment to the "Burnaby Watercourse Bylaw 1962" in order to prohibit the discharge of contaminants to the storm sewer, open ditches, watercourses and soil as outlined in the report.

MOVED BY ALDERMAN CORRIGAN: SECONDED BY ALDERMAN DRUMMOND:

"THAT the recommendation of the Municipal Manager be adopted."

CARRIED UNANIMOUSLY

Arising from the discussion Alderman Sawicki was granted leave by Council to introduce the following motion:

"THAT staff, in drafting the amendment bylaw, include provisions for the filing of acceptable plans for the disposing of wastes by businesses terminating their activities in Burnaby."

7. UBCM Resolutions

The Municipal Manager submitted a report from the Director Planning and Building Inspection providing an update on resolutions previously approved by Council and the UBCM, but which have not yet been addressed by Provincial Legislation. The report further recommends the resubmission to the UBCM of a resolution pertaining to the inclusion of the cost of parking in the rent structure for apartment buildings.

The Municipal Manager recommended:

(1) THAT Council approve the resubmission to the UBCM of the following resolution concerning the inclusion of the cost of parking in the rent structure for apartment buildings:

WHEREAS many Municipalities are experiencing excessive on-street parking in areas of apartment development, a situation which gives rise to problems of traffic congestion and increasing hazards to pedestrians;

AND WHEREAS the incentives to use the parking facilities provided by an apartment are generally lacking due to the prevalent practice of requiring an additional fee over and above the normal rental for a parking space, a condition which leaves many parking spaces vacant;

AND WHEREAS the initial response to this proposal from the Provincial Government did not demonstrate its impracticability or unsuitability;

THEREFORE BE IT RESOLVED that the Provincial Government be requested to provide the necessary amendments to existing legislation (e.g. Residential Tenancy Act, Municipal Act) to empower a Municipal Council, which wishes to do so, to require that apartment landlords of both existing and future rental apartment buildings include the cost of off-street parking in the rent structure in order to encourage the full use of these facilities by the apartment tenants.

- 2. THAT this resolution be referred to the Lower Mainland Municipal Association for its endorsement and submittal to the UBCM.
- 3. THAT a copy of the report be forwarded to the UBCM, Suite 15, 10551 Shellbridge Way, Richmond, B.C., V6X 2W9.

12. Proposed Oakalla Development Plan

The Municipal Manager submitted a report from the Director Planning and Building Inspection advising Council of the developmental opportunity presented to the Municipality with the phasing out of the Lower Mainland Regional Correction Centre (Oakalla).

The Municipal Manager submitted a report from the Director Engineering advising Council of the need to amend the local improvement construction bylaw pertaining to a portion of pavement to be constructed on the west side of Sussex Avenue between Carson Street and Marine Drive. This construction will be too disruptive to the ravine and natural water course existing on the west boundary of the Sussex Avenue road allowance and therefore the Engineering Department is recommending elimination of the parking lane on the west side between Carson Street and Marine Drive.

The Municipal Manager recommended:
