Mr. Alexander advised Council that subject rezoning would facilitate the provision of a combination self serve, full serve, natural gas and convenience store outlet. In support of the application Mr. Alexander noted that the nearest full service gasoline facility is approximately 1.6 kilometers from the chosen site, that the proposed facility will increase municipal tax revenues by approximately \$18,000 per year and that it would create employment in the form of five full time and eight to 14 part time positions.

(a) Mr. Douglas Oldham, Select Taxi Ltd., appeared before Council requesting consideration to increase the number of taxi licences available in the District of Burnaby. Mr. Oldham presented a brief history of previous discussions with Council held during the past two and one half years, at which time Mr. Oldham discussed difficulties encountered in operating his taxi business with a limited number of licences.

Mr. Oldham provided statistical information regarding population versus taxi cab ratios and advised Council that the number of taxi licences issued in Burnaby has not increased in the past ten years.



 - e) Completion of the requisite Highway Exchange Bylaw.
 - f) The granting of any necessary easements.
 - g) The dedication of any rights-of-way deemed requisite.
 - h) The deposit of the applicable charge of \$.50 per gross building square foot to go towards the acquisition of public open space in Metrotown.
 - i) The deposit of the applicable charge of \$0.306 per gross building square foot to go towards the cost of pedestrian overpasses of Kingsway in Metrotown.
 - j) The undergrounding of existing overhead wiring abutting the site.
