RECOMMENDATIONS:


1. THAT the penalties and interest owed by the persons listed in Schedule A (attached) be abated; and
2. THAT a by-law be brought down to formalize the abatement.

REPORT

This is the annual report recommending abatement of penalties and interest charges against taxes of qualifying applicants received in the year 1987.

Section 476 of the Municipal Act empowers Council by by-law to extend the period of payment, to abate or to rebate taxes, rates, local improvement assessments or any part of them on property owned, held or used as the residence of a soldier, surviving spouse or orphan of a deceased soldier. Our policy is to abate penalties and interest charges only on taxes of qualifying persons who submit application for abatement. Five applications for abatement have been received.

Staff have reviewed these applications and determined that these persons qualify for the abatement under Section 476.
