

#### CARRIED UNANIMOUSLY

- (a) The delegate withdrew the request to appear.
- (b) The delegate did not appear before Council.
- (c) Thelma MacAdam, Chairman, Environment Committee, Health Action Network Society, 11 3856 Sunset Street, Burnaby, B.C. appeared before Council to discuss the use of herbicides and pesticides within the District of Burnaby. The speaker provided Council with background information concerning the testing and regulation of herbicides and pesticides. The use of 24D as a component of agent orange used in the Vietnam War and its current availability for private use as a pesticide was sited as an example of the lack of safety regulations and the potential danger of pesticide use for the general public.

The speaker noted that the Department of Agriculture, as the regulatory body responsible for the use of pesticides, is primarily concerned with the efficiency of the product and does not consider the effect on the general public. Mrs. MacAdam outlined the dangers associated with pesticide use and the positions of various Lower Mainland Municipalities with regard to pesticide spraying. The speaker concluded by requesting Council implement a program to limit the use of pesticides similar to that currently used in Port Coquitlam in which the Parks Board must receive permission from Council prior to the application of pesticides.

(d) Mr. Douglas Turner, 7810 Morley Street, Burnaby, B.C. appeared before Council to express concern over the use of chemical pesticides including Roundup within the District of Burnaby. The speaker requested Council give consideration to exploring alternatives to pesticide use. Recent studies have shown that Roundup is not as harmless as the public have been lead to believe and that components of Roundup have been classified as carcinogens.

The speaker requested that Council form an environment watch committee with citizen representation to monitor the use of chemical pesticides in Burnaby, with a view to eliminating their use by finding safe usable alternatives.

4. Use of Herbicides/Pesticides in the Park System

The Municipal Manager submitted a report from the Director Recreation and Cultural Services requesting Council grant exemption from the directive limiting the use of Roundup to allow spraying on golf course greens and lawn bowling greens, Parks Department Greenhouses and to assist in the eradication of wasp and hornet nests on playgrounds and in other sensitive areas.

The Municipal Manager recommended:

(1) THAT golf course greens, lawn bowling greens, nursery greenhouses and wasps and hornets nests be excepted from the ban on the use of herbicides/pesticides.
