O P E N I N G P R A Y E R

The Reverend George Stegen opened the Inaugural Meeting with a prayer and blessing.

I N A U G U R A L A D D R E S S

His Worship, Mayor Copeland, then delivered his inaugural address. The following is the text of the Mayor's inaugural address:

Members of Council, Ladies and Gentlemen, Citizens of Burnaby, I welcome you to the Inaugural Meeting of the 1989 Council. At this time, I would like to reflect upon our accomplishments during the past year and outline some of our goals for the coming year. I applaud Council Members for their enthusiasm and energy in carrying out their many duties in the service of our community.

Council can justifiably be proud of its performance in managing the financial affairs of the community. Working with senior staff, Council achieved the lowest residential and commercial tax increase of any Municipality in the Lower Mainland in 1988. Taking advantage of the newly-created Major Industrial Property Tax Class, Council was able to shift the burden of taxation from residential and commercial properties to major industries, thus ensuring that the major industrial concerns in our community pay their fair share of taxes.

Prudent financial management permitted Council to improve police and fire protection for our citizens, and maintain the many fine services we provide to the community.

This year, I have had the honour of officially opening the new Bonsor Recreational Centre and the expansion to Confederation House for seniors. Both facilities will contribute greatly to the social and recreational needs of our citizens of all ages.

Council took a major step forward this year in recognizing the efforts and dedication of the Burnaby Historical Society and other groups and individuals who share a love of history and our common past. This year, Council established the Burnaby Heritage Advisory Committee with a broad mandate to identify, catalogue and recommend the preservation of those buildings and artifacts in our community that represent our links and connection with our past.

I am pleased that Council, in cooperation with the Burnaby Village Museum, was able to act quickly to save the historic Jesse Love home and relocate this important farmhouse to the Village Museum. I would like to acknowledge the contribution of Mrs. Evelyn Salisbury whose timely letter prompted Council to act quickly to save the Love House.

I know that a high priority of the Heritage Advisory Committee under the able Chairmanship of Alderman Doug Drummond will be to ensure that the Burnaby South Cenotaph, raised in tribute to those brave former students who gave their lives in service to our country will be preserved either at the school or another location and thus accorded due respect during the planning process that will result in the relocation of the high school and redevelopment of the Kingsway school site.

Crime prevention continues to be a high priority of this Council. I would like to acknowledge the fine work of the Crime Prevention Committee, chaired by Alderman Egon Nikolai, and greatly assisted by members of our local R.C.M.P. Detachment who together have helped make our community a safer place to live in 1988.

The Neighbourhood Block Watch Program has been an outstanding success in reducing the number of residential and auto break-ins in those areas covered by the program. I salute the 1,800 citizen volunteers in the Block Watch Program for their dedication to making our homes and our neighbourhoods more secure and safe.

Council's ongoing commitment to fighting crime included the addition of two R.C.M.P. Members in 1988 and an additional four police officers and two civilian communication operators are slated for 1989. Burnaby R.C.M.P. is presently investigating the feasibility of Metrotown office space to serve our growing downtown better.

Council has taken an active interest in resolving problems involving youths in our community. The hiring of a youth worker through a Ministry of Social Services and Housing grant to work in the Greystone area has resulted in a decrease in youth problems in the area. Staff is working with the Greystone Advisory Group to ensure that all problems involving youth in that area are addressed effectively. On a broader scale, staff is working with the Youth Outreach Task Force of the Inter-Agency Council to identify "hot spots" of Burnaby youth and solutions to youth problems. The Youth Services Review will be a "blueprint" for addressing youth problems that arise from time to time in our community.

I am also, at this time, considering revisions to the Crime Prevention Committee's Terms of Reference to reflect a broader concern with social issues facing our community. The broader issues that need to be addressed by Council in a very concrete way include: neighbourhood issues facing youths, seniors, the handicapped and multiculturalism.

Council is also concerned about the number of and variety of drinking establishments and gambling casinos in the community. A restructured committee with a broader mandate could address these and other issues of concern to our citizens.

Provision of adequate and affordable housing continues to be a top priority of Council. Council has directed the Housing Committee to recommend means of strengthening municipal policy with respect to the provision of municipal land for the construction of affordable housing. This year, Council approved a staff recommendation to make some municipally-owned land in the Cariboo Heights Development Area available on a leased basis for the construction of cooperative housing projects.

The Housing Committee, under Alderman Randall's experienced leadership, is working hard to respond to the question of rising rents in the Metrotown area. Council has directed staff to review the question of social planning issues, including the provision of affordable housing in Metrotown, with the Inter-Agency Council to ensure that Metrotown becomes a vibrant and dynamic heart of the community while respecting the right of existing Metrotown residents to live in stable and secure accommodation.

Council has also taken strong measures this year to restrict and control the construction of large homes in the municipality. Council has amended the zoning bylaw to ensure that large homes will only be constructed on the largest lots in Burnaby, thereby ensuring that new home construction throughout the municipality will be compatible with existing homes.

Council has also directed staff to prepare new guidelines for small lot development to ensure that new small lots are only created in areas that exhibit a pattern of small lot development.

Changed regulations for small lot development will help to ensure neighbourhood stability while permitting small lot development in only those areas which demonstrate existing small lots. Extensive public consultation will be sought before Council implements a new small lot policy.

Council is also working towards the adoption of an Oakalla Development Plan that calls for the development of 610 units of low-rise multiple family housing. Great care is being taken to ensure that generous portions of the Oakalla site are retained for open space and walkway purposes, connecting with Deer Lake Park. Council is working hard to ensure that the planned new development harmonizes with existing residential neighbourhoods surrounding Oakalla.

Council has also adopted in principle revised designs for the Moscrop-Gilpin Diversion and Royal Oak Alignment to ease traffic congestion on Gilpin-Moscrop and improve traffic safety and movement on Royal Oak. The revised alignments are sensitive to neighbouring residences and Deer Lake Park. Further public input will be sought prior to approval and construction of these necessary transportation improvements.

Council has also established a Hastings Street Advisory Committee to develop and recommend a new planning strategy for Community Plan Three. This broadly-based committee, to be composed of local business people and residents, will be charged with the task of designing a new Hastings Street Plan that harmonizes neighbourhood wishes with the business community's desire to revitalize and upgrade the area's commercial core.

Council has also implemented strong new regulations controlling the development of wine and beer stores in neighbourhood pubs and hotels in Burnaby. Applicants are now required to submit to a rezoning and a neighbourhood referendum process to ensure that the wishes of the community are fully addressed before any approval is given to a beer and wine store in the municipality.

I am particularly proud of the strong record this Council has achieved in the fight to maintain and improve our environment. In my Inaugural Address last year, I announced the creation of an Environment and Waste Management Committee with expanded terms of reference to replace the then-existing Pollution Committee. Under the enthusiastic Chairmanship of Council Member Joan Sawicki, the Committee has proposed a number of measures to help create a safer, healthier environment in Burnaby.

Some of the measures adopted by Council include:

- A moratorium on the use of chemical herbicides and pesticides by Municipal Departments, pending the development of an Integrated Pest Management Policy;
- A review and inventory of P.C.B. storage sites in Burnaby to ensure the regular monitoring of the sites and the safe storage, transportation and disposal of this dangerous substance;
- Development of an interim recycling depot at the Stride Avenue Disposal Site, while supporting the early implementation of a regional recycling initiative;
- Opposing the use of the Big Bend Incinerator for the disposal of cruise ship and bio-medical waste.
- At the initiative of Alderman Corrigan, Council this year adopted an amendment to the Burnaby Watercourse Bylaw which will prohibit the discharge of contaminants into storm sewers, open ditches, water courses and soil;
- Council Member Sawicki has spearheaded Council's efforts to preserve and enhance Burnaby's Big Bend agricultural land currently in the Agricultural Land Reserve. Council strongly supports the continued and enhanced use of our agricultural land and will work to support and expand our market gardening activities in the Big Bend.

Council worked hard on behalf of Burnaby citizens to ensure that our residents would have an effective voice in opposing the expansion of the Trans Mountain Pipeline Tank Farm and Westridge facilities unless adequate environmental safeguards were put in place to protect the health and safety of our residents in the Burnaby Mountain and Westridge areas.

Through our intervention at the National Energy Board hearings, we were able to achieve third party monitoring of air quality in the area around the Company's operations, funded by the Company itself. Council also appealed to the Federal Court of Appeal, albeit without success, the National Energy Board's decision to allow the expansion without a complete environmental impact assessment being carried out by Trans Mountain Pipe Line. However, Council remains strongly committed to fighting for stricter regulation and control of the major industrial polluters in the community.

I congratulate Council for its outstanding efforts in addressing the many environmental and waste management concerns facing our community.

Council has also approved the formulation of an economic development strategy under the direction of a newly-appointed Economic Development Advisory Committee, comprised of a broad spectrum of community interests, including business, industry, labour, the arts, education, social services and multicultural communities. Council is keenly interested in the healthy, sustained growth of our local economic base with emphasis on job creation, sensible, balanced use of our land inventory and sensitivity to the environmental impacts of development.

This year Council lived up to its obligation under the Municipal Act and adopted a Fair Wage Policy with teeth to ensure that the workers who help build this community's public facilities and roads are paid decent wages and receive reasonable benefits from their employers.

Council is also committed to making the business of municipal government more accessible, open and understandable to the general public. I will shortly be recommending to Council the names of three Council Members to serve on a Committee to review Council procedure and practices, public participation in the decision-making process, communication with the public, access to information, and resources available to Council. I recognize Alderman Corrigan's initiative in recommending the terms of reference for this Committee which will play a vital role in making civic democracy in our community work better.

Other noteworthy developments this past year include the development of the Burnaby Central High School Track by the Parks and Recreation Commission, Burnaby School Board and the Burnaby Striders Track Club as a shared use facility.

Council has also adopted a policy which calls for the development of continuous public access to the Fraser River Foreshore in cooperation with industrial users of the Foreshore. Staff is also evaluating the feasibility of a continuous north/south urban walkway through Burnaby, proposed by Alderman Drummond and supported by Council.

In anticipation of our 100-year Centennial in 1992, we will be selecting citizens to serve on the Burnaby Centennial Committee which will have a broad mandate to coordinate and recommend projects and events to commemorate and celebrate Burnaby's 100th birthday, I know that all members of our community will want to recognize and celebrate 100 years of growth and prosperity in this truly special community.

The coming year promises to be a very exciting and rewarding year for Burnaby. Plans are well underway towards the design and construction of our new Metrotown Resource Library, civic square and parking facility. These facilities will firmly establish the municipal presence in Metrotown and be valuable and well-used amenities for all our citizens. The Metrotown Resource Library represents the culmination of years of hard work and planning by our Library Board and I know the new Library will be a popular and cherished resource in the community.

We can look forward to improved library services as well in 1989. Alderman Jim Young, Council's representative on the Library Board, has done a fine job in carrying the message on behalf of the Library Board, library patrons and staff to Council.

Council has approved phase one of the Burnaby Village Museum Expansion Plan, scheduled for completion by the fall of 1989. Phase One will include expanded parking facilities, landscaping, a new administration facility to house museum departments and artifacts collection, and a public meeting facility.

Part Two of Phase One, planned for completion in 1991, includes the enclosure for a restored Burnaby Lake tram and an orientation centre.

Council has also asked the Parks and Recreation Commission to consider prioritizing the development of a recreational facility and swimming pool to be located at Confederation Park in North Burnaby. Council also supports a high priority being given to the development of the Riverway Golf Course.

Council will continue to exercise prudence and caution in managing the Municipality's finances. In the coming year, Council will maintain and improve the services we provide to our citizens while minimizing the impact on the average residential taxpayer. We will ensure that industrial and commercial property owners pay their fair share of taxes.

The past year has been an exciting and productive year for Council. Council has acted as a strong advocate for the citizens of Burnaby. I wish to thank all Members of Council for their cooperation and enthusiasm as we work together to help make our community a better place to live.

I also wish to acknowledge the fine efforts of the many citizens who volunteer their time and energy to serve on various Municipal Committees, Boards and Commissions. Your commitment and dedication to the community is a fine example of how the energy of people can enhance the quality of life in a community such as ours.

I would also like to recognize the patience and dedication of our Municipal staff who work hard to provide quality services to our citizens. I would like to acknowledge, in particular, the extraordinary efforts of our municipal workers and parks staff who went far beyond the call of duty to ensure that the Bonsor Recreational Centre and the new South Burnaby Cenotaph opened on schedule.

My first year as Mayor has been rewarding and challenging. I am gratified by the encouragement and support I have received from citizens, community groups, municipal staff and Council. I am grateful for the continued support of my good wife, Ruth, my family and my friends.

Together, we will all work to make 1989 a productive and prosperous year for Burnaby. As we approach our 100-year mark, Burnaby has much to be thankful for, and a bright future in store. We will work together to make our community an even better place to live.


