

(c) Mrs. Sophie Bodor, 4233 Pandora Street, Burnaby, B.C., appeared before Council to express concern with regard to the condition of the property located at 4231 Pandora Street. Mrs. Bodor advised that the structure located on subject property has been in a state of disrepair for eighteen months, and area residents are concerned about the safety aspect of the building and the potential danger of collapse. Mrs. Bodor requested Council take action to resolve the situation as soon as possible.



(d) Mr. Dennis P. Coates, Q.C., of Mair Janowsky Blair, appeared before Council on behalf of the Mountain Shadow Inn and Delaney's Place Neighbourhood Pub to discuss the applications for Beer and Wine Stores for these two establishments.

The speaker provided a brief chronology of subject applications and requested that Council direct preparation of a staff report on Delaney's and the Mountain Shadow Inn and following receipt of that report, Council adopt a conditional resolution approving the Beer and Wine Stores, subject to a referendum, and if necessary, subject to a rezoning.

Arising from the discussion Council requested that staff provide a report on the experiences of other Municipalities with beer and wine stores: whether or not they are causing problems in the Municipalities, including the views of the Police/R.C.M.P. and social planners.

In addition, Council also requested a report on the criteria the Planning Department will be utilizing in studying beer and wine stores.

(e) Remi Rizzo, 1387 Holdom Avenue, Burnaby, B.C. appeared before Council on behalf of the Rizzo and Ciapponi families expressing concern with regard to traffic problems at Holdom and Kitchener. Mr. Rizzo provided a history of accidents at that intersection which involved residential property owned by Mr. and Mrs. Rizzo and Mr. and Mrs. Ciapponi as well as accidents which were confined to the intersection. The speaker requested Council give consideration to making Kitchener Street a one way street to alleviate the traffic problems.




The Municipal Manager recommended:







NEW BUSINESS

Alderman Begin

Alderman Begin advised Council that he has been made aware of a situation at the Panorama Towers Apartment Complex located on Grange Street in which new rental agreements are being issued which call for rent increases of seventy to one hundred dollars per month. The rent increase is said to be due to the Metrotown location of the apartment complex. Alderman Begin expressed concern with regard to the potential negative impact of increased rents due to a Metrotown location and the effect this could have on the Metrotown area's reputation.

Alderman Nikolai

Alderman Nikolai requested clarification from other members of Council as to remarks made during the 1988 July 25 Council Meeting in response to a report submitted to Council by the Crime Prevention Committee which requested the appointment of a member of the business community as a member of the Crime Prevention Committee.





Alderman Corrigan advised that the Crime Prevention Committee Report had not received the ratification of the Crime Prevention Committee prior to coming before Council and therefore it was determined the report should be referred back to the Committee to follow the appropriate process.

Alderman Rankin

Alderman Randall enquired as to the availability of the list of deficiencies/work to be completed on the Bonsor Complex.

Director Engineering, Mr. E.E. Olson advised that the report is being prepared for presentation to Council at the regular meeting on 1988 September 12.

Alderman Young

Alderman Young enquired into an instance whereby a delay was incurred in obtaining medical attention for a person arrested by the R.C.M.P. Alderman Young requested that a review of procedures be undertaken with a subsequent report to the Mayor and all members of Council.

Director Administrative and Community Services, Mr. R.H. Moncur advised that the review was presently being undertaken and a report will be made available to the Mayor and all Council members upon completion.

Alderman Young enquired as to whether or not staff have received complaints regarding the Neighbourhood Place Restaurant, particularly concerning adequate parking facilities, noise and smell from the air conditioning and garbage.

Alderman Young requested that staff investigate the complaints and submit a report to Council.
