The purpose of the project is to generate valid Canadian statistical data regarding the amount of household hazardous wastes stored and how they may be disposed.

The project will be conducted through a written survey submitted to selected households with follow-up visits to each participant to discuss the survey.

The speaker requested Council support in the form of a \$2,000 grant to cover one half of the collection costs to collect waste from survey participants. It is hoped this grant will be matched by the G.V.R.D. Solid Waste Management Branch.

The speaker advised that it is hoped that Bonny's Taxi will have a wheelchair accessible taxicab available to provide service in Burnaby within two weeks and an additional three wheelchair accessible taxicabs by 1989 September.




