MOVED BY ALDERMAN SAWICKI: SECONDED BY ALDERMAN YOUNG:

"THAT Council endorse and send forward the following motion with respect to an independent public inquiry on Forestry:

WHEREAS overwhelming public testimony provided in the recent province-wide hearings on tree farm licenses clearly demands that either an independent full Royal Commission or a Public Inquiry under the Inquiries act must be conducted on the general subject of forest management in British Columbia;

WHEREAS the annual allowable cut (AAC) on the public's crown land is much greater than the amount which can be sustained in B.C. and there is no regulation of the amount cut on private lands; WHEREAS over 20,000 direct jobs have been lost in the forest industry from documented poor utilization, excessive waste, increasing automation and increasing exports of unprocessed logs. As a result of the mismanagement of public forests, many communities are facing economic and environmental crisis from the rapidly approaching falldown effect;

WHEREAS the lack of effective watershed protection and the failure of the government to respond to a growing public demand to preserve 13% of the province as wilderness has caused increased confrontation and civil disobedience across the province;

WHEREAS the new Forest Resources Commission and has not been given the necessary full powers of inquiry including subpoena and full protection of witness; and

WHEREAS it is essential that the investigation is conducted independent of the Forests Act and the Ministry of Forests. Because the process must be seen to be impartial by all parties involved, it is also essential that the composition of a Royal Commission or Public Inquiry be led by a small impartial team of judges, be given full subpoena powers, and include environmental, native Indian, union, tourism industry, fisheries industry, and general public concerns in balance with logging industry interests; and

THEREFORE BE IT RESOLVED that the Board of the Powell River Regional District request that the B.C. provincial government immediately establish a Royal Commission or Commission of Inquiry to undertake the following tasks:

- 1. Conduct a full investigation of the forest inventory, forest tenures, and the sustainability of the current annual allowable cut for all crown and privately owned forested land in B.C.;
- Investigate means to protect all forest uses, including domestic watersheds, fish and wildlife, tourism, hunting and trapping, wilderness, old growth forests, and native concerns;
- 3. Conduct a thorough examination of current silvicultural practices, wood utilization and export practices and recommend appropriate improvements needed to achieve sustainable, wholistic forestry;
- Investigate ways to protect future jobs for loggers and mill workers;
- 5. Recommend means available to B.C.'s forest industry to minimize detrimental effects of global warming; and
- 6. Recommend means to effectively deal with conflict resolution and fully incorporate local decision making input in resource management."
